### June 27 Election in Venice May Be Postponed

At press time, it was unclear whether the scheduled June 27 Venice Neighborhood Council election would take place, or be postponed for up to 90 days.

On May 20, the Grass Roots Venice Neighborhood Council (GRVNC) voted to hold the election as scheduled, in spite of opposition from the anti-Progressive caucus group, which had filed a petition for bylaw revisions that would make the GRVNC more restrictive. A May 6 vote on the petition carried six of seven revisions.

However, the GRVNC is only semiautonomous from the city of Los Angeles. The city's Dept. of Neighborhood Empowerment (DONE) was not yet ruled on the validity of the May 6 vote, nor on an earlier set of bylaw provisions approved by the GRVNC Board. On May 25, DONE's chief, Greg Nelson,

On May 25, DONE's chief, Greg Nelson, urged GRVNC's Board, "in the strongest possible way," to delay the election for 90 days.

GRVNC has called a Board meeting for 7PM, June 7, at the Vera Davis Center to consider what to do about the election.

## Racism in Venice?

ast month, a number of white Venetians were outraged at being called "white supremacists," white crackers," and similar names by Venetians of color. Most of the insults occurred outside the Vera Davis McClendon Center (named for a late, great Black Venetian) as they were entering a Venice Neighborhood Council meeting. One instance occurred during public comment at the meeting, but the speaker was quickly interrupted by members of the board.

While the email lists and internet message boards, which are overwhelmingly white, have been abuzz with indignation ever since, the larger question has not been addressed. Is there racism in Venice?

My observation after 35 years in Venice leads me to answer in a resounding yes. Venice is still segregated, and still subject to different police practices for members of different races.


In the old days racism and discrimination were much more overt. Blacks were allowed to live only in Oakwood. Real Estate restrictions in Venice and elsewhere prevented white property owners from selling to Blacks, Mexicans, Chinese and others. The KKK had a chapter in Venice. Their office was near where the post office annex now stands. When long-time residents of Venice who happened to be of Japanese origin were rounded up and put in concentration camps during WW II, we heard no protest from the "greatest generation."

In spite of it all, Venice continues to be a multi-racial city. Even with segregation, many Venetians find ways to embrace the racial diversity of this odd-ball beach town. In fact, so much embracing has gone on that more than 1,700 Venetians are of "mixed race" according to the

2000 census. Those whites who are blinded by their racism unfortunately miss the rich diverse cultural texture that make Venice, well Venice. Because of past legal restrictions on their mobility many Black, Native American and Latino families came to Venice in its early days and never left. To be a third and forth generation Venetian of color is much more common than it is among white Venetians.

None of this had deterred a condescending or even hostile attitude from newcomers who are white. A white friend told me that one evening last month when she was standing outside a community center located on the Black white border of Venice with one of the Black women who works there, a white man came by walking his dog. When he was asked not to

### Election messed up, says Reader

I voted against the initiative to change voter quali-fications for membership in the Venice Neighborhood Council. I did so for a variety of good reasons.

I am writing this letter, however, not to argue about the substance of that initiative but to ask for clarification of the voting process. As I approached the table to get my ballot. I was startled to see that one of the people handing out the ballots was wearing a "VOTE NO" sign on his shirt. At the same moment, I heard an agitated female voice behind me asking this person why none of the people handing out ballots was wearing a "VOTE YES" sign. He blew her off.

I was startled because the image of some handing out ballots prominently displaying his own position on the vote taking place violated everything I have learned over a lifetime of voting. How did this come to happen? And I am not asking a narrow, tech-nical question about whether or not the regulations governing the vote did or did not permit this. I am asking how anyone thought that such disregard for the norms of democratic voting was not going to get the same negative reaction from voters ON BOTH SIDES OF THE ISSUE!

### Election messed up, says Board

To: Department of Neighborhood Empowerment From: Grass Roots Venice Neighborhood Council

Re: May 6 Special Election Meeting for Bylaws Modifications

The GRVNC Board believes that its published election timetable, including an on-site election June 27, should go forward.

The GRVNC Board would like to convey the following concerns we have about the special election meeting and the bylaws modifications voted on, May 6, at a special election meeting.

### 1. The May 6 election was flawed due to lack of

supervision and procedures: Neither the Board, nor the Executive Committee, was in control of the May 6 election process. The Election Committee did not administer the election. The committee did not count the number of valid sig-natures on the petition. Because of this failure, it was not determined until after the election that only 44 signatures - six less than the required number - were from voting members. GRVNC bylaws (Article X) state that one has to be a "Voting Member" to be able to sign the initiative petition. The bylaws also state (Article III, Section B) that "proof of community stake-holder status will be required for voting rights to be effected." There is no indication that any of the signers of the initiative have shown such proof of status. Indeed, the petition itself implies self-affirmation of stakeholder status was used. It states "By my signa-ture below, I certify that I am a Venice Stakeholder..." The "self-affirmation" credentialing is not approved yet by DONE for Voting Members.

At the election meeting, the processing of voters and counting of ballots was left up to volunteers some of whom had no training. A lack of poll worker train-ing and oversight as well as immature election procedures and a lack of poll worker instructions failed, among other things, to make it clear that all voters should be given at least a provisional ballot. The 30



voters without identification who were given provisional ballots found them stamped "void." In addition, two GRVNC Board members were refused a ballot because they did not have identification! Voter were not allowed to vote by showing their GRNVC voter registration card as had been the past practice. Other voters complained that they were not allowed a secret ballot, since their registration information was stapled to the ballot. There was no one clearly in charge. Voters received varying treatment depending upon whom they approached for a ballot. Some reported being treated rudely by election volunteers.

The ballot itself was in violation of the bylaws,

Art. X, Sect. B: "All revisions to the By-laws should use strikethroughs to denote deletions from the Bylaws and underlines to denote additions to the By-

The election was conducted in a cramped lobby where there was a constant stream of people going to and from the Town Hall meeting in the adjacent auditorium. "Vote Yes" and "Vote No" flyers were left on the tables next to where people were voting. The Board failed in its obligation to provide an

election environment that ensured a fair process where all voters were treated with respect. The Board sincerely apologizes to any and all stakeholders who were insulted or inconvenienced.

In addition, the election was flawed by circumstances beyond the Board's control. Voters at the May 6 Special Election Meeting may have made their choices based on deliberately false and misleading information provided by some of the petitioners.

This false and misleading information included a flyer, "Who Speaks for Venice? (attached), that was distributed throughout the community.

It states that the question of who speaks for Venice would be decided by the May 6 vote: (1) "Is it you and your neighbors - people who live, work, rent or own property here?" (2) "Or is it simply anyone who belongs to an organization with "Venice-related activities'

In addition, the flyer claims "fraud...plagued last year's election."

These false allegations that outsiders control, or will control, the neighborhood council, and that the current board won the election because of fraud. would impel many, if not most, reasonable stakeholders - absent an investigation of the facts - to vote for the petition. It cannot be assumed that voters would have supported the specific provisions in the petition had it not been for serious misrepresentations of fact.

Since the petitioners included several candidates in last year's election and incumbent board members in 2003, it can be reasonably assumed they knew that only one case of fraud was found by either DONE or the League of Women Voters. That instance was Marta Evry's voting by absentee ballot for her dog, Raku Bowman. From their previous involvement in the neighborhood council, the petitioners also knew that all 20 Board members are Venice residents and that only a small percentage of absentee ballots in the 2003 election came from outside Venice (and these were from property owners and Venice workers as well as a

handful of volunteers in Venice organizations).

Therefore, the Board cannot endorse any of the provisions either on their merits or as an indication of stakeholder sentiments.

2. We are concerned that some of the specific language in the proposed modifications, voted on May 6, is either inadequate, confusing or disenfranchises genuine stakeholders. This includes the following:

Bylaws Change #1 - Art. II - Membership A. GRVNC Community Stakeholders

This change would restrict the definition of "work" as a criteria for being a stakeholder. This pro-vision would disenfranchise artists on the Ocean Front Walk who work everyday but are restricted by ordinance to donations (If this provision is approved it could trigger another petition to include them.). It would also disqualify non-resident board members of Venice organizations such as the Chamber of Commerce or the Venice Housing Corporation who are reimbursed with a stipend or not at all. It provides for no means of verifying whether the stakeholder qualifies under these restrictions, such as at least 30 days employment. It also denies eligibility to workers, and non-resident business owners, to vote for district representatives, while allowing non-resident property

-continued from page two owners to vote in those elections. There is nothing in the city charter that gives property owners greater status than workers in regard to neighborhood councils.

Bylaws Change #2 - Art. VI - Elections -Registration

### D. Registration

This provision requires even those "who qualify as current Community Stakeholders" to again show "proof" that they are eligible to vote. At the May 6 Special Elections Meeting, many local residents were turned away because they were not carrying ID. Others, including at least one Board member, were offered the opportunity to cast provisional ballots, which were not counted. Because of a theoretical possibility of non-qualified stakeholders casting ballots, thousands of stakeholders will be required in future elections to prove that they are indeed Venice stakeholders.

The Board is opposed to any system of verification that makes it more difficult to vote in a neighborhood council election than to vote for president of the United States.

#### Bylaws Change #3 - Art. VI - Elections -Qualification E. Qualification

This provision would raise the voting age in neighborhood council elections from 16 to 18. There is no indication on the ballot that voters knew they were raising the voting age, and thus disenfranchising Venice youth. The ballot did not state what was proposed to be changed per the bylaws: "All revisions to the By-laws should use strikethroughs to denote deletions from the By-laws and underlines to denote additions to the By-laws." (Art. X. Sect. B)

Bylaws Change #4 - Art. VI - Elections - Proof of stakeholdership

#### E Credentials

This provision requires that credentials be shown both to register and to vote. The list of credentials is deficient in several respects. It includes a valid passport (which doesn't list a home address thereby allowing anyone to vote). Another is a pay stub from an employer within the GRVNC boundaries. This is the only credential that would apply to workers. However, a pay stub contains confidential salary information that a stakeholder might not want to show to a neighbor who is checking credentials. In addition, not all Venice workers get a pay stub with a Venice address on it. Stores like Ralphs, Sav-on, RiteAid, etc. do their payroll out of a regional office, hence disqualifying their employees.

In addition, there are no credentials for non-resi-

In addition, there are no credentials for non-resident property owners. If their tenants pay the utility bills, then how are property owners to qualify to vote? Missing from the list of credentials is a rent receipt that would be helpful to residents and to business owners who rent their store.

This provision does provide for additional "proof" of stakeholder status to be adopted by the Rules and Elections Committee, but then makes the adoption process more cumbersome than the current procedure for changing the bylaws.

Bylaws Change #5 - Art. VI - Elections - Voting for a District Representative G. Voting

This provision restates the ineligibility of non-residential workers (and business owners) to vote in district elections, while allowing non-residential property comes to yout 650s Blue Change II. shows

owners to vote (See Bylaws Change #1, above). Bylaws Change #6 - Art. VI - Elections -Changing election procedures

H. Election Procedures
This provision makes it more difficult to create election rules than to change the bylaws. By requiring dual approval of election rules by a 2/3 majority of the Board AND a majority of the Voting Membership (presumably only those voting), it makes it exceedingly difficult to meet a normal timetable for preparing for an election.

Bylaws Change #7 - Art. VI - Elections -Absentee voting

### I. Absentee voting

This provision was not approved in the special election meeting.

### 3. Summary:

Summary:

1. The Board wishes the upcoming Board election to take place in accord with the bylaws and as previously scheduled and publicized.

2. The Board asks that DONE provide more guidance and assistance to all-volunteer neighborhood councils who are attempting to conduct proper and fair elections with limited training and expertise.

### City Foils Coastal Commission

The California Coastal Commission Staff has rejected the Venice Specific and the Oxford Specific Plans as incomplete. Completed plans are needed to qualify for a certified Local Coastal Program (LCP) for Venice.

Many communities in the California Coastal Zone already have LCPs that allow the local entities more jurisdiction over development and management of coastal resources.

Venice already has a Land Use Plan (LUP) that was certified in 2001. Now the City is supposed to provide the Coastal Commission Staff with all information to prove that the Venice Specific Plan (VSP) is in conformance with Chapter Three of the California Coastal Act. Chapter Three Policies are stringent so that a balance between development and preservation of valuable coastal resources can be achieved.

The City has failed to submit even enough information for the Commission staff to begin the evaluation process. Deputy Director Debra Lee of the Commission has endorsed a request for further data from the City of Los Angeles.

Here in order are some of those materials requested by the State Coastal Commission in a letter of February 13 and City Planning Director Con Howe's responses of April 28, some of which are summarized:

#### RESOLUTION OF SUBMITTAL

- CCC REQUEST- State in City whereas resolution that the LCP is intended to be carried out in a manner fully in conformity with the Coastal Act. Note the start date.
- CITY RESPONSE An amended resolution will be submitted to the City Council and this should not slow the process.



### LAMC SECTIONS AND ISSUANCE ORDI-NANCE

- CCC REQUEST Submit Los Angeles Municipal Codes (LAMC) referred to in the VSP required by the California Code of Regulations as well as "all policies, plans, standards, objectives, diagrams, drawings, maps, photographs and supplementary data in sufficient detail to allow review of the LCP for conformity with the Coastal Act requirements." Note: The City failed to submit 10 sections of the LAMC and a section of the City Charter.
- CITY RÉSPONSE The City will submit the Municipal Codes but "not for certification"! The reason stated by the City Director of Planning is that it would put a "tremendous and unmanageable workload on City staff... There is no need to additionally certify these other procedures".
   State Laws, the California Coastal Act, and other applicable laws require the City to comply with the Coastal Commission request to certify the LCP. City Planning Director Howe fails to even respond to the other requests.

#### OTHER LAMC SECTIONS

 CCC REQUEST - Submit "all parts of the LAMC that could be used to implement the LCP, including the procedures that the City could use for approving variances or exceptions from LCP standards."

### BY L.A. PLANNING COMMISSION

The city of Los Angeles Planning Commission, May 13, rejected the proposed Lincoln Center Development. This project would have been the largest commercial development in Venice. The pair of six-story buildings would have stretched from Lake Street along Lincoln Blvd. to the alley next to Palms Blvd (the area that Ralph's, Rite Aid, Ross and the old Wherehouse building now occupy).

The Commission began by calling on developers/architects Sam Adams and Jai Pal Khalsa to explain their project. Adams took one look around the room, which was packed with opponents of project, and asked the Commission for a continuance. This request was denied, somewhat indignantly.

After about a 15 minute presentation by the developers, the Commission noted the 40plus requests to speak in opposition the project from Venetians who had trekked down to City Hall, and asked if a smaller number would speak. Representatives of the Venice Community Coalition and the Neighborhood Council agreed and reviewed the project's problems with traffic, excessive height, impact on local businesses, lack of an environmental impact report and the overall unvenetianness of the development. The Commission also heard from Kevin Keller, chief planning deputy to L.A. Councilmember Cindy Miscikowski. Keller said Cindy M. supported a mixed-use development at this site but opposed this particular one

The Commission seemed to waver in favor of approving the development, if it was moved forward on the lot to the Lincoln Blvd. frontage. Ultimately, they voted to disapprove the project, as recommended by Hearing Officer Jon Foreman. But before that, two commissioners, Mitchell Menzer and David Burg felt it necessary to lecture the peasants – that is - the Venetians who had come downtown for the hearing. We were told not to celebrate the disapproval too gleefully because soon more

outrageous projects would come along and then we would be as miserable as everyone else (not a direct quote).

The project which was proposed nearly a year and a half ago aroused a storm of protest around Venice. Meetings were held in which more than 200 people turned out in opposition, the Beachhead ran numerous articles opposing it, and last June an anti-Lincoln Center slate was elected to the neighborhood council.

The project began at seven stories and 75 feet in height but was revised downward to six stories and 66 feet, with two floors of retail space and four floors containing 280 apartment units. It was still deemed much too tall for the neighborhood.

The disapproval of this monstrous project was a big victory for the community. When it had first been proposed, several members of the old Land Use and Planning Committee said that would be impossible to stop to project. They took the position that it would be better to wrangle some concessions from the developers. Not enough was gained, however, for the hundreds of locals who insisted on standing up against the project and ultimately beating it.

The Venice Community Coalition was formed by Penmar-area neighbors who were incensed by the project. This group was behind the very successful 'Envision Venice' workshop, Nov. 15, that brought out hundreds of people to discuss a community vision for Lincoln Blvd. Needless to say, that vision did not include this mega-development.

It was also a big victory for the Progressive Slate on the Grass Roots Vertice Neighborhood Council. They had campaigned against the project and put the neighborhood council on record in opposition to it, in contrast to the majority of the previous council and land use committee.

WWII. There are pictures of smiling young soldiers placing their feet on the backs of bearded old men in their yarmulkes and prayer shawls. There are photos showing soldiers and civilians forcing men and women to dance, rifles pointed at the feet of their prisoners. There are excerpts of letters they sent home telling of how proud they were to rid the world of Jewish vermin.

There were several stories a few years ago about a sheriff who forced his prisoners to sleep in tents, depriving them of "treats" like hot meals and coffee. These prisoners were worked hard, physically pun-ished, deprived of newspapers and books except for the Bible and given pink underwear. This, I guess to

make them feel less than men, and to de-sex them. One of the accused guards in Abu Ghraib prison was an ex-prison guard. I believe this man was a

civilian guard leased out by Halliburton. The most telling to me, was the picture of a fresh faced little pixie pointing her gloved fingers in a trigger position at hooded and/or naked "detainees"—so much for the superior sensibilities of the "fairer sex." We are just as good as men and just as vile.

I know these crimes committed by our military and our wardens are not as horrific as the Nazi atrocities of WWII, or other genocides ranging from the Persian annihilation of indigenous people BCE, or the killing fields of Armenia or Vietnam or Russia, but its only in degree, my friends, only in degree.

When I got over my shame "we're not supposed to do that! We're better than that!" to quote Rumsfeld, "Oh my."...The Palestinians blow up women and children, likewise the Israelis—brought up with Jewish guilt, I find that hard to face.

I guess I remember some Jew saying "Event-ually, we will forgive the Palestinians for killing our children, but we will never forgive ourselves for

I was surprised that some of the participants in the abuse of prisoners never heard of the Rules of the Geneva Convention in regards to the treatment of prisoners of war. Didn't their mommies tell them it was wrong to pick on the powerless? Our leaders do the tightrope dance of they're not POWs, they are insurgents-terrorists-they wear no uniforms there-fore they are not soldiers (so we get to torture

They are people. 'We are Americans. Aren't we supposed to be better than our enemies? Isn't that the reason our leaders gave us for ridding the world

of Saddam Hussein? Oh, of course, there were weapons of mass destruction, and a vain attempt to link Iraq with the horrific events of September 11, 2001, but our presi-dent has come up with the moral imperative to bring democracy to the non-Christian masses. And woe to any one who disagrees, no matter now respectfully, how quietly they do so. They are called unpatriotic—and that's one baby step away from

In Nazi Germany, people were exposed to the constant rat-a-tat-tat of war mongering. And told of their racial and cultural superiority. Anyone who questioned authority was questioned. People were told that to inform on one's neighbors or spouses was patriotic. We're not there—yet. But librarians are told to give up lists of what people read to the government. People can be held without access to lawyers, or even notifying friends or family members for no stated reason. I fear I might be held in a dungeon under a letter of cachet because I have a fondness for pita bread, humus b'tahini, mid-Eastern music and Omar Khayyam. People are scrutinized. Their e-mail examined, their letters opened, hearsay evidence collected by government agencies because they are persons of interest. They are surveilled, just as what happened in Nazi Germany, the Soviet Union, and in Iraq under Hussein. Well it's not quite that bad...or is it? Are we there yet?

leave his dog's poop on the yard, he complained that people visiting the center threw trash in his yard. My friend responded that she had never thrown anything into his or anyone else's yard. "That's became you're white," was his retort. While it may be extreme to express these feelings out loud, if you are white, ask yourself if you scrutinize a Black man walking down your street more than you would if he was white. Would there be any neighborhood watch committees if people of color never came into white neighborhoods?

It's only been in the past few years that a derogatory name for Oakwood among white Venetians has stopped being used in polite company (I'm not going to revive it here.) Lately gentrification has come to Oakwood. Whites who previously wouldn't have dared set foot on Brooks, Broadway, Indiana, etc. now drive their BMWs slowly down those streets looking for real estate. Others come looking for something more illicit. Some whites actually move in, all too often behind 8-foot fences patrolled by Pit Bulls. Meanwhile Black and White police cars cruise up and down every street. One long time resident remarked that the stepped up police presence is because "Blacks aren't selling their homes fast

Hot on the heels of the Yuppie invasion come proposals for not one but two charter schools on the grounds of Broadway Elementary School, When schools like Broadway and Westminster were overwhelmingly Black and Latino, no one outside Oakwood cared about the quality of education. Now, 50 years after Brown vs. Board of Education, we may be seeing the resegregation of our neighborhood schools.

Advances like integrated schools, lunch counters, an end to lim Crow laws and other overt manifestations of racism came as a result of Blacks - and a few whites - becoming militant, Marches, sit-ins, freedom rides, and in some cases, rude behavior, put liberal whites on the spot. Now, in some ways the clock seems to be turning backward. There are more young Black Venetians in jail than there are graduating from Venice High. Those on the street are restricted by terms of probation or gang injunctions (often without due process). Twelve year olds are already in THE LAPD'S computer databases. Is it unreasonable for Venetians of color to feel angry and powerless?

An LAPD bust in Oakwood on May 13 involved kicking in the front door of a home, and arresting two local men on charges of dealing crack cocaine. Some locals claim the search warrant was bogus and the evidence was planted. This followed the March 27 alleged police beating of Donovan Moore, which was covered in last month's Beachhead.

Admittedly I wasn't on the scene in either case so I don't know from personal observation whether the THE LAPD'S went "by the book" or if they used excessive zeal. However, police practices in Oakwood have been called in question

by residents for a long time, probably since Venice was taken over by Los Angeles. One former Venice Division cop, Mark Fuhrman - of O.J. Simpson trial fame - in an interview with Laura McKinney, bragged about beating and torturing gang members, "we had them begging that they'd never be gang members again, begging us." Fuhrman's negative attitude toward Blacks which I'm sure is not shared by any other police officers - was apparent. He said that he would tell Blacks, "You do what you're told, under-?" Fuhrman was also accused of stand, n planting evidence, a tempting shortcut for any bad cop.

Even while police are kicking down doors in Oakwood, it is possible to buy powdered cocaine in some of the Venice watering holes frequented by affluent Venetians. Quite a few impressive new homes throughout Venice have elaborate pot farms in their walk-in closets. When was the last time you heard about a police raid on a plush nightclub or a fancy home where illicit drugs were cultivated or sold? I'd guess never.

The unequal enforcement of crack versus powdered coke and other drugs is not the only problem. What is the problem is the lack of concern, sympathy, or action by those white Venetians who see Blacks and Latinos, and not racism, as the problem. Venice is a microcosm of our society. We have our suburbs and our inner city, our wealthy and our homeless, and we have residents from all over the world, including thousands of Blacks, Latinos, whites, Asians and hundreds of Native Americans on whose land we are all living. Meanwhile, Spanish classes are poorly

attended by Anglos. Community programs at the Vera Davis McClendon Center and Oakwood Recreation Center seem to be boycotted by whites. When the Neighborhood Council held a town hall on May 6 focusing on helping at-risk youth, hundreds of whites streamed into the adjoining lobby to vote in favor of denying 16 and 17-year-olds the right to vote and then made a beeline to their cars

Racism is so deeply ingrained on us whites that it can probably never be fully eradicated - at least not in our lifetime. All of our families have profited, either directly or indirectly, from the enslavement of Africans, genocide and taking the land of Native Americans, conquering the Mexicans in California, and near-slave labor conditions of Chinese, Japanese, Filipinos and other Asians and Pacific peoples. And the list goes on. Just ask Wal-Mart and other U.S. Corporations what they are doing around the world.

Overcoming this legacy is like a 12-step program. "My name is Bill White, and I'm addicted to racism." We're guilty as sin of exploitation and discrimination. We should be sentenced to community service for the rest of our lives. And when someone who has suffered from white supremacy all his life hurls an unfair expletive in our direction, we can be sure that someone in our family tree truly deserves it.

### QUEST: The Search for a Soul for Modernkind, by Vincent Coppola

Reviewed by Steve Goldman

With great passion, yet without a scintilla of mawkish sentimentality, Coppola here makes the strongly compelling case for love as the direct and primary implication of human consciousness. That would be laudable by itself, but these are not merely the pleasant musings of a decent well-intentioned person. This is (and it is astounding) tightly reasoned philosophy, based on acute, astute observation and profound and powerful argument. Building on Descartes (whom he explicitly reverses on the fundamental matter of "proof" of personal existence) and Kant, who seems indispensable to all who came after, Coppola emerges with a distinctive and compassionate American existentialism that is unlike anything heretofore. With strongly grounded links to modern cosmology, evolutionary theory and the sheer phenomenology of consciousness in space/time, Coppola delivers a ringing statement of free will, so sorely needed in this era of burgeoning biological reductionist determinism.

This in turn yields a ringing adduction of the ontological primacy of self, with commensurately devastating attacks on any variety of teeny-bopping reductionism, chemical biological, physical or psychological: and as well on any religiophilosophical tradition (usually Asian), which explicitly denies or tries to "eradicate" the self. "I myself exist, and I can love" is the rigorously derived, powerfully demonstrated theorem, which is the "first principal" here. What is more, the revolutionary "optional" theology "Quest" proposes, seems to at last settle that huge and perennial question for contemporary times. Additionally and astonishingly, and with philosophical deftness and gracious style,

Coppola's secularized Christology evinces sacred humanitarian values, again so needed in this era.

Coppola is a highly trained professional philosopher, a prodigiously well-read and deeply thoughtful theorist and analyst, whose similarity to the preponderant mentality in his field is only superficial. That is because Vincent is a philosopher in the all but abandoned grand tradition, a professor who actually professes, a professor who operates from a stance of engagement and compassion, so unlike his horde of reductionist, detached, time-serving technician faculty colleagues of the professorate; a man who actually strives to influence his student's lives for the sake of liberation through philo-

sophic method, this, let's say it, in the tradition of the Platonic Socrates. Philosophy is no idle pastime, dealing with jejune abstractions for Coppola, it is a matter of life and death, a tradition he shares with only a few of the greats, the likes of Wittgenstein, Nietzsche, and Kierkegaard, who, apart from particular doctrinal identity or particular slant or area of concern, were in it for "blood."

And most importantly in that connection, Coppola herein posits suffering as an object of philosophical scrutiny, i.e. being worthy of philo-sophical address. This is unknown in western philosophy to my knowledge; evil yes, even cruelty, but not suffering. While at pains to refute the Buddhist account, he does not of course solve the matter of suffering. how could he? Short of a thoroughgoing and slavish deism, ("the ways of the Lord are unknown to us, but He has His reason blah, blah") - how could anybody? Remember we are returning here to the root meaning of philosophy: philo+sophy = love of wisdom, not love of word games.

### NO SMOKING

Also without consulting Venetians, the Los Angeles City Council voted, April 21, to ban smoking on Venice's beach. Councilmenters apparently forgot to consult with the local neighborhood council. Enforcement of the ordinance is not expected to be a high priority, however, it could be enforced selectively against "undesirables."

### DUCK

The GRVNC Conservation Committee wants to construct a small freshwater pond at the head of the Grand Canal to encourage ducks not to cross busy streets and migrate into neighborhoods in search of fresh water. It's also calling for "Caution! Ducks Crossing" signs to be erected nearby.

The written style of this book is commensurately unique to its conceptual output. It is by turns funny, personal, engaged, warm, redolent with true and moving pathos (in the best sense) – derived from the author's own sometime anguished personal experience: the death of those he loved, and as well, (brace yourselves) his love for his Old English Sheepdog, and cockatel. The book is startlingly and refreshingly entertaining. Stylistically, there has, I hazard, never been a book of "serious" philosophy remotely like this.

The schema expressed herein is in no way explicitly political, as indeed neither is Vincent's classroom teaching. Remember, we are doing philosophy here, not proselytizing. But never have human affairs so greatly needed such an incredible book as this: remember, we are about to embark on another horrible, horrible war. Read this book, it will change your life. It changed mine and i was already a pretty loving guy, going in.





## lt's not just in Iraq

The recently exposed horrors of prisoner abuse in Iraq shocks people of sound mind. The current US administration has not yet admitted that we also torture American citizens who are prisoners in equally illegal and immoral ways within the United States. One example is the experience briefly described below by a Viet Nam War era conscientious objector who endured the horrors of the US Federal Prison in Springfield, Missouri.

....Most of my prison-time was served in the Federal Prison Hospital at Springfield, Missouri-in solitary confinement. The prison authorities explained this was necessary so that I wouldn't corrupt the rapists, and robbers, and murderers with my beliefs in conscientious objection and moral obligation. War-resisters were known as troublemakers, holding group hunger strikes and fasts and protest sit-downs. We were of course

forbidden to do any of those things, or even to discuss our "crime" with each other.

I was beaten bloody by guards, placed in cold rooms with no blanket, with unflushable toilets that overflowed with putrefaction. My head throbbed. And I was beaten yet again — and stabbed in buttock muscles with syringes of massive over-size doses of prolyxin — but without the cogentin which is supposed to be given with the prolyxin because it is necessary to counteract the extrapyramidal reactions that occur when the prolyxin is administered alone — which results in excruciatingly painful muscle paralyses. One cannot so much as move a finger. Agony racks every body fiber. The cerebral cortex of the brain is on fire.

I couldn't get enough air. My lungs refused to breathe deep. I thought I'd die of suffocation.

As we lay on our stomachs upon our metal bunks unable to turn over by ourselves — the pressure of the weight of our own torso upon the lungs was enough to kill us! And prisoners had actually died that way. So the guards watched us writhe, unable to breath, choking, retching, and made sure we suffered as much as possible without passing out, before they came in and picked us up and turned us over on our backs and left us struggling and gasping desperately for each

breath. On prolyxyn without cogentin a person cannot swallow. Occasionally a doctor came along and extracted the phlegm from our throats with a suction device to keep us from drowning. But they always let us choke a lot first.

After receiving such a shot of prolyxin sleep is impossible. One can only lay immobile and stare at the ceiling. Electric lights were deliberately left on all right long to impact the garish nightmare's maximum potential. The prolyxin's primary effect lasts seventy-two hours — but many weeks are necessary for full recovery.

The guards called it the punishment drug and laughed. It was cruel.

Another method used by prison authorities to squelch critics was to strap the person nude in a bathtub of ice cubes -- where screaming was not allowed.

Let me emphasize here once more: "...where screaming was not allowed." Forgive me if I do not describe that further. It is a terrible memo-

The aforementioned horror is an excerpt from Comporting Roadwise by RomTom, a recently published book from Medicine Bow Gallery. RomTom's experiences and perspectives with the previous military draft and the penalties for conscientious objection are unparalleled.

## Don't Turn Away!

We must look at, and remember, these scenes of torture and dehumanization carried out by the U.S. military, with the approval of high-ranking officials of the Bush regime. These photos are from Abu Ghraib prison in Baghdad, but similar treatment may have been common at Guantánamo Bay military prison and in Afghanistan. Our government must be held responsible for these violations of international law.

#### COASTAL TRANSPORTATION CORRIDOR SPECIFIC PLAN

· CCC REQUEST - Submit the Coastal Transportation Corridor Specific Plan (CTCSP) referenced in the VSP and the Oxford Triangle

CITY RESPONSE - The CTCSP is not submitted for certification! Again, Director Howe blatantly disregards the Commissions valid requests. Without this vital information a Local Coastal Plan cannot be legally certified.

### IMPLEMENTATION STRATEGIES SET FORTH IN THE CERTIFIED LUP


Sandy Keivman, Venice Deputy for Councilperson Cindy Miscikowski, stated to me that she had not seen the letter from Director of Planning Con Howe nor did she know if the Councilperson

had seen it or if she supports it. I was then referred to Kevin Keller. the Councilperson's Planning Deputy who also failed to admit seeing the letter. When asked if the Councilperson supported Director of Planning he stated, "The Councilperson generally supports decisions of the Director of Planning.

All of this begs an enormous question for Venetians, does

Councilperson Miscikowski support the decisions of what appears to be a rouge City Director of Planning or is she so entirely out of touch with her duties and is not aware of this major develop ment? The Venice Neighborhood Council Conservation Committee at its meeting, May 27, voted to recommend that Councilperson Cindy Miscikowski state to the City Council that the Venice Council concurs with the Coastal Commission and that the she advocate for this position. The Neighborhood Council Board must first approve this recommendation for ratification.

It is highly probable that both the Coastal Commission and the City of Los Angeles have already prejudiced the City's ability to prepare a Local Coastal Program consistent with Chapter Three of the Coastal Act by allowing two very large structures to be built in Venice in the early nineties. The photograph, above, shows the massive scale of just one of the buildings in question. Is this what the City has planned for downtown Venice?


