WE NEED AN Interim Control Ordinance.

While there is so much posturing in current events, like at the townhall at Westminster Elementary to 'combat' the Homelessness in Venice. Ask yourself, what great timing this is as the BID, Business Improvement District Ordinance is finished for the Ocean Front Walk, (OFW) one mile stretch of our public beach, presented by.... Carl Lambert, Venice Chamber of Commerce President. Timing is everything!

Hey what about that open sewer problem at OFW? There's a private company trying to fix the shit problem because the pipes burst and can't handle all the offices and crap thru our city sewage system. It's being pumped into the ocean directly! There's a reason for an ICO, a health hazard! Gajillion dollar properties and the human waste stench, priceless!

There are enough reasons to have an ICO for Venice for all MELLO determinations, all within our coastal zone. The biggest reason is 99 % of these MELLO determinations are decided by the owner affadavits. The Renter's information is typically not in the file or available to determine if there was an affordable unit to be replaced. The renter's information to decide this is the rent amount they were last paying and or their income verification. Can you imagine, not one unit recently has been decided without an appeal... has been found affordable? We're talking extremely low, low and or moderately priced? When was the last time it was determined that a replacement unit was financially feasible to replace within the two miles it was demolished? Within the coastal zone? Never! We all know how very affordable the 90291 was and just recently!!!! So it's been 15 years and counting these MELLO determinations have been corruptly decided and typically favorable for the person applying to build a new single family dwelling. For all the Venice love we have for people over profits, for humanity and not just talk about it but being about it, we require an emergency ICO on everything MELLO.

After all, there is zero requirement for anyone to be a nice person on the applications for the faux 'remodels' as described on recent applications, spare us all, it's a freakin' demolition. All the volunteer and kind hearted work that anyone does is not part of the application process... If the current laws were enforced we, locals, wouldn't have our displaced friends and neighbors vanished from our community. Where is the humanity when people lie on their applications?

Business as Usual

Maybe you've noticed this, maybe you haven't? A lot of very dramatic changes are happening around Venice. It seems like overnight entire neighborhoods have been transformed. Family businesses have been forced to close, while high-end trends and tourist boutiques pop-up in their place. Seniors, disabled, long-term fixed income tenants are being displaced faster than you can say "The Ellis Act," while luxury fortresses are being constructed at breakneck speeds. Just walk down Abbot Kinney on the First Friday of any given month and ask yourself how we got here and if this is really the Venice that we want as a community?

It has already made several rounds through the press how on Monday, April 18th, the Westside Tenants Union, along with several ally organizations in the community worked together to say, "Enough," and shut down a private, "Invitation Only" meeting with the City Planning Department, a room full of Real Estate Development interests and a few hand-picked "representatives" for the community for the purpose of re-writing the Venice Local Coastal Program (LCP).

The following evening, we heard the Venice Neighborhood Council falling all over themselves, once we exposed the situation, saying how these secret meetings to determine public policy and decisions, which affect all of us, should never take place ... yet that is the very root of the problem.

What we as a community shined the light on – and why this is so important – is that this is not a unique occurrence ... it happens all the time.

At that very same meeting Odysseus Bostick, of Assemblywoman Burke's office, reported that their office is trying to fix the Coastal Act to give the Coastal Commission the ability to weigh "affordability" as a measure when deciding on Coastal Development Permits and to add 3 Environmentalist Seats to the Coastal Commission ... things that were originally omitted, as all the affected voices weren't represented around the table during the original decision making process.

Then, at the very same meeting, Debbie Dyner-Harris, from our Council Office, gave an update on a BID (Business Improvement District) reporting that meetings have been taking place for the last two years by Business Owners to create a BID along our entire coast from Venice Blvd. all the way to Santa Monica, that the community really doesn't have a say on this and that the City Clerk's Office will be signing off on it soon.

This in itself is completely outrageous and deserves a series of articles to talk about all that is wrong with this plan ... put up to the public with a false narrative of "they have to because the government isn't providing the needed public services." However, in the same breath, it is never brought up that companies like Google and Snapchat, some of the richest companies on this planet – are given an 80% Tax Break by the City of Los Angeles — that's our money – money taken out of our community – money that is not – and should be – going to our public continued on page 5



Under Our Collective Shadow The Unhoused Sleep

Each night, as the southern sunlight dissipates in the City of Angels, a shadow takes its place. This shadow sneaks across every sidewalk, through every street, and into every neighborhood. It is a collective shadow that includes our unacknowledged fears, hatred, shame, and greed. Many of us scurry from this shadow into our waiting beds, refusing to share in any part of its making. Others take to the street, stand up in the courts, and call out at community meetings, carrying the light of conscience to illuminate not only the shadow's causes, but its effect. For, underneath the thread worn blanket of this shadow, over 30,000 human beings sleep each night -- sleep without shelter, without protection, without purpose. In the Greater Los Angeles Region, homelessness has exploded into a shocking humanitarian crisis.

On March 29th, Councilman Mike Bonin held a Town Hall meeting at Westminster Elementary School. To a packed house, he presented county, city, and Venice strategies to bring homelessness to what he termed "a functional zero". In his opening statements, Bonin said that homelessness was probably going to get worse before it gets better. He called dealing with homelessness controversial and divisive. Inaction was worse, however, than divisiveness. "I can't wait any longer for consensus before we take action."

Bonin said that Los Angeles County and City are working on the plan in "an unparalleled cooperation." All three plans depend on a data based Coordinated Entry System, (CES). According to "Home For Good", one of the developers of the system, "coordinated entry is an approach to end homelessness that requires comprehensive coordination of all housing and service resources in a community to better match people experiencing homelessness to appropriate permanent housing placements." (i.)Dept. of Housing & Urban Development (HUD) is now mandating that communities receiving HUD housing funding implement this kind of system (ii.)

Bonin said there is "no one type of homelessness, no one cause of homelessness, no one solution." Ending homelessness in Venice, he said, required ending it in Los Angeles, too. The majority of the night, he detailed first the City, then the Venice plans. This article highlights the Venice plan.

Before introducing the Venice plan, Bonin showed some results of a Venice community survey. This survey showed significant support for:safe parking; building housing on City owned land; expanding voluntary storage; reforming and expanding the shelter system; mobile restrooms and showers; and dedicated police officers trained to address homeless issues. The nearly 800 people surveyed were largely opposed to inaction.

The Venice Plan has three main components: preserving affordable housing; increasing services and outreach; and implementing a street strategy.

To preserve affordable housing, Bonin laid out five steps. The first two recommendations are to reform the Mello Act and to legislate short-term rentals. For the last few years, local activists have claimed that it is exactly because of Mello Act violations and illegal short-term rentals that Venice has been rapidly losing its affordable housing in the first place.

The other three steps are to build more affordable housing; to build housing specifically for the homeless; and to implement a rapid housing program. So far, Bonin is working with Metro to use the Metro Yard to build at least 35% affordable units. For housing the homeless, the city is looking to use the Dell/Pacific parking lot.

As part of the outreach and services strategy, Bonin launched the CES, Venice Forward, a year ago. Although this collaborative network consists of over thirty commu*continued on page 4*



A VIEW FROM THE BOTTOM

When cooking up a bum stew, you quickly learn there has to be at least three rocks around your fire -- saves your teetering meal from ending up all over the ground right before it's done. The experience to learn such lessons grants the Street Person a clarity on fundamental truths that translate and apply in other life conditions. Suddenly it becomes clear that if the Venice community has to come up with policy considerations to affect and diminish the high number of people living on the streets, it is not enough to only make this a conversation between the government agencies with millions to throw at any feasible solution, and the local organizations & non-profits cooking up proposals to receive these grants. There has to be more than just pro-forma input from the street people these decisions will affect. When more stakeholders are in on the decisions, solutions that come out will be balanced and will gain legitimacy with a greater segment of the community.

Governments function best when their great powers (that we the governed grant them) are clearly defined and reflect the consent of the people. The view from the bottom is that a majority of this community seeks positive co-existence with the street people living on the beach. The will of these neighbors is to see the powers of government functioning within that same spirit. When we empower welfare agencies, our police department, and other government functions to enact policy that deals with street people, it is clear that these policies will more practically implement when they are created as a conversation that involves government, NGOs and input from the homeless.


During the past few weeks, I had occasion to be in audience while two significant members of government performed outreach to the constituency in the Venice area. The first of these -- the Coastal Commission's three-day stint in Santa Monica last month -- totally ignore the heavy load that the community is bearing as we deal with our overpopulation of street people. At that meeting no discussions dealt with homelessness, and the Commission proposed no solutions. The latter -- Councilman Mike Bonin's big plan on homelessness -- was heavy on promises and future considerations, but seemed to do little to intervene in the short-term with any significant impact. The crux of Councilman Bonin's plan puts a high premium on access to shelters, and storage for personal belongings, but has no answer when it comes to increasing affordable housing. While Bonin's plan proposes future development to specifically increase low-income housing, these developments are years away, and seem poised to be mired in bureaucratic red tape. Bonin's meeting to announce his plan (which has the unrealistic goal in its title of "ending homelessness"), seems less like an opportunity for the councilman to get input from the community to formulate a plan, and more like a chance to sound very self-congratulatory that homelessness is being fixed.

In the meantime, as government throws its hundreds of millions of dollars toward solutions, and NGOs open wide their coffers to receive these lucrative grants, caught in the midst of it all (and feeling very much unheard), are the street people that these hundreds of millions are supposed to help. Yes, many of these NGOs provide exceptional service. And in addition, we recognize that social service agencies and NGOs that serve in these very necessary roles must pay the men and women that do these jobs a decent wage. The whole of the community can expect more widespread excellence if the norm of how homeless services get delivered includes true dialogue with the men and women that these services will benefit. Such dialogue would create opportunities for the Street Person, and the first candidates to fill roles within the relevant agencies would naturally be the street people being served. What a two-fold opportunity to deliver services AND raise someone out of poverty.

Additionally, real and sustaining dialogue with street people in formulating policy, means that governance will experience less resistance in implementation. When powers are not responsive, and seem to only be functioning with the force of might, the resistance that mount up every step along the way can be very costly, and will require more and more force to maintain its operation. Imagine the black-hole of cost if the police are our primary interaction with street people? How much less would we have left for significant interventions that could positively affect a Street Person's life, if more and more of our "homeless" allocation goes to the police budget? This defies logic. Instead of needing scores of cops to pound the street people into compliance, what would make more sense is to find that happy medium where the community serves all of its population.

We end with solutions that my own dialogue with street people have uncovered. First and foremost, never discount the human dignity of your neighbor just because his home is in the outdoors. Whenever possible we do not want just a handout (that includes GR), but an opportunity to earn for ourselves. Street People need places on and off the beach to store personal belongings. Solutions include first-come-first-serve locker banks at every bathroom location, and turning the shuttered senior center on Westminster into free storage. Instead of cluttering our neighbor's sidewalks with lines of our bodies at night, it continued on page 5

In April of 1969, a Venice activist by the name of Helene Wolff presented a prepared statement to Los Angeles City Planning Commission. It went something like this:

The City's study of Venice is founded on the idea that it is desirable that property values go up and that everything else is incidental to that. I believe that this is neither necessary nor desirable to many homeowners in Venice. We have bought homes - on lots we consider "just right" not "substandard" - in neighborhoods we consider varied, interesting, loving, changing, and challenging.

Varied

Venice may be unique in the whole world - neighborhoods that are truly integrated. My block has homeowners and renters, very old people and very young, hip and square, young families and middle aged families, married and unmarried, schizophrenics, trouble makers, peace makers, recluses, busybodies, cats, a St. Bernard dog, beautifully kept gardens, unkempt yards, at least one racially mixed couple, a millionaire, welfare recipients - and many people I do not know. I am speaking of one block.

Interesting

Like most streets in my Venice neighborhood, mine is a walk - you cannot drive on it. The fronts of the houses are not merely impassive facades. We tend to live in the front as well as the back. Neighbors can lean over front fences to talk or fight or observe. With a variety of people, a variety of things happen and when they happen most neighbors will help, or hinder, or at least watch.

Loving

Phone calls - "your car was home - are you all right? - you are usually at work"..."I smell smoke"..."where did the fire engines stop"..."Bill died"..."has his cat been taken in by anyone"..."may I borrow just one cup of rice"..."the battery is dead? take my car"..."go ahead, I'll watch the kids"..."would you like some coffee - the night was so cold and you slept outside"..."I'll leave the key"..."the kids were busted? I'll feed the dogs." Christmas Day: a young man with a flute stopping by the gate to serenade the cats.

Changing

The average age on the block was 80 when I moved in six years ago. Many friends have died. Many people have moved in. Trees are taller. So are the children. With Washington Boulevard [West Washington Boulevard which is now called Abbot Kinney Boulevard] as a gateway there is a chance of understanding between

black and white communities - a chance for more blacks to move from Oakwood into other parts of Venice if they want to - and for whites to move into Oakwood (many do). Change Washington's zoning and still the busy sounds, the joyful music, of an art renaissance.

Challenging

Challenged to open up Oakwood.

Challenged to live with people different from one's self - perhaps difficult people -- old, alcoholic, mean, rebellious, -- perhaps braver, gentler people - all people.

Challenged to learn from them.

Challenged to teach them.

Venice challenged to decide its own fate - make its own plan.


"Property value" is relative. You cannot raise my property's value to me - only lower it. Lower it by forcing my neighborhood to reflect one social or economic or moral or racial strata of society. Lower it by raising its monetary value so that I am forced out by developers. Lower it by buying it to build a freeway or parking lot. Lower it by building a freeway as a wall dividing Venice - or dividing the ocean.

Helene Marie Wolff passed away some years ago. If she were alive today, she would be 85. But her words create a sort of mirror's reflection of the struggles facing Venice in 2016. What she referred to as "Varied" we now call Diverse. She spoke of Venice as being "Interesting" with people interacting at their front fences; difficult nowadays with ten-foot-high fences on some streets. She told the Commission that Venice is "Loving" because of the way neighbors care and look out for each other; may we be so blessed this day. When she said that Venice was "Changing", she meant that the people were growing and aging, now, Change means evictions and demolitions. She declared that Venice is "Challenging", but that the challenges are Venice's own challenges. And she showed that Venice's real value is in its strength as a Community.

Today, Venice faces ever more sophisticated threats from malevolent outside forces. But can a renewed strength of Community bring a new hope of Victory? And can we imagine that we stand at a point on the journey that we could not see in 1969?

There is strong talk in Venice of Secession. Is this possible? Could Independence be imminent? Understand that if Venice breaks free from L.A., one of two things will happen: either the money classes will rule or the people will rule. But are the people ready to rule? The strength and sophistication of the Venice Community activists of today say "Yes". Simply stated: The People of Venice are ready. We are ready for the Day of Independence that was dreamed of by our Venetian forebears.

The Aliens Have Landed

Are people my age allowed to have fun in this town anymore?

Now this could be a 1/3 life crisis thing, with me turning 33 (or as I like to say, thirty-free), but something deeper is happening on the Westside. Something far worse, and sadly out of my control.

The aliens have landed, colonized, and have officially taken over. They even renamed our beloved sand: Silicon Beach.

Tech geeks, turned superheroes, turned super villains overnight. A town so deeply rooted in the art of fun and the fun of art, slowly dissipating to this silicon sludge. This, "too-cool-for-school" poison that has infiltrated the border along the beach, most terrifyingly personified by the infiltration of this filth found on Abbot Kinney. A street that once symbolized the heart of Venice, named after its founder, has since transformed to this new age Rodeo Drive. You almost have to fit the rich hipster dress code just to be seen walking past the overpriced retail outfits that have quickly replaced the long standing staples of the street that could no longer keep up with the egregious rent spikes forced upon them by the economics of supply and demand.

Five plus years ago, I welcomed the gentrification. I thought Venice could use a little touch up. The streets were rampant with homeless, who, on the surface, I don't have much of a problem with, until they turn dangerous. And they did. Multiple times. At least in my little Venice bubble. What I didn't want, nor could anticipate, was an entire facelift.

Complaining about the Silicon Beach wave is nothing new. But what may have slightly gone unnoticed, with their rise to power at the expense of the locals being forced east in a form of perverse reverse manifest destiny, is this town's fun being torn down with it. Its flare. Its spirit. Its refuge from reality. You can still feel it on the boardwalk strip, but it has been mainly relegated to the teens, the performers, the drifters, the tourists, who come from all over the globe, that would never know the difference.

The Unhoused Sleep - continued from page 1 nity partners, some long-time homeless activists stated they have been shut out of the entire process. Calvin Moss, activist with "Food Not Bombs" and Co-founder of the Venice Justice Committee sited three organizations Bonin should reach out to: the Venice Justice Committee, Food Not Bombs, and the Occupy People. These people in these groups, Moss continued, are not only doing the outreach, but are not afraid of the homeless.

The outreach plan also includes requesting a \$50,000 grant for the LAPD Chaplains Regina and Steve Weller and increasing training for first responders.

As part of the street strategy here in Venice, Bonin proposed a variety of specific actions. The first is to use the Westminster Senior Center for a voluntary storage facility for the homeless. Chrysalis would serve as the non-profit partner to manage the facility. In his overall city plan, Bonin said Los Angeles needed at least fifteen voluntary storage facilities. Right now, there are only two: a small trailer here in Venice; and a warehouse on Skid Row.

The second action is to either find funds or buy a trailer for the non-profit group, Lava Mae, to bring mobile shower units to Venice. A third action Bonin is proposing is to increase restrooms. Two ways to do this would be to keep Ocean Front Walk bathrooms open later or round the clock; and to bring Porta Potties to the community.

Although Bonin's survey showed significant support for safe parking, Bonin simply called it a missing piece. In the public comments, both Peggy Kennedy and Margaret Molloy reminded Bonin that safe parking was promised by Councilman Bill Rosendahl in 2010. At the time, Bonin was Chief of Staff.

How much would the City and the Venice plan cost? 1.8 billion dollars over a period of ten years. To fund the plan, Bonin is proposing some kind of ballot initiative in November.

Following his presentation over forty-five community members were given up to two minutes each for public comments

The community received Bonin's presentation with a mix of enthusiasm, distrust, and anger. Three consistent concerns were funding, expediency, and de-criminalization of the homeless. John Raphling, a civil rights and criminal attorney, feared that the ballot idea for funding would be a dodge. Where would the money come from if the ballot issue does not work? He said that de-criminalization was not discussed in Bonin's proposal. "We need to stop criminalizing people for being poor and living in the streets," Raphling stated.

Linda Lucks, former Venice Neighborhood Council President, and Peggy Kennedy, Co-Founder of the Venice Justice Committee, thought Bonin was not acting quickly enough. Although Lucks was thrilled with the proposal, she pointed out that it had taken four years to get here. "It has to be on a fast track. We're in an emergency." She said that there were over 400 parcels of city owned land just in CD11 alone that could be used. She called for Mayor Garcetti and Bonin to step up.

In an emotional voice, Kennedy called Bonin to "put tents, bring trailers, and open toilets, for God's sake. It's an emergency. People die! Do you know people die from being homeless . . . It's a horror story." She also stated that unless there is a violent incident, armed police were not necessary.

Since the Town Hall meeting, the City has made four motions that support some of the specific goals in Venice. The City, however, also passed Ordinance 184182, amending Section 56.11, Article 6, Chapter V of the Los Angeles Municipal Code to regulate the storage of personal property in public areas. Now, other than tents, belongings of the unhoused must fit into a 60 gallon container or they will be confiscated and stored in a distant location. This motion was passed, 13-1, the day after Bonin's Town Hall. Only Gil Cedillo opposed it. Is it any wonder that Venice activists and some residents do not trust Bonin?

As the meeting started winding down, a voice in the back of the room rose, addressing the LAPD directly. It was Calvin Moss. "LAPD, you should be ashamed of yourself . . . how many more people are going to be murdered in Venice?" He was referring to the three men killed in 2015: Brendon Glenn; Jason Davis, and Jascent Jamal Warren. Both Brendon Glenn and Jason Davis were shot by LAPD officers. Twice that night, Moss brought up the fact that no one had talked about these deaths tonight, but they should have.

Moss, along with Peggy Kennedy, then left the meeting. In an instance, the calmness of the meeting changed to aggression, at least in the back of the room. Senior Lead Officer Theresa Skinner appeared agitated by Moss' words. She looked across the room at two other female officers in the back corner and, in unison, without a word exchanged, the officers charged out after the two. Moss and Kennedy had not only left, but had done nothing to warrant their action.

The Beachhead reached out to Calvin Moss after the meeting. Asked about the officers' behavior at the meeting, Moss replied that "the LAPD and City of LA are well aware of the activities of the activist groups that work independently of the city and have referred to us as 'Carol's Cadre,' in the past. Carol Sobel is the Civil Rights attorney that has supported the unhoused in Venice and LA. The LAPD have repeatedly tried to intimidate these activities." Also, on February 17th, the law office of Carol Sobel and John Givensbn, filed a civil lawsuit against the City of Los Angeles on behalf of the Venice Justice Committee and Peggy Kennedy. The lawsuit seeks to challenge the sunset provision on Ocean Front Walk. Currently, this provision does not allow solicitation of donations for free speech activities after sunset.

The officers' sudden and aggressive display demonstrates the surprise nature of the unacknowledged, collective shadow. Until we acknowledge the dark emotions that we project on the unhoused, movement towards ending homelessness will be at a snail's pace. And, each night, when the sun goes down over the City of Angels, our collective shadow will continue to claim dominion over its most vulnerable citizens.

Business as Usual continued from Page 1 services. Instead of making those who are profiting the most pay their fair share, their solution is to give these Private Entities even more power over our Public Spaces.

What we are seeing is not just one isolated incident, we are seeing an entire pattern and practice of major decisions being made behind the scenes and behind our backs, without proper community input, while those with the financial influence receive access to the policy writing process.

Now, when we confront our public officials about what, by all appearances, are grave Conflict of Interests concerns, our questions are brushed aside. We are told to believe that "This is the way things are done all the time. Everything's fine."

When we then point out that "This is the way things are done all the time. This IS the problem," there is suddenly a mental disconnect. Those who work within the system have great difficulty understanding that Business-as-Usu-al, the very way decisions are made across the board – at every level – for decades – where we listen to the moneyed interests first and the community last, if at all – is the fundamental problem with our government.

If we do not include all the voices from our community – especially those who are most affected by the decisions we make – from the very beginning of the process – then how can we be surprised when we see Venice spiral into greater and greater inequity?

Perhaps there are those who don't know, or even just don't care, there's plenty of money to be made for those who never have enough. For those of us though who really do care about the future of Venice, we need to think long and hard about the direction we are going in, of what is being built and all the people who are being left behind.

We're all in this together. Business-as-Usual will not solve our problems. Together though, by including all of our voices and perspectives, we can decide for ourselves, as a community, what our future will be.

is time we are allowed legal, nighttime camping on the beach within a few designated areas. In addition, city lots that are going unused during the overnight can be open to parking for RVs and street people living in vehicles. We are asking, too, for a tad more privacy at the beach showers.

There are many communities in this country that are much farther than Venice in having these kinds of dialogue with their own population of street people. As the heart of our community shines forth in how we solve these problems, we have an opportunity to be a national model of what a balanced, community-centered approach looks like in dealing with street people. I look forward to what Venice comes up with.



Judge Garland Stumbles Over The Venice Post Office

When President Obama nominated fellow Harvard Law School graduate Merrick Garland to the Supreme Court on March 16, he thought he was picking the least controversial judge he could find. Garland has been a judge, and then the chief judge, for the U.S. Court of Appeals for the District of Columbia Circuit, since being appointed by President Bill Clinton 19 years ago.

After carefully vetting the judge, Obama knew there would be no scandals such as pot smoking, a boyfriend or other social alarm bells that would drive Republicans crazy. And, Obama knew that the judge had never addressed issues such as the death penalty, abortion or gun control. The D.C. Circuit deals mainly with reviewing decisions of federal government agencies, including the U.S. Postal Service. Garland kept his head down while plodding rough federal regulations.

What the President didn't know was Garland, in at least one case, was either unable to read or understand the plain language in a federal statute, and consequently made the wrong decision on the case. One attorney, in a polite response, said the decision was "deeply flawed." In the legal world, incompetence is worse than having political beliefs or puffing on a joint now and then.

What does all this have to do with Venice? Well, the case that Garland fumbled had to do with the Venice Post Office. When word leaked out, in 2011, that the historic Venice Post Office would be up for sale, several individuals and organizations came together under the umbrella of the Coalition to Save the Venice Post Office. The classic Roosevelt-era building with its equally classic mural, The Story of Venice, had been a regular stop on the rounds of generations of Venetians.


Now it faced an unknown future because of a decision made 3,000 miles away.

The Coalition mobilized Venetians with flyers, rallies, and meetings. Since all the decisions were made in Washington D.C., we formulated an appeal to the Postal Regulatory Commission (PRC), which summarily denied the appeal without holding a hearing.

The Coalition then made contact with a D.C. attorney who had expertise in the byzantine world of federal regulations and requirements. A petition for review of the decision of the PRC in allowing the sale to go forward was filed with the District Court and ended up in the lap of the chief judge, Merrick Garland.

Attorney Elaine Mittleman, acting on behalf of aggrieved Venetians, pointed in her petition to "the plain language of a statutory provision, 39 U.S.C. § 3663" which requires a court review once the petition is filed.

Since this section of the U.S. Code is the heart of Garland's mistake, it is reproduced in full: A person, including the Postal Service, adversely affected or aggrieved by a final order or decision of the Postal Regulatory Commission may, within 30 days after such order or decision becomes final, institute proceedings for review thereof by filing a petition in the United States Court of Appeals for the District of Columbia. The court shall review the order or decision in accordance with section 706 of title 5, and



5 • May 2016 • Free Venice Beachhead chapter 158 and section 2112 of title 28, on the basis of the record before the Commission.

Judge Garland, in his decision of July 8, 2014, discounts the 2006 law, above, and claims it does not supersede a 1974 provision that exempts post office closings from judicial review until the PRC has made its ruling. Garland took this to mean that no court review was necessary even after a PRC ruling.

Mittleman told the Beachhead, "I can't overstate how flawed this opinion is. Agencies must know that their final orders can be reviewed in court – that is part of what should make agencies operate properly. Judge Garland missed this very fundamental point?"

A post office closing, for many people, is the most important decision the post office can make since they are reliant on its services. Judge Garland may not be aware that there are many postal patrons who need a full service post office within walking distance, and many more who take civic pride in the stately, and massive, design that says, "here is a city worth noting."

Meanwhile, as the legal filings, pro and con, continue, what has been the effect of Garland's decision to disallow a court review, and a possible reversal of the PRC's decision to sell the Venice Post Office?

Today, the once-beautiful building looks like an abandoned ruin. An advertising and graffiti-laden plywood fence surrounds the property. No work appears to have taken place in a long while.

The Postal Service sold the building to Hollywood Producer Joel Silver, who said he would remodel the building for use as his company office. Meanwhile, several of Silver's recent films did poorly at the box office, according to Variety magazine. Contractors' bills went unpaid, resulting in liens against the property. Little or no work has been done since the lawsuits against Silver were filed a year ago. If the suits are not settled, one result could be a forced sale of the property to pay the bills.

In addition, the mural that greeted postal patrons in the lobby has gone missing. The Story of Venice painting by noted artist Edward Biberman had hung in the post office since 1941. At the time the building was sold to Silver, he also leased the mural from the Postal Service. The lease agreement required the mural to be on public display at least six days per calendar year. Concerned Venice organizations did not learn about this provision until after the fact, nor were they provided with a copy of the lease agreement.

In any case, Silver has not complied with this provision, weak as it is. A number of people have told this reporter that they would prefer to have the mural on display at the Venice/Abbot Kinney Library where it could be seen by many library patrons during regular hours.

The sad story of the Venice Post Office has been due to the lack of concern by Postal officials, Judge Garland, Joel Silver and his creditors. The lack of support for the postal system by the U.S. Congress in favor of private corporations like UPS and FedEx is behind the shrinking role of this public service. The USPS is prohibited from "competing" with these private entities, and must pay them to ship its parcels.

The reestablishment of a postal savings bank was floated by both the Venice Coalition and Sen. Bernie Sanders, among others. Such a bank would attract low-income earners that the commercial banks don't even want. Instead, the Venice Post Office ran into a meat grinder of fiscal and social irresponsibility which was then continued by Supreme Court Nominee Merrick Garland.

Green Fences

The Westside Tenants Union held a meeting at the Venice Community Housing Corp. (720 Rose). 39 people were in attendance and some of the issues discussed were:

- Stopping evictions for seniors and handicapped

- Taking pictures or calling 311 when you see a green fenced property
- The importance of showing up for meetings
- Historic Preservation Overlay Zones

- Crashing secret meetings (page 1: Business As Usual)Needing bloggers

There was also an exercise on how to make important points in under a minute when speaking to the media or

to city officials.

The W.T.U. also held a Rally earlier last month at the abandoned Senior Recreational Center (Westminster & Pacific), the dog park, is also located here. The building has been vacant for over 3 years and could be used as a

storage facility for the "houseless".

Coincidentally, there are three members of the W.T.U running for Venice Neighborhood Council!:







REVIEW: FLAKED by Eric Ahlberg

This 10 part Netflix series takes place mostly around Abbot Kinney Bl.

SPOILER ALERT – I am going to critique the entire season, including late season reveals.

Go watch it first, because after this you will see it with different eyes.

Marxist Summary: a lumpen bourgeois fakes everything, Save's Venice, and gets the Girl. It lacks any activist perspective, and dwells on the corruptions and frailties and exploits of its characters. It is a bourgeois story because it is all about individuals, and not about collective action. It is a funny and writerly piece, with a quite complicated plot and a lot of deception and mendacity, which I liked, in the end

The Lead, "Chip", played by Will Arnett is a slacker/ self-help guru(?) with a storefront on Abbot Kinney where he makes stools. Chip has used it for 10 years, but it seems obvious that he is not really running a business, he is just hanging out at AA meetings at the Dog Park to pick up women. Chip fucks a few women but none of them seem to really want to hang with him. Chip is a piece of work. Chip lives major lies. Chip hamms it up for the AA Meetings where he goes to pick up chicks. He took the blame for a manslaughter charge for his ex-wife in exchange for tenancy in the studio. Her dad wants to sell the studio now, the deal being limited to 10 years. Chip allies with the "Save Venice" movement, who want to prevent a large hotel being built on the property. But for him it is really all about his ex's family who he is trying to manipulate. He drips sincerity when sharing his pain, but things are not what they seem.

Overall the plot has a wicked layering of duplicity, sequenced into reveals. It takes our community struggles as backdrop to a existential and dark comedy. Knowing as many of the real-life players as I do, this feels like a bit of a rip-off.

Many have criticised the awkwardness, even the unbelievability of the major hook-up between Chip and London. I believe this is deliberate because Chip and London are both enormous liars, hiding secrets. London (she is using a fake name) is seeking the man who killed her brother (publically Chip, privately, his ex-wife), and fleeing a wedding. Chip really didn't do it, but he can't tell her. Yet she seems to want to cling to him like a broken person. In this existential mess swims Chip's motivations

to support "Save Venice"....really?

The Lead character, Chip, saves Venice, in a monologue before the Venice Neighborhood Council, going on far longer and with more melodrama than anyone would tolerate at those meetings. This is what heroes and anti-heroes do in mythology and screenplay, fair enough. This reduces the gentrification issue to a dispute with Chip's Ex-wife's family. Putting Will in the center of the anti-gentrification movement does a dis-service to that movement. The Hotel is stopped because Chip manipulates his wife's family, but his ex-wife's father evicts him anyway, for spite. In a final reveal of his despicable character, Chip has been stealing his best bud's wine (he is a high end wine seller), and drinking it, and not telling his AA Sponsors.

At one point a lot of (staged) anti-gentrification demonstrators march down Abbot Kinney (on the sidewalk, they probably couldn't get street closure for the shoot).

The location shooting is nice because they utilize many of the older bungalows as the residences of the characters. It looks funky, like funky Venice. Perhaps too much Venice lore and jargon is used because I can't imagine most people getting the jokes about streets.

The AA backdrop to the story is appropriate, there are up to seven AA meetings in Venice per day, and we have a lot of Halfway Houses and rehab clinics.

There is one Black character, a policeman, with a perverse sense of humor. At one point he bursts into his friend's apartment in uniform and with gun drawn, just for fun. It's disturbing to see Police portrayed as dangerous clowns, however, from reports I have heard, this is how police joke with their friends, privately.

One flaw so obvious it must have been on purpose, is that the characters would leave their bikes and skateboards out in the open without locking them up.

There is an slimy evil nerdly Silicon Beach Billionaire dickhead caricature, which we like to see, but we are easily pandered to. He and his ex-wife's lesbian fiance turn out to be the financiers behind the Hotel.

This is broad humor and dark satire and ultimately does more harm to Chip's character than to the "Save Venice" movement. Still it feels weird to see our community's struggles fictionalized.

The Marxist Critical Razor asks

Does it portray the oppression of the working class. – negligible

Are the Workers shown to be aware of their oppression.


– a little

Are the workers struggling to overcome their oppression. – mmmmm

Are the workers victorious in overcoming their oppression. – ambiguous.

Conclusion: This is a bourgeois piece of trash that does a disservice to our community's struggles. Chip, who Saves Venice, gets called "Mayor of Venice", and gets the girl, is a complete dick. It is quite funny however in that uncomfortable embarrassing observational humor sort of way.

But what about the overall gestalt of the thing. Metacritic: Critics: 43/100 User: 2.4/10 – ...pretty bad. I think it's hard on viewers when they finally realize what a dick Chip is.

penned with an in lieu fee. Yes. So the City Of LA can collect funds paid by developers to wiggle out of their responsibility required by MELLO to replace the affordable unit they are erasing from the rental market. The City collects, interest on these funds are favorable, and it's for affordable housing in the near future. How near is near? We don't know, we asked for a timeline at the townhall and never got an answer. The answer: How about the in

lieu parking fees collected in the last 15 years? How is that being handled and how many parking structures have we built within the 2 miles the funds were collected? If there were ever an in lieu fee - make it a million bucks! There is a viable and feasible solution!

Did anyone ask you about the in lieu fees? How about the BID(s)? The VNC approved the proposed BID presented by a defunct Business Committee and an illegal vote took place. This Business Committee has yet to post their minutes from 8 - 9 months ago and post the required BROWN ACT notifications for their public meetings, info such as meeting location, date and time. Thanks VNC President Newhouse for 'looking into this... ' it timed out and this activist requested this to be placed on the agenda for March and it was denied. Yes, the vote was not legal and my inquiry failed. Tell us how this is legal again in our bylaws? Please ask VCHC and LACAN about BIDS. This OFW BID will further privatize our public beach and criminalize the homeless people. Just like DTLA and Hollywood - criminalize the very people the City Gov't Reps claim to assist.

There was a list of promises in the town hall offered by CD11- but these promises cannot be held true without controls placed to tighten up the current laws. Nothing new needs to be written... These promises are empty without slowing or stopping the current rubber stamping of proposed development applications - we need an ICO on all MELLO applications. We need an ICO for a year.

The system is beyond rigged and beyond corrupt. It's also glaring how CD11 chooses to communicate with the community...'Combat Homelessness...' Perhaps a thesaurus can be of help to offer a kinder and more humane support. Are we at war with homelessness?

Don't just talk about it - be about it!
