VENICE DOGZ start online petition against National Chain Stores on Ocean Front Walk

The Venice Dogz: An Alliance for the Preservation of Venice, the activist group who started the protests against Snapchat and their expansion in

Venice, has a new battle on their hands... prohibiting future national chains and franchises on Ocean Front Walk. After Ben & Jerry's opened back in March 2018, The Venice Dogz sent a notice to all property owners on the walkway that they plan to picket, protest



and boycott any future national chains that open on Ocean Front Walk. They mailed the notice to all




mailing addresses on the BID, emailed over 200 realtors in Venice and LA, and also hand-delivered it to each business on the walkway. Their notice can be seen in the April 2018 edition of the BeachHead however, the property owners seem to have ignored it given reports that Starbucks and Skechers will be opening soon right in the middle of Ocean Front Walk.

Mark Rago, a leader of the Venice Dogz, has been informing the Venice Neighborhood Council for months about other cities all over the country that have imposed ordinances against the expansion of national chain stores that include McCall ID, Port Townsend WA, Carmel by the Sea CA, Arcata CA, Bristol RI, Dennis MA and many more. He says bigger cities such as Boston MA, Portland OR, Brooklyn NYC and Boulder CO have also started taking similar steps. However, the most notable city to prohibit national chains is right up the 5 free-way.

San Francisco has had ordinances in place since 2004 and prohibits "formula" establishments entirely in the areas of North Beach, Hayes Valley and parts of Chinatown. The city's regulations define a "formula" retail use as an establishment that shares common features, such as a standardized array of merchandise, trademark, architecture, and décor, with at least 11 other establishments worldwide. The term "retail use" includes both stores and restaurants, as well as some services. Under a city law, a "formula" retail store or restaurant cannot open in any of the city's neighborhood commercial districts unless it undergoes a public hearing and obtains special approval from the Planning Commission. The initial outline of San Francisco's "formula business policy" was enacted by the Board of Supervisors in 2004, when it added formula retail stores and restaurants to a list of uses that require neighborhood notification. This meant that nearby residents were notified when a chain applied to be located in their neighborhood and had the option of requesting that the applicant undergo a review by the Planning Commission.

In 2006, voters overwhelmingly endorsed a referendum that greatly strengthened the law by making formula businesses a "conditional use" in all neighborhood commercial districts, meaning that each application is reviewed and approved on a case-by-

Abbot Kinney Festival 2018 Conversations

Abbot Kinney Fest 2018 drew a diverse crowd of Venetians, Los Angelinos, and tourists of all ages, colors and economic backgrounds.

I took a sampling to discover if they lived in Venice, for how long, and whether they were concerned about gentrification. I'm curious what people feel about our homelessness issues, and what they what they knew of various potential proposals meant to ease the crisis, so I asked if they have heard about the potential Reese Davidson Community, the permanent supportive housing development currently being considered to be built in the land currently used as a parking between North and South Venice Blvd, or if they had heard about it by its previous name, Venice-Dell- Pacific, (aka the "Monster in the Median" by NIMBYs strongly fighting against the development).

I also asked if they knew about and supported Councilman Bonin's proposal to use the long dormant MTA lot on Main near Rose as temporary bridge housing for the homeless, and if they had any other pressing issues they wanted to share.

The first person I interviewed lives in SM. The 60ish gentleman is concerned about gentrification because his building has just been bought. He hadn't heard about Reese Davidson by any name. He had heard about the Bridge housing a bit but had no real idea what was going on. To him it "seems stupid". Why? The location, he responded. They should sell the location and make so much money and put so much more housingelsewhere.

My next conversation was with a woman who had lived in Venice for 26 years. To her, gentrification was of no concern. "It comes with pros and cons". She sees the bright side, since she's a homeowner and is reaping the benefits. She lived here when there were gangs, shootings, drug houses. She's part of an East Venice neighborhood group working on positive change. She hasn't heard about the Reese Davidson Community proposal. She feels the MTA Bridge Housing proposal doesn't make sense. Thinks it would cost billions, and Venice is

THE FIGHT FOR THE FIRST BAPTIST CHURCH CONTINUES

The following is from a recent conversation with Dr. Naomi Nightingale about the hearing before the Department of City Planning's Office of Historic Resources to apply for historic monument designation for the First Baptist Church of Venice.

Jon Wolff: The Save Venice team that's fighting for the First Baptist Church of Venice enjoyed a victory yesterday.

Dr. Naomi Nightingale: Yes. We were absolutely elated and relieved that the Commission gave us an approval. That approval meant that they would consider our application to make First Baptist Church of Venice a historic monument. So that started the process. If we had gotten a "no" vote, that would have pretty much put an end to the effort for historic designation.

JW: What's our next move? What can we expect to happen next?

NN: They will schedule a site visit. After that, they will use their criteria to determine eligibility for a historic designation. Then they will schedule another hearing where they will let us know their determination thus far. I don't know what the time period is for scheduling that. Our group needs to meet to figure out what they will be looking for. We don't know where the stained glass windows are. We don't know where the crosses are. We don't know where the crosses are. We don't know where the pews are. We have no idea what it looks like on the inside of the church.

JW: The Save Venice team made a presentation based on the value of the history of the church.

NN: Absolutely. We talked about the value of the history of the church, not only in terms of its structure and what was involved in the Community participating in funding the structure and continuing to support the church after and throughout the building, but also about the significance of the church in terms of value to the Community as a place of refuge, as a place of counsel and Community-grounding and unification. It was a source of Community events and activities and a place where people went to celebrate weddings and to have homegoings and funeral services for their families. The significance of the church goes beyond the building itself and is inclusive of the land which the building sits on. And the land across the street where the original church sat, because all of that is infused with the African-American contributions to the entire area now called Oakwood.

JW: The history of the church included so many First Baptist Church—continued on page 3

case basis. Under the law, the Planning Commission must hold a public hearing and base its decision on several factors, including whether similar goods are already available within the district and the compatibility of the proposed business with the character of the neighborhood.

No other large American city has done as much to stop the spread of chain stores as San Francisco. In fact, the national average of stores that are considered retail and restaurant chains in the U.S. is 32%, but San Francisco hosts only 12% thanks to these ordinances they put in place over 14 years ago. More information about their ordinances can be found here: https://ilsr.org/rule/formula-business-restrictions/2321-2/.

Says Rago, "If San Francisco can prohibit national chains in North Beach, Hayes Valley and parts of Chinatown, there's no reason we can't do it here in Venice for Ocean Front Walk. People don't come to Venice and the walkway to go to a national chain establishment - they come to see what they don't see anywhere else. It's the character and diversity that separate Venice from every other town and tourist attraction in the world. That's what makes Venice special. That's why most of us live here and that's why most of us love it as much as we do. And that's why Ocean Front Walk must be protected and preserved. It's not an artificial mall that you can see in every other part of the country and that should be celebrated, advertised, protected, and honored." Penske Media Corp. declined to comment on Monday about whether it will reassess a \$200 million investment by a Saudi Arabian public fund earlier this year.

Hollywood has been under mounting pressure to distance itself from the Arab kingdom in the wake of the disappearance and alleged murder of Washington Post columnist and Saudi dissident Jamal Khashoggi.

In February, Penske, which owns Hollywood trades Variety and Deadline among other publications, received a \$200 million infusion from Saudi Arabia's Public Investment Fund.

The deal was hailed as a "significant milestone for PMC and its stakeholders" by the company at the time.

"After a decade of growth without raising any outside capital, this minority funding will further amplify our investments in existing PMC properties and provide additional resources for future acquisitions," Lauren Utecht, vice president of communications for the company, told Penske-owned WWD in February.

Utecht did not respond to repeated requests for comment via email and phone on Monday. An email to Jay Penske, chairman and CEO of PMC, also went unanswered.

Khashoggi has been missing since entering the Saudi consulate in Istanbul on Oct. 2. Turkish authorities have accused the Saudi government of murdering Khashoggi, a prominent critic of Saudi Crown Prince, Mohammed bin Salman.

The Saudi government has insisted that Khashoggi left the consulate soon after he arrived and that he was not in its custody. But on Monday, CNN reported that the Saudis were "preparing to admit" that Khashoggi died during an interrogation gone wrong.

News of his possible murder prompted a growing number of media companies and executives to drop out of the Future Investment Initiative, a high-powered international conference scheduled to be held Oct. 23-25 in Riyadh. That includes Viacom CEO Bob Bakish, New York Times columnist and CNBC anchor Andrew Ross Sorkin, The Economist editor-in-chief Zanny Minton Beddoes and Los Angeles Times owner Patrick Soon-Shiong. Similarly, The New York Times announced it would no longer be a media partner of the event

On Monday, WME's parent company, Endeavor, signaled that it was preparing to withdraw from its \$400 million deal with the Saudis.

An individual with knowledge of the situation told TheWrap Endeavor was in the process of pulling out of its deal, though the logistics have not been resolved.



Penske and Endeavor aren't the only Hollywood players in business with the Saudis, though they are two of the most prominent to have recently sold major stakes to the sovereign fund. AMC, IMAX, World Wrestling Entertainment and others also have deals with the kingdom. AMC did not respond to multiple requests for comment. A rep for IMAX declined to comment.

In May, IMAX announced the signing of a multi-theater deal with Vox Cinemas, as the premium screening format planned to expand into Saudi Arabia. But a person with knowledge of the situation told TheWrap Sunday that plans to build more movie theaters in the kingdom, which have been mired in red tape, will likely be put on "pause" following Khashoggi's disappearance.

WWE, which is due to return to Saudi Arabia on Nov. 2 for its "Crown Jewel" wrestling event, told TheWrap in statement that it's "currently monitoring the situation"

Khashoggi's disappearance has cast a long shadow on the Crown Prince, who in April got the royal treatment during a Hollywood charming spree. The visit included a high-profile dinner at Rupert Murdoch's Bel Air estate. Among attendees were Disney CEO Bob Iger, Universal's Jeff Shell, Fox TV exce Peter Rice, and actors Morgan Freeman, Michael Douglas and Dwayne "The Rock" Johnson.



AKF Conversations – continued from page 1 already overloaded with services. She also thinks they should sell the land to make more of an impact on homelessness. Go inland and buy blocks. When I ask her where that would be she didn't know... hasn't done the research. She is frustrated since she's surrounded by services like the Claire Foundation, and it hasn't helped. Feels the homeless population needs to be held accountable. She points out that they're not acting like good neighbors, and are not seeking housing or services. She passes a place every day off the 10 freeway near 23ish and Olympic, which gives services, and is empty every day...she finds it frustrating.

Next I spoke to a beautiful young couple who are not from Venice. The striking 21 year old girl is from the Netherlands, here in the US to work and visit, and staying in Tarzana. She finds our homeless situation surprising. "Didn't realize how bad it is! Worse than anywhere else in 1st world countries." When I asked her why she thought that was she replied "Health insurance" and the US "Doesn't take care of people". Her boyfriend, who is from Australia chimes in, "Lack of welfare". In Australia, the government gives people looking for a job \$300 a week. ... Gives them a chance... they offer free counseling/therapy. The couple doesn't think the housing crisis is due to higher rents. They think we need to spend our tax dollars "less on weapons, more on people". In Australia the rent is high, but people earn more. There's a bigger middle class, same in the Netherlands.

A middle aged man who works at the Venice Library has lived in Venice since 2001. He's concerned about gentrification, concerned about his 14 year old daughter. Regarding the homeless he says, "something has to be done...out of control for a long time...we need the right funding county/city/ state. Hadn't heard of the name Reese Davidson, but had heard word of the potential project and supports it. He also supports the Bridge Housing proposal for the MTA.

A 40ish scruffy fellow has lived in Venice since October 1995. His gripe was that he was forced into the Venice BID which is 2200 per year. His property was zoned commercial but it's always been residential. Built by Abbot Kinney in 1920- 100 years ago. The state law says if it's zoned commercial he needs to pay. He hadn't heard of Reese Davidson but sort of supports it- wants to get the homeless population off the street. He's concerned about the MTA Bridge Housing. "Don't know what they're going to do".

A 60ish man has lived in Venice for 10 years. When I asked if he was concerned about gentrification he replied, "Maybe... What's it to you?" He supports Reese Davidson and Bridge Housing. He's moving away but, "Will always love Venice".

A thin man with tattoos lives nearby for 12 years. Yes, he's worried about gentrification....it's "changed big time". He lived in Chicago before where "people with money took over Chicago". He's for supportive housing, but hadn't heard of Reese Davidson or the MTA Bridge housing proposals.

A young 20 something couple grew up here basically (lived in Fontana) but visited her cousins in Venice. 7 years residence. BF lives in Venice. Yesthey're worried about gentrification and urged a no vote on 10. They hadn't heard about Reese Davidson, but are against the MTA Bridge Housing idea. 'Not so close to residential areas. Once you create that, "break-ins go up... more and more homeless surrounding the potential housing site." They live on Sunset and Main, right near the potential site. They fear..."let's compound everything....Burning Man on the beach....no way of knowing what this is". They want the city to provide support, "but not here....City will do whatever to make money' When I pointed out it may actually get safer due to increased guards at the facilities they seem sur-

An older gentleman was kicked out of Venice in 99, after 27 years. Neighbors were messing with him. Gentrification is here – 110 house tract. Hadn't heard of Reese Davidson, or the MTA Bridge Housing, but says "gotta put them somewhere...tricky situation...He wants them off the street, but somewhere far, far away...feels bridge housing makes more sense than Permanent Supportive Housing."

A 50ish hipster/activist local has lived in Venice for 15 ½ years. Hadn't heard of the name Reese Davidson, but has heard of the project and knows it faces serious opposition. He's fine with it, along with the MTA bridge housing. He feels it's highly political...a moneymaker-should be mixed use and shopping. Not worried about gentrification, but yes, it's affected him. Had "driven the cost of living up, and my friends out". Transformed the neighborhood- "Some good, some not so good

Next I spoke to a tony couple with a young, vivacious 1st grader (full disclosure-they're my neighbors). Husband was born in Venice and lived here until he was 5. He and his family have moved back to Venice around 3 ½ years ago. We agreed AKF Conversations – continued on page 5

First Baptist Church- continued from page 1 events and so many personages that came through the church over the years.

NN: Yes. Originally, the African-Americans that came to Venice, including Mr. Reese [Arthur Reese] and Mr. Tabor [Irving Tabor], started from very humble and very limited beginnings. But as much as they didn't have, they came together to build places of worship. Even if it meant converting an old barn into a religious place. From there, they went to 7th and Westminster where Reese donated the land to build that church in 1927. All of the history and the essence that goes along with it, the narratives of the stories and the lives of the people who made those contributions, were not in easy times. This was 35 to 40 years after the signing of the Emancipation Proclamation, where people came to California from the South hoping to escape racism and discrimination and have better opportunities. Little did they know that were going to face some of that same racism here. They were relegated to living in this restricted covenant area and told, "This is where you can live. Nowhere else. This is where you have to learn to thrive. You can't go outside of this. None of the fruits of the area outside of this boundary do you have access to." These people and the people after them, including my grandparents and my parents, took what they thought was the least and made the best of it.

JW: The church is the symbol of that very struggle.

NN: The church is the iconic symbol of that struggle. Because, when anybody passes, drives by, walks by, and sees the neon sign of First Baptist Church, they remember. They can say, "I got married there." They can say, "I went to church with my grandparents there every Sunday." "I went to Sunday school there." "I was a member of the Boys' Junior Choir there." So many things happened in that church that, visually, it standing there and being the beacon and the symbol in this Community keeps people, not only rooted to their Black History, but infused within their own history, and gives them a sense of pride that says, "Yes, that's our church."

JW: Now the Penskes and their lobbyists were hoping to argue against this? Is that right?

NN: Well, according to what Penke's wife said, she didn't come there prepared to speak. She thought that "the facts would stand for themselves." Obviously, that wasn't the case. The Commission was swayed by our presentation that the church deserves consideration. And so they did not support the Penskes' project at this time.

JW: To take from what Elaine Irwin [Jay Penske's wife] said, that she wasn't expecting to have to speak... it seems like they weren't expecting a lot of what the Save Venice team has put in their face.

NN: I think that Penske had no clue of what he was up against when he purchased this property. I think that he was ignorant about the kind of pushback that he was going to get. I think he had no idea of the determination and the intelligence and the effort and the organization that the Save Venice group has. I think he might have been a little bit hoodwinked or had the wool pulled over his eyes by Horace Allen, because he didn't do his investigation to what he was really getting into. I think he's totally surprised by this. I don't think he expected this. I don't think he expected it at all.

JW: He can probably expect that this fight is going to continue and that Save Venice is going to keep going.

NN: We're not going to give up. This group is not going to stop. Our energy has not dissipated. We've had people show interest in joining us and helping to continue the fight. Helping to provide the information that we need. To show that the Community is along with us and to ensure that First Baptist Church becomes a historic monument; that it never becomes the Penskes' residential single-family home. And that we're able to maintain and celebrate Black History in Venice.

JW: I believe we're going to win.

NN: It's in my heart. I don't know anything about losing. I don't see a stopping point. We've got an approval from OHR. That's a green to light move forward. We're waiting on CEQA [the appeal to the California Environmental Quality Act exemption], and we're optimistic about that being a win for us as

So I came to Venice to drain it of its very soul.





First Baptist Church-continued from page 3 well. We're looking to see what we can do with the Coastal Commission, as it relates to their work in continuing to sustain the history of the Venice Community, which is part of their charge.

JW: And the petition is over 32,00 signatures now.

NN: Absolutely. The last we looked, it was 32,600 and I think it's going to grow.

Peggy Lee Kennedy and the Venice Justice Committee advocate for the rights of homeless people on the Venice Boardwalk. The LAPD has regularly threatened Kennedy with arrest for illegal vending in violation of the ordinance regulating such activities on the Boardwalk, that is to say, LAMC §42.15. Thus in February 2016 Carol Sobel filed suit in federal court on behalf of the activists. The suit survived a motion to dismiss after an August 2016 hearing in which not only did the City's oral arguments seem pathetically pro forma but the judge, Dean Pregerson, seemed openly skeptical of the City's position.

And that's pretty much where things stood for over two years until yesterday, Wednesday, October 10, 2018, when the City of Los Angeles passed a motion agreeing to settle the case. The terms are excellent for the plaintiffs. The City agrees to rewrite the relevant section of LAMC 42.15 to explicitly state that activities protected by the First Amendment, including the use of a table, are expressly allowed on the Boardwalk until midnight. The City will also pay Carol Sobel's office \$80,000 for her excellent work on this matter. Turn the page for the full text of the motion. Full text of yesterday's motion settling Venice Justice Committee v. City of Los Angeles:

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect payment of attorney's fees and costs and settlement in the case entitled Venice Justice Committee, et al. v. City of Los Angeles, et al., United States District Court Case No. 2:16-CV-01115-DDP-SS (the pending litigation concerns Los Angeles Municipal Code [LAMC] Section 42.15.) SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the City Attorney to pay \$80,000 for Plaintiff's attorneys' fees and costs in the above-entitled

2. AUTHORIZE the City Attorney to settle the

above-entitled matter along the following proposed terms:

a. The City agrees to change the language of LAMC Section 42.15 in two places as follows:

i. Subsection E.9 would be amended to read: Except as provided in Subsection F.1, no Person shall set up or set down items in, take down items from or block, or attempt to reserve a Designated Space between Sunset and 9:00 a.m.

ii. Subsection F would be amended to change the title of Subsection F (as set forth below), and to insert a new F-1 (the current F-1 and F-2 would be renumbered F-2 and F-3, respectively)

F. Additional Rules for Activities in the Designated Spaces, and Areas Outside of the Designated Spaces, Pagodas, and Recreation Area.

1. Use of the Designated Spaces After Sunset.

No Vending or Performing may occur in the Designated Spaces between Sunset and 9:00 a.m. After Sunset, First Amendment activities, including but not limited to petition gathering, political speech or other protected expressive activity may occur in the Designated Spaces. A person engaging in First Amendment activities between Sunset and midnight may use one table not to exceed 4 feet by 6 feet in connection with those activities. The table must be removed from the Designated Space when the individual leaves and, at the latest, at midnight.

 AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.

This matter was recommended for approval by the Budget and Finance Committee (Krekorian – Blumenfield – Bonin: "Yes") at its meeting on October 1, 2018, in Closed Session as permitted by Government Code Section 54956.9(d)(1).

He hadn't heard of the Reese Davidson development proposal. Has mixed feelings about potential MTA Bridge Housing. 1) Is it the right location? 2) Will it be staffed? 3) Will it be clean? I.e. – will it end up being like a bad motel?? He's concerned the homeless won't use it. He pointed out they don't check themselves into facilities. And it's too small- the capacity is too little. If there are 1000 homeless people and only 20 rooms it would be a failure. He notes that we can't get people to go into the shelters we have, but when it rains they'll go in.

The conclusion I draw from this small sampling of Abbot Kinney Fest attendees is that resistance and fear of potential housing solutions in Venice come in all shapes, sizes and ages. Everyone seems to just want to have the problem go away. Serious resistance seems to depend most on how close the residence is to the service. If the services currently provided were more visibly proving an improvement to the neighborhood, it would help greatly. On the other hand, some residents don't even know where supportive housing already exists. I used to live a block away from one of these properties, a group home, and didn't even know it. I just used to notice how cool the place looked, and wondered who lived there. Communication needs to be better to alleviate safely and cleanliness concerns. And active learning on the part of the residents would be welcome since there is much disinformation being spread about. Regarding the location, Los Angeles will not sell its real estate and buy a larger plot of land ELSEWHERE to house more people. For many reasons. I've been told that "this is the property it owns". I'll dig more into why next month, but the short answer is "It's not going to happen." I've also been told there are "Fair Housing Laws" preventing the relocation of homeless population to ...other places. Turns out the poor have the right to live in

Back in 1975 there weren't very many improv comedy groups in Los Angeles - maybe three or four. Now there are hundreds! One of the groups that pioneered the form in 1975 was Off The Wall. Directed and produced by Dee and Norman Marcus, OTW performed in an upstairs dance studio on Fairfax Ave. in West Hollywood.

In 1978, Robin Williams, who was living in his car, having just moved to L.A from San Francisco joined the group. After one class, Dee asked Robin if he wanted to be in the show the next night. He stayed for a year and a half. Several OTW cast members are featured in the recently released Robin Williams documentary on HBO, "Come Inside My Mind".

Off The Wall had several illustrious guest cast members join them frequently such as Garry Shandling, John Ritter, George Wendt, Chevy Chase, Bonnie Hunt, Betty Thomas, and even Shelley Winters. For a few years, in the 80's OTW's piano player was no other than Michael Feinstein! Chris Thompson, another founding member of OTW created and produced the TV show where Tom Hanks got his start, "Bosom Buddies".

OTW performed steadily for 40 years. They left the dance studio in 1980 and moved to The Improvisation on Melrose where they became the resident improv group performing every Monday night for fourteen years. After that, they were at the Upfront Theater in Santa Monica.

AND NOW, they are performing once a month at the FanaticSalon Theater in Culver City!

The show is completely improvised. Off The Wall does what is known as "short form improv". Inspired by audience suggestions, the six-member troupe performs games, scenes, and spontaneous musical numbers, accompanied by award winning pianist Carol Weiss. They lampoon current events, social morays and even present an "audition for the musical version" of a film that's in current release. Think Jurrasic World with musical numbers.


Andy Goldberg, a founding member of OTW began teaching improv in 1979. Some of his students included Bryan Cranston, Alex Borstein, Corbin Bernsen and Amy Hill. Andy has continued teaching improv and currently has two workshops, one at the Avery Schreiber Playhouse in North Hollywood and the other at the FanaticSalon Theater in Culver City.

Andy has recently put together a new, younger improv group called Mostly Organic. They open the show, followed by OTW. Members of the two groups range in age from twenties to seventies - hence the name of the evening, Generations of Improv Comedy. OTW is primarily the same cast that audiences and critics have raved about since 1980. Special Guest Cast members recognizable from Film and TV also join in the fun.


