FREE TO VENICE RESIDENTS

# VENICE 5 FREED!

Five Venice residents who had been imprisoned after they refused to testify before a federal grand jury in Tucson, Arizona have been freed at least temporarily by a court order granting them release on their "own recognizance" pending appeal

of their contempt commitments.

The Ninth Circuit Court of Appeals in San Francisco, finding that the appeals presented serious legal questions, ordered release on December 23 of Teri Volpin and David Scheffler, who work in Support Our Soldiers, a civilian support group for anti-military GI's, Lee Weinberg, a UCLA counselor, Karen Duncan, who works at the Midnight Special Bookstore, and Pam Donaldson, who was active in Movement politics at UCLA. Teri had been imprisoned since November 3, David since November 19, Lee since December 2 and Karen and Pam since December 3.

The grand jury is purportedly looking into the purchase of dynamite in Tucson by a man the government says is a Weatherman and its transportation into California, and has already indicted John Fuerst, who remains at large, for possession of explosive devises. It has become clear, however, that the special U.S. attorney in charge, Guy Goodwin, is using that isolated incident and supposed violations of the kap brown Law (the Federal Anti-Riot Act of Chicago Conspiracy fame) as the basis for a general fishing expedition into Movement politics in West Los Angeles, particularly at UCLA; and questioning of the Venice witnesses has, consequently, centered primarily on their political beliefs, conversations, associations, and activities.

Despite the fact that Fuerst has been indicted already, Goodwin has indicated the grand jury session, previously extended once to March 31, may be extended again to December 31, 1971, the maximum permitted by law. That points to the conclusion that the Government has absolutely no evidence against Los Angeles people and that it needs time to subpoena and interrogate many more witnesses in the hope that something will turn up. Even if it uncovers nothing, the Government still wins; Movement workers who refuse to testify are granted immunity from prosecution and if they still refuse to talk are railroaded into jail the same day after what passes for a contempt "hearing".

Goodwin's questions—extremely broad and entirely unrelated to the Tucson incident—assured that
the witnesses would refuse to testify. Typical examples follow: "During the time that you lived at
such and such an address, name every person who
lived or visited there and describe all conversations you had with those people;" "Describe fully
your participation in any riots, demonstrations or
disorders during 1969 and 1970;" and with reference to a long list of names, "describe the nature
of your contact with each of those people and all

conversations you had with them."

Each of the witnesses refused to answer questions like those on the legal grounds that the first and fourth amendments forbid Government intrusion into privacy of belief, association and speech, that the fifth amendment allows a witness to refuse to incriminate himself or herself, and that the Government's refusal to allow attorneys into the grand jury room violates the sixth amendment.

Their blanket refusal to testify stems from an understanding of what the Government is seeking to do in Tucson (and in other cities across the country). As the crisis in the economy deepens and as

### THE ORGANIC RIP-OFF CONTINUES

Ghetto groceries are nothing new to Venice. They can be recognized by their incredibly high prices which are often more than stores in wealthy areas. Because few residents have the means to get out and compare prices, they are forced to shop in stores nearby, even though the prices are higher, the food is stale, and the owner has a total lack of empathy towards the community.

This being the Aquarian Age, we now have an organic ghetto grocery to capitalize on a developing concern for healthful eating. New Pars, on the corner of Windward & Pacific is owned by Phil Parker who also owns Pattons Health Food Store in Hollywood and Phildon Electrical Contractors. Parker is a very wealthy man; when you see the prices in New Pars, you will understand why. (See the

November BEACHHEAD).

When the store first opened, Venice was almost unanamously delighted. We really needed a health food store. People poured in with ideas to make the store aesthetically more pleasing, more in tune with the community -- suggestions like art on the walls, using a lot of natural wood, and getting rid of the antiseptic atmosphere and plastic signs. It was my own feeling that the community should make the store responsive to its desires by showing Parker that it was to his advantage in the long run to lower the prices and listen to the Venice people. Unfortunately Parker placed himself above concern for our community. He is so hung-up on making money that nothing else is important. The prices are outrageous and still rising. The painters had to walk off the job to get paid and the carpenters who built the store still haven't received all their money. Most of the Venice residents who have staffed the store have either quit in disgust or have been fired. We wanted a health food store but we got the same old ghetto grocery.

Now, fortunately, there is an alternative to that exploitive food racket. Free Venice has formed a food buying cooperative. Good food is purchased in bulk and distributed among co-op members at cost. There is no profit. Everyone shares the work and everyone benefits from that cooperation. There is a large selection of organic foods from Alta Dena dairy products to natural grains, nuts and honey. Fresh fruits and vegetables are also available at low prices (hoping eventually to have organic produce as well). Below are a few of the items and prices now enjoyed by co-op members. They are compared, whenever possible, to New Pars' prices (their cheapest) as of January 2, 1971, out of sheer delight.

### COURT DECISION GOES TO THE DOGS

Inty is the shaggy sheepdog usually seen on the roof of Doc Compton's house at Ocean Front Walk and Sunset Ave. Inty was recently picked up on the beach, and Doc was given a citation. Instead of paying the \$35 fine he asked for a trial. At the trial he told the judge the leash law was unreasonable because it discriminated against owners who obeyed the law and got licenses (if Inty'd had no license, Doc would have gotten no citation), and because it deprived dogs of their right to run free, which they need to do from time to time to keep their health. He said the City required licenses, but offered nothing in return; he proposed that certain times and places be set aside where dogs could run loose. The judge dismissed the charges. Doc Compton says he already has about 2,000 signatures on this petition, and he wants to get more so he can bring the matter to the City Council. 



Since its inception in July, Central City "Bricks", under the directorship of Gerald Hillsman, has been dealing with the multifaceted problems of ex-felons. The program, which was initially designed to serve approximately 50 ex-offenders during the first year of its grant, has handled more than 200 cases thus far.

In providing services for exfelons, "Bricks" also involves itself with the problems of drug abuse and addiction, and secures legal aid for those who need it. For more information contact CenDr. Brian Hilton, consultant and lecturer on metabolism and applied nutrition, recently conducted a seminar and class for members and students of the professional schools at the UCLA Medical Center.

Dr. Hilton's message to the group, "Your Health and Ecology" stressed the fact that the efficiency of the inner ecology of the body is equally dependent upon proper digestion, assimilation, metabolism and elimination. Foods that effectively nourish, lend impetus to the mechanisms of the body permitting them to operate physically, mentally, emotionally, etc., at an optimum level.

Dr. Hilton will conduct a seminar on Health and Nutrition at the Westminster Elementary School on January 4, 1971 at 7:30 PM. Admission is free. Everyone is welcome. (Hopefully, Dr. Hilton, who is from New Zealand, will become a resident of Venice).

Jerry Wright, a deputy registrar from Venice and a member, fortuitously, of the Peace and Freedom Party, was busted on the Santa Monica Mall, Sat., Dec. 11, for doing just that. Make too much to qualify for Medical and you still can't afford the exorbitant fees of a private physician? A lot of us fit into that catagory. This system, unfortunately, doesn't recognize free medical care as a basic human right. So some people in the community got together to do something about it. They formed the Venice Health Council and out of it came a health clinic with a lot to offer. It is located at 316 Lincoln Blvd (UCLA Dental Clinic by day) and open from 6 PM-10 PM 7 days a week. It provides competent volunteer doctors and nurses, free medicine, an ambulance on call and has made connections with local hospitals for emergency care and lab work. #### VENICE POETS DEFENDED

Dear Bob,

Every time I read your review of the New Venice Poets, I get upset. I don't think you've been sensitive. I don't think you've been fair. Take your first quote, for instance. The lines come from the first part of "The Soldier With His Head Shot Off." They may be "reminiscent of the angry young English poets." I don't know. I haven't read that many angry English poets. But read further. The second part of the poem is strong-full of twistings and leaps. And the last line (a subtle linguistic experiment) is brilliant. Taken as a whole, "The Soldier With His Head Shot Off" is a powerful poem.

And your second group of lines? I don't feel that they're 1950-ish angry or full of unrendered feeling. They come from "To the Monument for the Workers." Krusoe is trying to portray the dignity of a group of "gargoyle-hunched" peasants. Oppressed by men and the elements, the workers built a road. This in itself is meaningful. But in addition, they transcended their oppression. They turned their backs on their road. Revolutions explode out of such turnings. I don't see the oldness. I don't feel the tiredness of this poem. I see the shadows of Che.

But New Venice Poets is not a lifeless Marxist tract. Of course, there's humor in the book. Not the "ha, ha" variety. It's always subtle, twisted, bitter, tortured. Look at the work of Jennings, Dashev, Salmins. Add to this the linguistic experiments of Hirschman, St. Louis, Russo. Add to this the nightmares of Joseph Hanson, Ann Ross, and John Harris. Add to this my own struggling-toward-light fantacy poems. If you don't like Richard Eiden's "The Shade of Ill-drawn Curtains" (the echoes of other poets in these lines don't bother me), then turn to the poet just before Eiden. S.S. Veri's "Loss Among the Honkies" is a gut-tearing major achievement.

Sure, New Venice Poets is not filled with avant-garde poetry.

Sure, the poems are flawed. Who ever heard of a perfect poem?

Sure, each of us has his debts to pay to poets who wrote before him. But trying to be sensitive and fair, I maintain that New Venice Poets is full of powerful original work.

If anyone wants to find out for himself, stop by Beyond Bar-oque, 1639 W. Washington Blvd., and pick up a copy of the book. It's only \$1.00. It's worth far more.

policy becomes more and more obvious, growing numbers are recognizing the necessity of thorough and fundamental changes in the capitalist economy and in all the oppressive and alienating institutions it breeds. More and more people have dedicated themselves to securing those changes. The Government is responding in ways that governments have always acted in times of impending crisis -- out of economic and political self-interest in survival. That self-interest takes many forms, one of the most important of which is the use of the legal system to "legally" stifle and repress those who are in the forefront of the Movement for change. So the Government, desperately seeking a scapegoat to cover its failures, intensifies its laws, blatantly oppressive legislation like the Organized Crime Control Act of 1970 and imaginative legal weapons like the

punitive use of grand jury proceedings. Thus basic notions of "civil liberties" are discarded, thus the courts sanction the open and indiscriminate use of official force more and more readily, thus the Government's power to grant immunity from prosecution becomes a prosecutorial weapon discriminatorily applied. Understanding this, the people who have been subpoenaed have determined that they cannot assist the Government in maintaining itself under the present circumstances and they have consequently refused to give it any information whatsoever.


That has been the traditional position of the left, however, wide spread use of the subpoena power and grants of immunity could force a re-examination of that position. The possibility that large numbers of Movement people could be jailed for up to 18 months perhaps paralyzing Movement activities in some areas may be more damaging than giving the Government relatively harmless information. Certainly, that alternative must now be given serious consideration.

#### EDITORIAL

Several weeks ago, on one of his brief visits to the United States, Yapping Sam Yorty told the Santa Monica Rotary Club he saw "the hand of subversives" in our fight to save the Venice Canals for the people. Maybe you saw it in the Evening Outlook -page one, banner headline seven inches deep.

"The subversive forces have what they call a struggle movement in the Canals," said Yorty. He got a round of applause when he attacked "the doves and obstructionists who are against

everything.

"What a beautiful area that will be if the Canals are built. You find that whenever we want to do something constructive, some opposition will spring up."

The "beautiful, constructive" thing the City wants to do is to move the low and middle income residents out of the Canals and change the area into a very high rent millionaires' yacht basin. The people of the Canals have petitioned the City Council under California state law to be allowed to refurbish the area in such a way that the existing community will not be destroyed.

Putting aside the rumor that Yorty stands to make a great deal of personal money out of this yacht basin, if you keep in mind that he is not the Mayor of the people of Los Angeles but the Mayor of the money of Los Angeles, then you can see that he's right. We are subversives. We're out to subvert his "master plan" for moving all low-income and minority people out of Los Angeles to make way for the rich We're out to save our communities from the land pirates and money sharks who work through City Hall, and to get a little

power for the people. Of course, that's not what Yorty meant. "Subversives" is a good word the money-junkies and

power-junkies use to divide people against themselves. It's interesting the way the rightwing Evening Outlook played up Yorty's speech -- the Funk family that owns the Outlook is speculating heavily in Venice land. If the proposed millionaires' yacht basin goes in they'll make fat, easy profits; if we get our people's renewal area agency for the Canals they

won't.
