DLA CITY MUSTER PLAN

Two years ago the Los Angeles Planning Dept. cranked out the Master's Plan for Venice. Last year that plan was approved by the L.A. City Council. It was the first of a series of 66 community plans, which when all completed will be pieced together to form the General Plan for all of Los Angeles,

According to the L.A. Planning Dept., the purpose of the Venice plan is "...to provide an official guide to the futute development of the community..." But what kind of development do they have in mind?

Area I (Oceanfront)

- 1. high density residential zoning
- 2. widening of Pacific Avenue into a major highway
- 3. development of a Windward Avenue Mail
- 4, zoning out the industrial land bounded by Main Street, Pacific, Sunset and Thernton

Area II (Oakwood)

- 1. an assessment district to widen streets
- 2. zoning out the industrial land bounded by Main Street, Rose, 4th Avenue and Brooks to permit building high rises

Area III (Canals)

- 1. transformation of the Venice Canals into a private yacht harbor with access to the sea.
- 2. razing the existing dwellings in the Canals and replacing them with single family town houses

Area IV (Barrio, not Oakwood)

- 1. high density zoning
- 2. street widening and openings to accommodate the projected high density

Area V (Peninsula)

1. an assessment district to transform the present walkways into streets for improved access

Master's Plan or People's Plan? The City projects a population

of 82,000 people for Venice by 1990, 73,000 to live in multiple dwelling units. Valuable industrial land which could be developed to provide work for local residents is being removed (a bit too unsightly for those who will be able to afford the view). Streets are to be widened and improved all over Venice to service the new residents. And NO provisions to insure that all this development does not displace the low and moderate income people who now live here.

Venice is to become a high density, high income, commuter and leisure oriented beach resort. The Canals and the Oceanfront will be the first to go (with the direct help of the city), and Oakwood will follow naturally in due time. Blacks and Chicanos will be the first to go, as they are generally the groups least capable of absorbing the increased rentals. Poor, but relatively more affluent, whites will follow as their budgets are stretched to the breaking point. All for the sake of profit; all at the expense of people.

Master's Plans are generated by bureaucracies, behind closed doors, in buildings miles from the areas being planned for. People's Plans are made by the people living in those areas, in living rooms, schools, in parks, on the streets, anywhere that people gather, by everyone who wants to help.

Master's Plans are concerned with property and the money that can be rung from it- taxes for the City, profit for the "owners." They are physical plans, land use and zoning maps, which encourage the most lucrative development an area can support, regardless of the consequences for those who live there. People's plans are concerned with life, how people live and how they relate to one another and their natural environment. They are social plans for building vital and satisfying human communities.

Master's Plans are the Plans of the enemy. People's plans are our



Off The Land Speculators

Can you see those land speculators buzzing around Venice like vultures these days? They're about to zoom down on our heads if we don't take action soon. Their plot to sell and buy and buy and sell land here in Venice for high rises on the Oceanfront is in full swing. The C.F. and F. Corporation is pushing for grabs and has been for a long time, particularly in Oakwood.

The inference from all this landgrabbing is plain. Black people, Chicanos and poor whites, senior citizens and unemployed youth are about to be shunted out of Venice if they don't put up a strong fight. Even small homeowners see the handwriting on the wall and that's why they have entered the fight with the City Planning Commisson.

What kind of action could we take at this time to stop their institutionalized violence? The North Beach Resident Property Owners Association is asking for letters from Venice residents to Commission President David S. Moir at L.A. Planning Commission, City Hall, 90012. We ask that we make the letters strong with your indignation. You want to know why the people of Venice can't plan their community. Yes, we are in favor of a zoning roll-back but we also want to plan the improvement of our own community. Also write to Elizabeth Armstrong, Stanley Diller and Neal Petri. They are the other commissioners on the Planning Board, And although they are Yorty appointees who can't stand "dirty" Venice, they'll have to bet the wrath of the people who live in Venice. The artisans, the poor artists, the senior citizens who live along the oceanfront and have lived there for dec-

ades, do not wish to leave. Speak Up, People or you'll be wiped out. The Scharfs and the Kurt Simons sit like vultures, waiting for our carcasses. Write those letters Before January 6, 1972; that's the final day for the commission's decision. Happy New Year!

What's In A Name?

If you have been looking for Howland Canal where our community house is, and you have been lost, you can call it a plot or a dirty trick. Either way, it adds up to the same sneaking dealing, changing the good old American name of Howland to Capri without consulting the canal people. After all, they only live there. And besides why was it changed and whodunit?

The people of Howland Canal weren't asked if they wanted to go Mediterranean and harbor their yachts in the Capri Ct. Canal. No, they weren't consulted in the matter at all.



Community House Court Settlement

Free Venice groups have agreed to a temporary out-of-court settlement of a court case in which the Free Venice Community House property, 468 Howland Av, was cited for activities supposedly not permissible in a residential zone.

The recycling center on the property had been charged with "storage" of cans, glass and newspaper. Public assemblies held on the property were also cited as being out-of-zone, despite provisions of the First Amendment to the U.S. Constitution protecting such assemblies. The City also threatened to cite the Free Venice Food Co-op distributions held at the Community House.

The out-of-court settlement made reduces activity at the Community House to uses more in keeping with a residential neighborhood. The Free Venice Ecology Community agreed to reduce the number of barrels and bins in their recycling center. The Food Co-op agreed to confine food distribution activity to the inside of the house. The City will permit small-scale public assemblies in the yard once a month. If there are no substantial complaints in a month or so, the City will not prosecute.

Many people feel that this case represented political harassment of Free Venice groups because of the part Free Venice has played in fighting the Venice Canal Project, meant to turn the Canals into a private yacht harbor for the wealthy. In a separate case, the Food Co-op has been charged \$210 dollars for back taxes stretching back to before the Co-op was formed.

The Co-op is now distributing food at three different locations so that the Community House distribution can be held totally inside. The cold and early dark of Winter had been making outside distribution increasingly unpleasant. Many Co-op members had also felt that the increasingly too large distributions reduced the sense of cooperation and intimacy they had previously felt.

The Ecology Community will be setting up smaller centers near people's homes. Instead of having one central recycling center, recyclable materials will be taken to the Westside Environmental Center behind the Co-op Market on Barrington Av. If you would like a few recycling cans outside your home, call Milton at 821-5281 or David at 392-7225.

Health Council

The Venice Health Council expects to receive a 50 thousand dollar grant from the Northeast Vally Cooperation which is funded by the OEO. This is to get the Council started in coordinating health services planned for the community.

The Family Planning Center maintained by the Venice Health Council at 316 Lincoln is desperately in need of volunteer help. The monies promised haven't come in yet. The center is open from Mondays to Fridays from 6 to 10 p.m. Persons who can give time once a week or even one hour per week are very welcome. Doctors, nurses, receptionists and all those who can make themselves generally useful in a family health center, please contact Michael Coffey at 392-3430.

New Medical Center

At Hampton drive, corner Electric, in Venice, there will be a new medical center open to serve all people. So says the administrative assistant, Abelardo de la Pena. Nobody who needs medical attention will be turned away. For those who cannot pay medical fees, there will be a screening test to determine the person's ability to pay. Fees will be determined on the basis of the family's net income as is done at the UCLA Medical School. Free to women is a cancer detection test of the uterus and brests, to men, there is also several free cancer detecttion tests.

Med-i-cal and Medicare cards will be accepted. The clinic will operate from Mondays through Thursdays during the daytime hours as a start. Call 392-7722 for more information.

Food Conspiracy

Forty-four members of 16 groups attemded the second conference of Southern California food conspiracies, held in Santa Monica on Dec. 4. Almost every co-op in the region was represented.

A major topic was ways of providing "organic" meat, fish and poultry; i.e., natural protein that has been exposed to the minimum of hornonal and chemical interference. Examples of direct action include the Topanga co-op, which is grazing its own range-grown beef, thus avoiding the commercial practice of adding stilboestrol hormones to produce artificially high fattening rates; and Echo Park-Silverlake, which is exploring the use of meat imported from New Zealand, where law forbids the use of hormone food additives, food coloring, etc.

Joint buying to gain lowest prices was further examined: representatives of the Barrington Co-op Market offered a proposal for buying some products through Associated Co-ops, San Francisco, and another suggestion for buying some products through the huge Certified Groceries group was put forward.

Data on truck operating costs was examined, following up a suggestion for a co-op trucking route.

The working of a co-op store in North Oakland was discussed. This retail store is operating with the direct labor of co-op members, and it may become the focus of the first joint cooperative effort in Southern California. Arrangements are being discussed to provide Oakland with honey, fish, and produce, in return for access to grower-supplies of dried fruits.

A third conference will be held at Topanga in January.

Lavender People

The Lavender People is a group of Gay activists attempting to create a sense of Gay community and identity. We are working to off oppression, create alternatives to the existing Gay environments, and help each other in the struggle to "come out" as Gays in an uninformed and often hostile society. Some of our current workings include: weekly Gay rap sessions; uncovering and negotiating to change any discrimination practices in hiring of Gays; contacting bar owners about whether or not, and why, Gay people are forced to refrain from common behavior, such as holding hands, that is commonplace among our "straight" brothers and sisters in bars; and raising funds to open the Gay Community Center, where we'll be able to meet, talk, read, and dance in an open and non-opressive situation, have self-defense and Gayrelated classes, and involve ourselves in other activities of Gay Liberation. We call ourselves "Gay, Proud, Unafraid, and Defiant".

We have adopted the following statement of purpose, that you might understand us better. "The Lavender People seek to combat persecution of Gays, and to liberate the Gay human from this society's sexist beliefs and practices. We denounce the subhuman status and destructive definitions this society generates about homosexuality. We are working to establish social, cultural and political alternatives, and we encourage Gays to continued on page 5

New Women's Center

On December 4, a group of women from eight or so different women's groups which meet on the Westside got together to discuss plans for the new Westside Women's Center. A building has not yet been chosen for the Center, but it was agreed that the Center should be located between Ocean Park and Venice Boulevards, walking distance from the beach, but not in an area dangerous for women.

When the Center is established, all kinds of things will happen there. We will have a coffeehouse for women which will open two or three evenings a week. On different days different sisters with special backgrounds will be available for counseling and rapping with women who call or drop by for coffee. Everyone had agreed on the importance of having a Welfare Rights worker one day to advise recipients (and women who are wondering if they're eligible but afraid of going down there) on welfare law. Anotherday will be for women with drug problems.



Naturally the Center will be used by Women's groups for their meetings, will have film showings, and lectures of importance. We plan on a small liberation school to start— maybe four or five classes. We agreed that one room should be set aside with toys and

cribs so that women could leave their children while at meetings. It was felt that to try to have a full child care program at the Center would be too ambitious, at least for now.

What is now needed to make all these great ideas become reality is money! Sisters, its going to take about \$700 to open the Center and keep it going until the programs can raise money.

We decided that each Women's group would plan one small fund raising event, like a cheese and wine party, a buffet supper, br a garage sale and that a central committee of volunteers will plan two major fund-raising events, one a film showing of a major film and another an evening of entertainment by (hopefully) some well-known women performers and poetry readings by some local women poets.

Free Louis Talamantez

Al lado de la bahía de San Francisco, murallas grises se levantan de la playa - San Quentin, Seccion B dentrol del prision se conoce el "Adjustment Center". Es una seccion de seguridad maxima donde todos prisioneros son aislamientos. Tiene la intencion de empujar los prisioneros a locura, y se reserva mas para lideres negros y Chicanos de los prisioneros. Se permanecen en el centro, ano despues ano hasta se llevan el processo sobre cargo alguno de conspiracion. Generalmente este quiere decir el castigo de muerte por jurado blanco y gringo.

Esto es la cuenta de Luis Talamantez, no obstante no se ha llevado a proceso sobre el cargo mas recientamente. Tenemos que poner el grito en el cielo para librar Luis Talamantez y los otros hermanos con quien se procesara - Hugo Pinell, Larry Spain, Fleeta Drumgo, Willie Tate y David Johnson, No, no podemos esperar para el anuncio de los verdugos.

Luis, a la Edad de 12, fue encarcelado en "California Youth Authority".
El tiene ahora 28 anos y estaba en
carceles varios para muchos de los
16 anos pasados. Luis Talamantez es un
victima del programa a mantener los
pobres Cicanos, negros, asiaticos y
Indios Americanos en carcel cuando el
gobierno no puede manejar sus rebeliones justos. Luis es un hermano de la
raza quien sabe la violencia y injusticia
del sistema prisioneral. Y porque la
lucha contra ello, los oficiales del
carcel quieren aquietarlo.

En1965 Luis fue declarado culpable de robo (sin armas) y se dio 2 fallos de cinco anos hasta perpetua, segun el fuero vicioso del fallo interminado de California. Y en 1970 cuando Luis pelao con 2 otros prisioneros, fue lo unico declarado culpable y recibio otro fallo perpetual. Si esto no es sobrematar, que es?

En 1971 despues del muerte de George Jackson, los hermanos de la raza, Pinell, Talamantez y los otro 4 fueron cargados con 5 cuentas de conspiración para fugar del prision. Se bato mucho a Hugo Pinell y se atormento a Luis Talamantez.

No tenemos nosotros en Venice cuidado para los prisioneros de la raza y sus hermanos negros? Claro, Talamantez es de nuestro barrio. Pero ademas, el, con los otros, representan el mas gran sufrimiento que los pobres deben sentir en la vida, suframiento que no es necesario, si el sistema prisioneral de veras rehabilite los jovenes confusos en vez de volviendo-los en crimenales degradados y inhumanos.

Debemos luchar con los prisioneros para justicia.

B.A.L.A. (Barrio Alliance of Latin Americans) has a new board. The new members are David Olivera - Chairman, Chino - Vice-Chairman, Calvin Grein -Treasurer, Mrs. Castro - Secretary, and Marta Rodriquez - Sargent-at-Arms.

B.A.L.A.'s new board is not only these brothers and sisters who have been active in the Chicano community, but those ready to work to bring the whole Venice Chicano community together. They plan to develop new ideas and directions to set the Chicano community in motion.

B.A.L.A. membership meets every Tuesday at 8 pm at La Causa Youth Center, 1043 W. Washington Blvd. All Chicanos and Chicanas are welcome.

Venice has had a serious problem with drugs for many years. And these drugs have been used as a tool to oppress our people. Drugs numb the minds of our ninos and make la gente selfish. B.A.L.A. has always been concerned with all of La Raza with special interest in the young people of our barrio. To help the youth with their drug problem, B.A.L.A. approached Venice High with the suggestion that we do a drug awareness program. We want to tell the students about the drug programs available to them in Venice and elsewhere. We MUST DEAL WITH THE EVIL.

B.A.L.A. and P.R.C. (prevention, referral, counselling program) offered to work with the students together with UMAS, the Chicano student group. We want to develop drug abuse awareness through the use of films, raps by Chicano professionals, and literature.

Because of red tape, our program
has not been okayed yet, but we hope
that parents and students of Venice
High will request and support our
effort to get a drug education program
going.

Along the San Francisco Bay, gray granite walls rise from the shore- San Quentin, B section within the prison is known as the Adjustment Center. It is a maximum security section where every prisoner serves in isolation. It is meant to drive the prisoners insane and is reserved most often for Black and Chicano leaders of the prisoners. They are warehoused in the center year after year until they are brought to trial on some conspiracy charge. This usually means the death penalty by an all white jury.

This is Luis Talamantez's story although Luis hasn't been brought to trial on what they have charged him with most recently. We must raise the cry to free Luis Talamantez and the other brothers whom he goes on trial with, Hugo Pinell, Larry Spain, Fleeta Drumgo, Willie Tate and David Johnson, No, we can't wait for the announcement of the executioners.

About Luis- at age twelve, he was committed to the California Youth Authority. He is twentyeight now and has been confined to prisons for most of the past sixteen year. Luis Talamantez is a victim of the racist plot to keep poor Chicanos and Blacks as well as Asians and American Indians in the prisons when the establishment can't cope with their justified rebellion. Luis is a La Raza brother who knows the violence and injustice of the prison system. And because of his struggle against it, prison authorities are trying to silence him.

In 1965, Luis was convicted of robbery (not armed robbery) and was given two five year sentences to life under the vicious California Indeterminate Sentence Law. And in 1970 when Luis was in a fight with two prisoners, he was the only one convicted and given another life sentence. If this isn't the system of overkill, then what is?

In 1971 after the death of George Jackson, La Raza brothers Pinell and Talamantez were charged with five counts of conspiracy to escape the prison as were the other four brothers. Hugo Pinell was severely beaten and Luis Talamantes was tormented. Do we in Venice have any concern for the La Raza prisoners and their Black brothers? Sure, Talamantez came from our community. But more than that. He together with the others represent the greatest suffering that poor people have to experience in a lifetime, suffering that wouldn't be necessary if the prison system really rehabilitated young confused kids instead of turning them into degraded, dehumanized criminals.



Until now, Karen Duncan and Pam Donaldson have refused to talk to the grand jury. Their idea is not to cooperate with conspiracy traps. Right on.

New Year — New Political Campaign

Forty delegates representing the California Peace and Freedom Party attended a Dallas convention over the Thanksgiving weekend. The convention was to invite third parties from across the U.S. and adopt a structure and strategy for change in America.

The new party is called the People's Party and it is made up largely of the old Peace and Freedom Party and the New Party. However, the convention stressed that state and community organizations in the national party have autonomy. This is in keeping with the philosophy that each individual ought to have maximum control over matters affecting his life.

Dr. Benjamin Spock was selected as the stand-in candidate for President. He pointed out at a meeting in Santa Monica that even if the Democratic Party selected someone like McGovern for President, the People's Party would have to carry on. Dr. Spock spoke of the character of the Democratic Party representing big business and therefore they could not be the political instrument whereby basic, fundamental change could be affected in America. Spock's running mate is Julius Hobson, a black man.

Venice and the Master's Plan

The battle for our Venice community continues! To some the war is over. But battles lost or won don't always determine the final outcome. Example: The Venice Canal Project is in the courts and realistically is dead for another two or three years (perhaps the City will now consider Free Venice's alternative plan for the Canals, \$5.5 million vs. the City's \$25 million.

More recent events are as follows: According to the Los Angeles Times (22 Aug '71) Nancy J. Leathers, senior city planner, stated that the Venice Community Plan "will undergo a thorough restudy by the community and city planners alike following a series of recent planning developments." Mrs. Leathers went on to say that a community group will be chosen to help the department.

In response to the above mentioned pronouncement, an Ad Hoc Venice Planning Committee is in the process of being formed. The Committee is open to any Venice resident that agrees with the principle that any future plans for Venice should include its present residents.

The Committee has hired a planner and staff (through a grant from UCLA) to assist the community in developing plans for Venice. As a sub-group, a Conference Committee has been formed to create a National Design Conference to be held in Venice.

Any Community Committee by its nature must be a coalition of various self-interest groups within Venice . . . the Ocean Front, Oakwood, Canals, local business and the like. It is hoped that all of us realize that the common bonding force is the threat of our extinc-

tion.

Ideas as to how to save Venice vary in the Ad Hoc Committee. Some feel that by developing a good plan and presenting it to the City Council, that will do the trick. Others feel that the need for national attention would help explain Venice's problem as not completely unique, but rather symbolic of urban America. Thus, the need for a national conference. Whatever your thoughts, join the Committee and share them with others, working to save the present community of Venice. For information, call 396-6876.

The rest of the people in the people in the tree were hauled down and put in police cars. A youth of 15 was frisked and when he ran across Neil-

son Way, the police grabbed him and dragged him to a police car where four big cops twisted his arms and legs, tying him up and throwing him on top of a prisoner in the police car.

Tom Sewell, president of The Venice Historical Society, managed to remain in the tree. The fire department then arrived with a hydraulic ladder to remove him. Sewell was arrested. The workmen who cut the tree down were booed

1 clove garlic







Charlie Haden - Liberation Music Orchestra, Impulse AS 9183 Rahsaan Roland Kirk - Natural Black Inventions, Root Strata Atlantic SD 1578

These are two exciting and intense jazz albums, very different yet both related to the political and cultural revolution. Charlie Haden is one of the finest young jazz bass players. He is playing currently in the Ornette Coleman group.

Haden brought the Liberation Orchestra together after hearing the Spanish folk songs embodied in the revolutionary songs of the Spanish Civil War. His players are all New York jazz musicians of high repute, Gato Barbieri, Mike Mantler, Don Cherry, Carla Bley and Dewey Redman.

The first side of the record uses the two most exciting songs of the film, "To Die In Madrid" and the arrangement of same by planist Bley. The orchestra does free playing and improvisation that comes to oftimes a melancholy yet stirring musical combination which the Spanish songs lend themselves to. One can almost feel the struggle of the Spanish Loyalists against the Fascists.

The second side of the record is Haden's beautiful song for Che and Ornette Coleman's "War Orphans" with Haden playing a lyrical bass solo. The orchestra does its unusual improvisation here again, tuning in Carlos Puebla, Cuban folksinger, singing "Hasta Siempre".

From a different cultural and historical period is the Root Strata album with Rahsaan Roland Kirk, one of the finest jazz musicians around. He talks about the music of the black people and how it was stolen and turned around to become the Glenn Millers instead of the Coleman Hawkins and countless other black musical geniuses never recognized.

His sounds are beautiful and truly reflect his black experience. His tribute to Coltrane to Ellington and LaTouche brings alive the moving music of the black ghetto. It's "Daydream", "The Ragman", and "The Junkman Ran from the Businessman" etc.

Both records are a must for anyone into jazz. The music and musicianship are tops. And the minds where it was put together were for creativity toward building a better world.

Welfare Reform

Recent court decisions have knocked holes in the welfare "reforms". Many poor people were dropped from Welfare because the "reforms" required stepfathers to support children of others, and because many working parents with low incomes had their welfare terminated. The courts decided the "reforms" were in violation of Federal Law. Other parts of the Law are under attack in the courts.

Welfare clients who have been declared ineligible in the Welfare offices might be wise to appeal or reapply for Welfare, It would help considerably if there were a strong Welfare Rights Group in Venice to help do this in an organized way.

There is a disease going around these days that seems to be affecting people seriously. This rapidly spreading plague has reached epidemic proportions. Its prime victim is the health enthusiast, that certain type who heralds his body as the quintessence of health while proclaiming to all what the right way to live is. As one can readily see, attitudes, interest and awareness of better nutrition is on the increase, all to the good. All sorts of false claims of this or that product in ads do influence some people. 





Prison News


