The following is a speech by Alan Ross of the North Beach Residents and Property Owners, before the Venice Town Council.

Honorable Councilwoman, Ladies and Gentlemen,

I am sure that here tonight you have many important items to discuss. But I would like at this time to draw your attention to a grave problem that besets us all—the loss of our homes...

Our community, unique in its character— Is in iminent peril of being wiped out. Wiped out by an anonymous band of financial manipulators, who see as a speculative bonanza this fast coastal strip of land that time has seemingly forgot.

On our left we have our 36 million dollar yachtsmen's paradise— Marina Del Rey and the ensuing peninsula— just dying to spill over across Washington Street; and on our right we have the rising megalithic monster of Santa Monica shores— towering over us like the sword of Damoclese.

Now the question is, what do we do with the headache in between

Let's see, we have about 1800 homeowners, many of whom are absentee landlords. There are about 2000 renters, the resident hippies and old Jewish people who play gin rummy with rheumatic fingers on park benches . . . Well sir, we tried to rezone these dregs of humanity out of their homes but that didn't work- so let's say we try and tax them out. I mean the law says very plainly in article 13, section one of the State Constitution that the tax assessor can come along every year and do a spot check on neighborhood sales and up the tax ante accordingly. The rest is easy, A sells to B. B sells to C. And C sells to D. and the price increases with each paper, for that is all most of these sale are- ficticious transactions. And the funny thing isthey all work for the same faceless family. And Tax Assessor Watson has all the proof he needs, if and when you make your appeal. "See, the property on the next block was sold for five thousand bucks more than you paid for it.

FIFTH ANNUAL VENICE CANAL FESTIVAL

As you came to the Canal Festival by way of Dell Avenue, there were reminders of the very political issues that engendered such a community get together. Five years ago the Canal Festival was the Venice Canal's farewell to the world: the passing of the Canal Assessment District was imminent and the removal of the poor and near-poor (i.e. the people who worked at skilled/seasonal or semi-skilled jobs; one-parent families; semi-retired, struggling artists and musicians who worked at other jobs to keep themselves and their families affoat and who were constantly a week away from financial disaster) to make way for the affluent and upwardly striving swinging, bell-bottomed, Guicci-shod, Credit Card Set. This was to be that community-within-a-community's swan song, or, if you will, Duck Song. It was to say to people at large, "This is, folks-take your last, long look at us; sample our wares; meet our friends; say fond farewells; listen to our music; dance with us; be with us for the last time; remember us lovingly. It won't be the same again ... ever."

Well here we were five years later: the Children's Park site at Howland and Dell, the boardwalk gone But, crowds of people jamming and cramming into the Canals- feathers, bells, cameos, cotton candy sweet smells mingling with incense and the insistent, sour smell of mustard. Pushed on by the crown, one remembers a bare six months after the City's face got red for tearing down the park, and for jailing six people who symbolized the cry of a whole community. . . "We shall not be moved."- and passing or being carried along by the wave of a human sea- past the new playground built by people in the Community with the cooperation of the City, complete with a house on stilts. Finally, one gets to a bridge. You lean on it, looking at the people in rubber rafts, skows, Tom Sawyer-ish concoctions, etc. The sun that was not shining and reflecting on

the waters yesterday is out today sunburning visitors, buyers and sellers alike. You look down the people-filled sidewalks, alleys and bridges— Festival time! The Venice Saturnalial— Police cars directing a few bewildered cars; motorcycles harumphing, huffing and burbling with impatience as they tried to push through the people-filled bridges.

Despite the efforts of some Scroogy property owners, the Fifth Annual Canal Festival was there with the statement, "Yes, we're still here!" Candles, Indian bread- hot, fatty and sweetleather goods, baroque music (MY soul music!), dancing, models of geodisic dome homes, leaflets, pamphlets, erotic prints, cotton candy, fresh cornall collaged together. A chorus of singers nearly drowning on the barge, Hare Krishna people giving away marvelous food- actually coming up and offering it to people. Residents cooling down the more rowdy and intoxicated elements of the community, who, after all, are residents too- and mostly just having a hell of a time, a real community shindig.

And then, as you look Southward, you see the Allen Radford Building to-wering, glowering, lurching towards, and hunkering over the Canals: an anti-human complex to gobble them up.

Yes, the City-planned Monster has been downed, but the hydra-headed monster is back again. Seven new alternative plans that incorporate all the evils of the old Monster Master Plan, i.e., no allowances for the present residents; filling in the canals; or destroying the "unsafe" bridges and widening the Canals for the future, affluent yacht owners. I can't go on- it makes me sick. But the community who first put on the Festival is still there, fighting Code enforcement, high rents; and they're still putting on great festivals in spite of the City's preoccupation with cement over all, motor boats and yachts instead of rowboats. And in spite of the City's worries about the fraility of the present old bridges of Venice-yes, folks, the City wants to tear them down because they're

TAX ASSESSMENT APPEALED

After fifty years of protests, the community of Venice has now brought the battle for survival to a new and exciting high. Instead of battling for and against more city services, i.e., Pacific Coast Freeway, the Canal Project, street widening, poverty funds, bike paths, police, parks, etc., 26 homeowners protested the 1973 property tax increase on the grounds that it violated, among other things, their constitutionally-gauranteed right to "life, liberty, and the pursuit of happiness." Can you see it: Pursuit of Happiness v. Los Angeles County!!! . . . and just in time!!!

On September 15, 1973, a typically-Venice group of protesters (two senior citizens, eleven children, and fourteen other home owners representing a variety of socio-economic and cultural values) made the long trek to downtown LA to file a joint appeal of their taxes. Homeowners from North Beach, the Peninsula, Central Venice, and the Canals are involved in this community-wide protest of property tax increases, including four members of the Venice Town Council. Attorney for the group Andrew Von Sonn said, "Homeowners based the appeal of their 1973 tax assessments on a variety of constitutional and environmental issues."

Among the list of 22 issues were:

1) Because a tax increase will result in

the elderly and the poor being evicted vrom Venice, the Tax Assessor is required under the 1970 Environmental Quality Act (Friends of Mammouth v. Mono County) to file an Environmental Impact Report

The LA County Tax Assessor is subverting the intent of Proposition 20

 Tax assessments based on sale force resident property owners to pay taxes on unrealized profits.

Homeowners argue that real estate speculation in Venice, caused in large part by the 24.5 million dollar Venice Canal Waterways Project (city supported) and the over-zoning of the North Beach area has now been stopped by: a) an inprecedented 125-acre zoning rollback of the North Beach area, b) the legal defeat of the Venice Waterways Project, and c) Proposition 20.

The group asked for a moratorium on any Venice tax reassessments until the effects of these changes have been studied.

A spokesperson for the group said that if the Tax Assessor doesn't establish a moratorium their attorney will appeal their cause to the California State Supreme Court. Interestingly, Nader's Raiders asked if they could be involved

gentlemen, that Mister Watson forgot to do his homework. Because the zaning rollback and the effects of Proposition 20, the coastal initiative—while emminently in the best interests of the people—have served conversely to devalue our property—not to increase its value.

The tax assessor needs also to examine the fine work done by councilwoman Pat Russell, Mayor Bradley—the city planning commission and the rollback examiner who have all acted publicly to preserve the unique character or community of Venice

This year homeowners have opened their mail and found a tax bill different from last year's- single family dwelling: not an increase of 20 or 30 dollars, but between \$600 and \$1000. Now isn't this a simple way of driving the poor undesirables from their homes. For everybody says-"You can't fight city hall." What then happens, in most cases the lead is passed to the renters who have had rent increases of up to 100% The tax assessor is directly contriening H.U.D.'s order that the city preserve and develop low cost housing. His deputies incorrectly reassessed on highly speculative transactions prior to the passing of Proposition 20 and the zoning rollback. In fact, they acted prematurely- because, who now would want to buy 70-year-old homes that cannot be torn down and high rise apartment houses put in their place.

He needs also to look to Palos Verdes and Orange County where taxes have been reduced because of Proposition 20. Why then have the people of Venice been unfairly victimized? In fact, why does the electorate of this great state bow to the immorality of legal blackmail? Taxes are needed, we know, but a sales tax is fairer than a living tax. The law must be changed—people on fixed incomes must not be victimized for living in

the home they love— Let them pay taxes on accrued profits if they sell. Don't tax them for breathing and growing old.

A referendum must be instigated.
Signatures must be collected to erase forever this immoral law that favors only the rich.

Friends, I can tell you that living here is quite an experience. Since the depression this community has had to fight for something or other—but injustice is the breeding ground of fighters, and perhaps that makes our cherished possessions all the more

worthwhile.
This community attracts a special breed of person. They choose this as their homes because ticky-tacky boxes do not appeal to their way of life.

Would you take a 20-story monstrosity and plant it in the sleepy Scandinavian villiage of Solvang? Is it by apathy or subversive design that will allow those with monopolistic motives to steal away our unique environment?

We are doing our part. Wheels are turning. The A.C.L.U. is helping— legal action is being undertaken— are you doing your part? Write to Senator Robert Stevens, to Governor Reagan and to Mayor Bradley. Those of you

who haven't yet appealed your assess-

ment I suggest you do it together.

I would like to make one final point, and you may gather from this what you will. No commercial beachfront property in our area was re-assessed.

Only the homes.

In closing let me relate a short story. While collecting petitions the other day, one dear old lady rolled back her sleeve and showed me a number tattooed on her forearm. "See this," she said, "I know what it is to be displaced, I was in Auschvitz. Where do I sign?" Ladies and gentlemen, that was Nazi Germany in 1940. Today we are in America, 1973.

The City of Los Angeles is in the process of planning a freeway through Venice that would be an extention of the Richard M. Nixon Freeway, Route 40. Dear Friends:

The Venice Civic Union for at least 28 years has exerted its best efforts to represent the needs of the property owners and residents of this community. It is expedient to our mutual interests for the majority of us to get together to prevent a dissident, non-representative minority from forcing undesirable conditions upon us due to our apathetic attitudes.

The most urgent of our present problems is that of zoning. There is a group, consisting primarily of tenants, that wishes to keep this highly desirable, beautiful beachfront area in a slum housing condition so that Welfare and ATD recipients can enjoy cheap housing. This would prevent multiple housing for working people who want to live near the Ocean in clean, modern, residential conditions. This type of zoning will endanger and devalue property considerably. As long as Venice remains as it is now lending institutions will refuse to finance construction because of downgrade zoning and the City will continue to refuse to help with street improvement and pro-

vision of the off-street parking required for new housing. The existing, inferior housing which attracts undesirable tenants and neighbors who foster dope and crime give Venice such an unsavory reputation that many prospective tenants are apprehensive of renting in our area. Downgrading of the zoning will permit [prevent?] people to live in this finest beachfront area of Los Angeles. Under present law, "high-rise" buildings, the term used by ignorant scare advocates, are an impossibility. New buildings are now limited under Los Angeles Building Dept. restrictions to three stories and this will not change with the proposed zoning; however, the proposed zones prevent residences and provide for business only, with no multiple housing or restricted parking in the area.

Other important considerations facing us are: off-street parking, "tow-away" parking signs for Fire and Police Dept. accessibility, avenue access for cleaning and rubbish pickup, enforcing of dog laws, Police protection, monthly fees in City parking lots, no on-street parking on Pacific Avenue south, the Canal Project, and many others.

This July absentee landlord Kurt Simon shared his brand of thinking with fellow speculators in the form of a letter from his "Venice Ocean Front Improvement Association". Referring to the zoning rollback in North Beach, which would tend to preserve the existing residences, he asked, "Who is behind this absurd scheme to use Government force to impose the new lifestyle on our old established community?" His answer: "There is a small, welldisciplined group of political activists determined to both make the area into a low-rent slum and to cause dissent by dividing us into feuding factions."

Among his specific suggestions was: "Join civic groups such as the Civic Union, the Chamber of Commerce, the Women's Chamber, etc." Now comes the aforementioned Venice Civic Union with its own proclamation, written by Raymond W. 

serving their best interests as present homeowners. They have been supported by other Venice groups that include tenants, but it's safe to say that without the resident property owners the zoning rollback would not have taken place.

The real conflict, Mr. Robinson, is not between property owners, and tenants; it is between property owners, resident and absentee, whose only concern is makin benefits and vexed by many of the same maximum profit from their property and all other residents, tenants and owners alike. And in this conflict the minority is not we who are fighting the speculators in order to remain in Venice. The minority is precisely Kurt Simon, Raymond Robinson and the other economic fascists who would rid Venice of the Welfare recipients and the Social Security recipients and the disabled, and, we must conclude, also the North Beach resident property owners.

It is a curious thing that landlord Robinson tries to blame the alleged "slum housing condition" on tenants. If there is a slurn (and if so, it must be the most expensive slum in the whole history of slums), then who made it so? The landlords, of course; they own it. Tenants live where they can. It's the owners who determine the condition of the housing. So, folks, the people who made Venice a slum (if it is) are our old friends Simon and Robinson and the Civic Union, etc. The "existing, inferior housing" is their property, not the tenants'.

And who is giving Venice "such an unsavory reputation"? I remember when Lawrence Lipton's book "The Holy Barbarians" described Venice as "a slum by the sea." Members of the Civic Union were outraged by Lipton's description. Now the Civic Union itself says Venice is a slum. If they think so, maybe they are the ones who ought to get out.

Venice is a community. It is not just a place with parcels of property laid out like a monopoly game. A community is what it is because of the people who live in it and relate to each other. Buildings, beach and weather do not make Venice a community; the people do. All the people, including tenants and property owners, workers and welfare recipients, young and old, affluent and indigent, conservative and radical.

There is a very real danger to our



community: the danger that high rents and proeprty taxes will force a substan tial number of present residents, both renters and property owners owners, out of Venice. If that happens, we all lose, all escept that small but well-disciplined group of profiteers represented by Kurt Simon and the Venice Civic Union.

Part of the charm of Venice is that so far all different kinds of people have been able to live side by side in the same community enjoying many of the same problems. Without the low-income people, who must have low cost housing to remain her, Venice would not be the community which we presently know and love.

GRAPES OF WRATH AGAIN PLEASE DON'T EAT LETTUCE OR GRAPES

In 1962, Cesar Chavez began organizing farm workers in the Delano area of California's Central Valley In September of 1965, the Delano grape stike began. From 1965-1970, farm workers struggled and sacrificed to win contracts

in the grape industry.

In 1973, as those first UFW grape contracts came up for renewal, the growers and the Teamsters plotted to destroy the farm workers union. Instead of negotiating in good faith with the UFW, the grape growers signed back-door contracts with the Teamsters Union. The Teamsters made the deal pleasant for the growers by giving up the union hiring hall (thus, bringing back the labor contractor system), by weakening pesticide protections for workers and consumers and by eliminating all on-the-job contract enforcement by elected farm worker committees. Asked if farm workers would be able to participate in the Teamsters Union, Einar Mohn, Director of the Western Conference of Teamsters said: "We have to have them in the Union for a while. It will be a couple of years before they can start having membership meetings, before we can use the farm workers' ideas in the union." (L.A. Times, 4/28/73)

In response to the Teamster-grower collusion, Cesar Chavez demanded secret ballot elections but the growers refused. Farm Workers went on strike in Coachella, Arvin, Lamont, Delano, Fresno, Livingston, etc. 4,000 grape workers went to jail for peacefully picketing. Two strikers have been killed for standing up for their rights. Hundreds of workers are going out on on the boycott, again, to tell their story to the American people.

"Most of our people are people who do not have skills-they're from the streets-they're the bottom."

"Dope fiends expect immediate gratification, we change our attitudes when we change our Attitude. Then we find we can do anything."

At the Open House Weekend September 15-16 that celebrated three years of proudly tell her parents about her first job "in an office on Wilshire Boulevard." There are employment agencies and businesses that have written to Tuum Est

saying, "If you have any more people please send them to us, as we are happy drugs. They take one day at a time, each to employ them." Adjectives like "honest" and "reliable" are in abundance. "That's the first thing we learn," said one of the long-time residents, "honesty in

> There are three stages that one goe. through at Tuum Est. In the first stage, one keeps to the house. You are not allowed on the streets. In the second stage, one is allowed to go out accompanied by another resident. This gives people the opportunity to say no to temptations and gives the longer-term resident a sense of responsibility when accompanying a newer resident. The third stage: residents get a job outside the house and save their money for a car and/or an apartment. After handlings the job and the world, they can leave, but they always can come back to the house for reinforcement. If someone splits and wants to come back to live, he has to wait 90 days.

They picked Venice for the drug rehabilitation program because "this is where it's at." "We live next door to the

connection. Every day we make the decision not to use. We make it that day and we do it by ourselves, we're adults."


For the same reason, Tuum Est feels that people must learn how to deal with their environment. People must also learn how to deal with other people. That's why the facility is co-ed. Each complex (except for the complex at 108 Vista, which is used as the main hall for meals, groups, seminars and the office) houses approximately eight to twelve people. The men usually have the living room (about three beds), which is called the "freeway."

One fourth of their money comes the federal government. The rest is donated by private parties. If you have good, usable furniture and office equipment that you don't need, Tuum Est does. It must be in good condition. They'll accept Blue Chip Stamps and those 10-25 cent promotional coupons and, of course, money.

If you feel you'd like to get straight with a drug problem, call 392-0773. If you want to donate money or whatever, call the same number.

MURALS VENICE





DEDICATED

The dedication of the Venice Murals started out with everyone obediently standing up while the National Anthem was played. A few people raised timid voices in song. "They forgot the last two words of the National Anthem," said Dr. Zane of the Free Venice Beachhead. "What are they?" I inquired. "Play ball!" cackled Dr. Zane. For once, Dr. Zane was in good taste and completely relevant. Because the dedication of the Venice Murals showed what could happen if the City of Los Angeles played ball with their Colony of Venice.

Under the direction of Judith Grupp, artists of Venice scrubbed off the graffitti on the walls of the picnic area in the Pavillion, prepared it for painting and created a work of art where once Bureaucracy had built stark, gray cement walls for a picnic area. As you walk into the picnic area from the Ocean Front Walk side, the history of Venice leaps and whirls from the walls.

Councilman Pat Russell said at the dedication ceremony, "Usually these dedication ceremonies sumbolize the City giving something to the community. I feel in this instance that the community is giving somehting to the City." Yes, Ms. Russell, the same people who are being forced out of Venice by Code enforcements, taxes, and rents are making Venice a nicer place to live for the more affluent.

Vince Coppolla of the North Beach Area Town Council accepted the murals on behald of the community. "This is

a joyous occassion," he said, "and these murlas represent a joyous occasion--and that's what Venice is all about- a joyous occasion."

Judith Grupp introduced the artists and and explained the group effort. The murals tell the story of Venice from the times when nothing but ducks and reeds inhabited the swamp of Venice to the times of Indians, Spaniards and railroads, including the first developers of Venice, Abbot Kinney, and his dream of Venice, of America then unfolding. We were shown the 1900's, the crowds, the amusement pier. Then, the War years, symbolized by a magnificent parody of a W.P.A. painting style showing the wings of airplanes as the Rising Sun of Japan hovered over the Pacific. A leaf out of a 1950 year book showing the girls in poodle haircuts and white blouses, the boys in duck tails and basketball jackets. The "Beats" discussing swing and blowing cool sounds. The old Jews on the benches, with the whole history of their people behind them, the pogroms and the social issues. And the present, as these old peop le sit in the sun and the old, red Synagogue sits in the sun with a For Sale sign on it. Much, much more-each one has something to say-all of it shows the love that people have for Venice. One criticism I won't hold back: one of the artists had just sketched in a scene and left it that way. From what I understood, the artist felt that that was the statement and felt nuthing else was needed. I do disagree. I feel (and this is my opinion only) that the section in question looks unfinished, and I fed cheated,

There is a section that children painted and it is delightful. Canal monsters and sea monsters abound along with water, sand, and boats with sails bellied out before the wind.

The Baroque Jazz Ensemble played beautiful, baroque music, Be Bop jazz and Villa Lobos--AND, a piece called "Blues for Venice."

The murals are powerful and wonderful. Unfortunately, some creepish nurds have tried to deface the murals. They seem to be the sort of people who turn into land developers and earth rapers.

"The Venice Off-Ramp," an improvisational theater group, amused the audience.



In Tom's second type of somg, he either satirizes or speaks directly out at various flaws he sees in society as a whole. In one song ("The Monkey That Became President"), Tom tells the story of a chimpanzee who learns to talk and eventually goes on to be President of the United States. The moral of the story is told in the last two lines of the song: "Would you rather have a monkey in Washington DC/ Or have those people making monkies out of folks like you and me."

If you really want to get back to your roots, but in an meaningful manner, buy one of these albums, or turn your radio onto KFOX and listen to Tom T. Hall.





Last month I was in Chile. I was tremendously excited by what was happening there. Allende's popular government was giving the working people and peasants an idea of what it is like to be important. People were open and anxious to talk about how they felt about the Popular Unity Government and what it had done for them.

Allende's election was a surprise to everyone. It was difficult to believe that many leftist groups who disagreed on many points could put together a coalition and win. In the first election the Popular Unity Party received 36% of the vote. During the last three years the PG (for Popular Unity Government), despite incredible economic difficulties had improved the quality of life for Chileans enough to get 44% of the vote in March, 1973.

Among the changes people emphasized were: they now work an eight hour day when before Allende they never knew for how long they would work; they get paid better; there are centers in the neighborhoods where they can leave their children while working; anyone can go to school in the evenings and on Saturdays; and price ceilings were put on food and rent to protect the poor. People pointed to the new houses with plumbing which were in construction beside the cardboard and tin slums; to neighborhood centers with health services such as prenatal, maternity care and education, including distribution of milk to children who before couldn't afford to have any; and to the park in Santiago that now has a free children's movie, a place to dance and a dozen good, cheap restaurants to take the family on Sundays.

Clearly Allende's government cared about the people and was doing things for them. Slowly however, because the US was doing what it could to eliminate Allende and the PG by: dumping its copper reserves to lower the world market price especially since copper is Chile's most important export; withholding aid and loans; and refusing to sell vital machine parts. Chile, in this period, suffered continuous economic crises, inflation, shortages of nearly everything and strikes. Strikes and shutdowns

were organized by the opposition and through these measures they intended to aggrevate the economic chaos until the Allende government was forced to resign in failure. But with every month more people were being organized behind the Popular Government, Allende's supporters felt that by the next election he would win a clear majority in the legislature. From this came a sense of dread. How long could the right, the military, the imperialist power powers "allow" a popularly elected Marxist government to successfully continue? The longer Allende's government continued, 'vealed, ITT, who has been reaping large the harder it would be to destroy. Many felt that "tomorrow could be the day the civil war begins," the day the Right would move to eliminate the Popular Unity Government.

Every weekend there would be mass demonstrations with the message, "We want to live! We don't want a civil war!", a children's demonstration for peace or an anti-fascist film festival. One day a government publication appeared on every newsstand about Fascism in the world, linking it to oppression of the poor and repression of the Left in Latin America.

The fear of a military coup was immediate because there had been an abortive attempt by the military on June 29 of this 'year to take over the Presidential Palace. The impact of June 29, 1973 on the people was enormous. Everyone told me where they were that day and what they were doing when they heard the shots and what they thought. It must be remembered that Chile has an ideal of the democratic process similar to ours. The idea of a military coup is as repugnant to Chileans as it is to Americans.

I met, stayed with, and talked to a number of thoughtful people who were opposed to Allende's government. Their main criticism was that the reforms and nationalization of the copper industry were unconstitutional. Along with their intense opposition, most felt Allende should be removed in the next election, which they were confidant would happen. They were doing what they could toward that goal by supporting the crippling transport strike, by organiz-

ing farmers to destroy their crops (I saw dairy farmers pour their milk on the ground); by closing their stores; and by forming vigilante groups to see that their neighbors did so. The plot was to bring everything to a halt so Allende's government

would lose support.

So why the hurry to get rid of Allende? Perhaps the opposition plan would have failed or perhaps succeeded. I'm sorry we'll never know now. I asked several people if Allende's support was strong, armed and confident enough to fight back if a coup took place. All said yes.

It is hard to know what will follow the military coup, however it should be our responsibility and concern that the American government and corporate intervention in this tragedy end. Chileans, both pro and con Allende, were convinced US intervention was occurring.

As the Senate Watergate Hearings reprofits from copper mining and other industries, was directly involved in trying to prevent Allende's election to the tune of one million dollars to Allende's opposition. On December 4, 1972 before the General Assembly of the UN, Allende spoke of the further plans that the US imperialists had in order to disrupt and overthrow the democratically elected Popular Unity Government after its earlier attempts to prevent Allende's party's election had failed:

"In July the world was shocked to learn the details of a new plan of action which ITT itself presented to the US Government, a plan aimed at overthrowing my government within a period of six months. I have in my briefcase the document, dated October, 1971, which contains the 18 points of that plan. Its objectives included strangling the economy, diplomatic sabotage, sowing panic among the population, and fomenting social disorder so that the government would, it was hoped, lose control of the situation and the armed forces would be impelled to break the democratic system and impose a dictatorship."

By now, intervention on the part of US Administrations and corporations in the internal affairs of other countries comes as no surprise. The ITT memos, the Pentagon Papers and various Senate investigations have demonstrated the extent of White House participation in foreign covert operations. US corporations such as ITT, Anaconda and Kennecott were forced, much to their corporate dismay, by the Allende government to share

their profits with Chileans. When economic and political covert intervention failed to unseat the PG government, direct military intervention became necessary.

Is it just coincidence that at the time the the military coup took place, US Naval vessels were off the coast of Chile and US Naval destroyers "Richard E. Turner," "Taterall," and "Vesol" and the submarine "Clamorage" were all in Chilean waters? Why was it, as Reuters' dispatches revealed in the LA Times, that word was sent to the Nixon Administration on September 8 to expect a military coup on September 10? In summation, the coup happened during the time the Chilean military knew that US naval vessels would be near Chile, and the US government, informed in advance about a planned coup against a democratically elected government, participated, at the very minimum, by its silence.

When the US government participated in the coup that assassinated Patrice Lum umba and overthrew the elected Congolese government, and carried out the bloody war in Vietnam, it was claimed such intervention was necessary to "protect the people from Communism and to enable them to democratically decide their own affairs." Is that why the US Government and corporations participated in the military coup in Chile which overthrew a freely elected, democratic government and murdered its president? Or is it that US imperilaism will not allow people of other countries to determine their own destiny-to assert control over their own resources and to build toward socialism when they believe it is best for them?

All of us who respect the national sovereignty of other countries and are opposed to US intervention in these countries' affairs and believe such intervention violates the democratic principles under which US imperialism attempts to camouflage its true purpose must join in the struggle to restore the democratically elected government of Chile. We must demand that Congress and the President refuse to recognize the military junta; we must demand that there be an investigation of the role the Administration and corporations played in the military coup; we must organize support for the political prisoners (in the thousands) arrested by the junta and we must in every way possible support the right of the Chilean people to return the Popular Unity Government.
