The Venice Town Council passed a resolution condemning the festival funeral, but on a gray, hung over, muggy Sunday, over 300 Venetians followed the Canal Festival Funeral procession as it wound and struggled up the narrow bridges and crumbling sidewalks of the canals. The black-clad crowd stood quietly and patiently as the funeral wreaths were laid on each of the 21 lots that are up before the South Coast Regional Coastal Commission for building permits on October 4. They stood on the dusty lots ad people talked about the little houses that had been there, and the residents that had lived in them, moved out by high rents, high taxes and terrorist activities per-

YES ON 14 Continued on page 4) RMWORKER INITIATIVE INSURES FAIR ELECTIONS

The United Farmworkers Union has launched its campaign to win passage of Proposition 14, The Farmworker Initiative, in the November 2 election. The initiative is designed to insure the right and the opportunity for farmworkers to have secret ballot elections.

Since 1935 when most workers were given unionization rights under the National Labor Relations Act, farmworkers have been excluded from the rights and privileges now taken for granted by many other workers. Last September the Agricultural Labor Relations Act (ALRA) was passed by the California legislature, giving farmworkers the right for the first time to vote for the union of their choice.

By February of this year over 350 farmworker elections had been held in the fields under the new law. The UFW won 205 of these and the Teamsters won 102. But the election process ground to a halt in Fegruary when the Agricultural Labor Relations board (ALRB), which oversees the elections, ran out of money. The elections have been stalled ever since, because grower-backed legislators have refused to vote more funds in the hopes of forcing through amendments to the ALRA which would be favorable to the growers.

Early this spring, the UFW called a boycott against Sun Maid Raisins and Sun-



sweet Prunes, whose owners were leaders of the grower coalition blocking passage of the ALRB funding bill. In April the UFW leadership decided to put the farmworker election issue before voters in the form of an initiative. In this way the UFW hoped to mobilize public support, which has been the farmworkers best ally in their long struggle.

Since the farmworker initiative campaign began, the pro-grower legislators have changed positions, and have recently voted to fund the ALRA. They want to prevent passage of the Initiative, because if it passes, the ALRA will be stronger and harder to change in the future. Though the immediate funding problem is gone, the UFW is going ahead with the

Initiative. Porposition 14 is the best way to guarantee that the same blockage in funds doesn't occur again.

If the Farmworker Initiative passes on November 2, it would become a part of the State Labor Code. Presently, the law can be changed by a majority vote of the legislature. As a part of the labor code, it could only be changed by a two-thirds majority of the legislature or by another initiative. Also, it would be written into law that the legislature must provide the necessary funds for carrying out farmworker elections.

Another important provision of Proposition 14 is the guarantee of limited access to grower property in labor camps, or are transient and don't have permanent addresses, it is essential that organizers be allowed to speak to workers on grower

property. The Initiative would allow organizers in the fields for an hour before and after work and at lunch breaks.

Proposition 14 would also require growers to give a union a list of their employees if the union was following the proper procedure to seek an election. In addition, the ALRB would be given the right to impose triple damages against a grower or a union which commits an un-(Continued on page 3)



An Open Letter to the UCLA Community

Clinical Psychologist

Faber, Carl Faber. I understand he's being given the boot. I'm not surprised.

People like Faber are incongruent with the modern concept of a university. What is a university supposed to be? A delving into all manner of esoteric subjects of questionable value to contemporary life? An escape, a retreat from the adult responsibility of finding better solutions to our urgent problems?

Schools are where this nation's values are transmitted to the next generation. If our society strives for security and comfort, if it depends on the uninterrupted production of a great variety of things, if it requires law and order so that the economy can operate at peak efficiency, if it is curious about how other people have lived -- then these values will quite understandably permeate our universities.

What happens when a person like Faber comes along and tries to teach about things which have little relevance to our society's basic cultural values? -- Subjects which are not only rather irrelevant to those values, but which serve to distract students from their primary goal of learning vocational skills and professional roles.

For Faber goes on and on about topics such as the nature of a person's identity ... 'What gives a life its meaning?! How does someone know who he really is?" And so forth.

really are answers. So what good does it do to pursue subjects like these when busy students; are trying to learn their place in our socio-economic system?

In fact such topics implicitly seem to question the system itself and its underlying values ... ! What are our lives really like?' Are we at peace with ourselves, and with others living on the earth?' 'Are we giving up our connection with the sky and the sun, with trees and the speech of animals? ' 'Are most of us unaware of the enormous spaces inside ourselves, unaware of our breathing?

Here is a sample of the voice of Carl Faber: "Listering, when it's at its deepest, is ... a revolutionary act. If you are really with somebody... and they're allowed to break out ... and make a moment... and all of what that means to people... you fan the fire of human spirit. But if you're not there ... if you're detached, and living on yesterday's answers ... you kill the human spirit, often without even intending to. Often intending the opposite. By imposing on it, and holding it down. And those moments will never happen. . . "

Faber's subjects are beyond words. People like him are totally out of place in our nation's universities. And that, ladies and gentleman, boys and girls, is why we are dying.



CACTUS RUSTLERS

The Southwest is being in vaded by a new kind of bandit-the cactus rustler.

Officials in Arizona say that hundreds of rustlers have been digging up the increasingly rare Saguaro cacti with arms like candelabras that grow up to 50 feet in height. The reason for the sudden interest in the cacti is that the rare plants can be re-sold on the underground market for as much as \$40 a foot.

The cacti, protected under Arizona law, grow at the slow rate of about one inch per year when young. A 50-foot specimen is usually 150 to 200 years old. State officials, attempting to stop the problem, say that "cactus theft. as profitable as cattle rustling used to be..". ZNS

It's here but do we need it -- another business, a depot for exploiting the Good Earth, the land we share, some of us?

Cactus is uprooted from the desert soil of our Southwest, the U.S. and Mexico. They dry and die in Venice. They will be shipped to dept. stores like pottery, dead or alive.

What happens to people these days may be less obvious and more indirect. But cacti are plants and they don't talk, right? They're just sort-of around to be used like furniture, unless they make a fuss of it and speak an acceptable language. It's happening to Venice too, being picked at and sold for the top buck. This kind of consciousness is killing us.

Ciant five to six hundred year-old Saguaro cactus are living candelabras reaching up to fifty feet into the air, monuments of texture and slow sure grace. Their skeletons, ribbed and without green skin, are robbed from their graves, their beds of homeland, and piled by the street. What's left of them will be packed in cardboard and shipped to museums and private collectors for money. Who's paying anyway?

Do these merchants, the modern slave runners, even consider the lives dumped into their rented trucks and all the other living things which depend on these plants for food, shelter or reproduction? In death, as in life, plants change naturally and return to the soil as humus, minerals and nutrients to feed families of beings who as themselves like to be where they are.

These people at 660 S. Venice Blvd. leech the fine-tuned organics-booty not to be returned to the homeland without a fight. They cut into the body. And this may be perfectly legal and done with permits. The balance tips precariously low.

I'm afraid this is a common ongoing metaphor.

GROWING PAINS W cultivation vs. the law

With the beach air, the Southern California sun and the high price of marijuana these days, many people are using their green thumbs to grow their own. As a matter of fact it doesn't take an Eagle Scout to spy pots all over L.A. sprouting gram and beautiful but illegal plants so you can reacily expect that the man does make busts now and then.

Section 11358 of California Health and Safety Code provides that "Any person who plants, cultivates, harvests, dries or processes marijuana shall be punished by imprisonment in state prison from 1 to ten years."

Actually though the avove sounds oner- if a cop looks over a fence or through our, in most cases where just a few plants a window from a walkway or other public are involved it is not usually a big prob- place the bust is probably going to be lem but it is a hastle to be sure.

If cultivated weed is found growing and you can be shown to own or rent or otherwise have control over the property this is usually enough to convict by circumstantial evidence. In most cases of first offenders if there are oney a few smaller plants involved, plea bargaining results in a reduction to a straight misdemeanor possession, a small fine and non-reporting probation for a year or two. However, if ther are large plants it can get sticky.



Observation of plants by police from any place where there is not a reasonable expectation of privacy is legal. This means if a cop looks over a fence or through a window from a walkway or other public place the bust is probably going to be a good one.

The National Organization for Reference of Marijuana Laws (N.O.R.M.L.) is was a campaign to put cultivation in the same class as possession of an ounce less of marijuana. That is where one grows an amount for personal use (up a good one.

A conviction for cultivation is a felony for life and usually also will result in formal reporting probation for three years and a fine. Time in custody for first offenders can most often be avoided however, there is no guarantee that some weird judge won't dish out a few days as well.

First offenders can be diverted. See the last issue of the Beachhead (Sept.) for a detailed analysis of the diversion program - however it means generally that the case will be continued for six months while a few drug abuse sessions are completed. Upon completion of these sessions and after the six month period has passed, the matter is dismissed.

Though diversion is some saving grace it is far from trouble free. In the first place a bust for cultivation requires high bail, usually \$2,500 and that's expensive and even though the diversion program is generally good it requires a probation officer's approval, a report to the court and a number of court appearances.

The National Organization for Reform of Marijuana Laws (N.O.R.M.L.) is waging a campaign to put cultivation in the same class as possession of an ounce or less of marijuana. That is where one grows an amount for personal use (up to 6 plants) she/he shall be given a citation and punishable by only up to a miximum \$100 fine. Assemblyman Willie Brown (D-SF) is committed to present a cultivation bill to the 1977 legislature and to cement his commitment you can send a post card or letter to him congratulation him and assuring him that you shall help persuade your local Assemblyman and Senator to support this bill. residents. No permits were applied for by the coordinators of the funeral. That's why no permits were given, Mr. Nieson Himmel, reporter for the L.A. Times.

A casket representing the Festival was carried by six "honorary" pall bearers. These represented the interests that killed the festival. The Tax assesor, absentee landords, Alex Mlikotin of Solar Systems (his company owns 18 of the 21 lots up for redevelopment.) City Hall personified by Rat Pussle, the L.A.P.D., and the afflu-hips.

A paper mache duck was constructed by Arlene Hendler, local artist, and floated down the canals with a notice of intent

stuck through it's breast.

A funeral is not a funeral without religious ritual. One of the major Venice religions was represented by witches from an anarchist Coven. They prayed to the Goddess to dispell the evil forces that threaten to gobble up the land.

Mary Jane Kwan, one of the original organizers of the Canal Festivals and forced out of the canals by high rents, launched the coffin down the canals.

Every segment of the Venice Community vas represented. As a canal resident said, 'the dogs didn't get into fights. They knew something important was going on. Sylvia Cohen sang 'There's a Moon Over Venice Tonight' written by David Scott. Marcell read a favorite poem of Mary Lou Johnson's. Mary Lou was the facilitator coordinator and Mother of us all during the funeral arrangements.

The first Canal Festival was originated as a funeral, and now it's buried because it grew old and lost the original meaning - that of a rallying cry to preserve the rich mix of people that makes Venice a community and not just a place to live is. The funeral, despite the cries of "negative", "ooh, I hate death." and 'black makes me look so sallow'. turned out to be one of the most positive actions held in Venice in a long time. Remember October 4. I looked at the people as they saw the lots marked for outsized houses. Houses to be surrounded by six foot fences. Houses three times as tall as the smaller, older structures around them. Not apartment buildings for mixed incomes, but dwelling places for people who are going to use Venice as a

suburb. a bedroom community. The only people who weren't at the funeral were the two people who comprised the membership of the Venice Marina Women's Chamber of Commerce, who had opposed the Canal Festival since its inception, and the two reporters from the L.A. Everyone contributed to the funeral in their own way. Happy Jack lent the coffin, and the media was there and as usual managed to imply that a bunch of beer drinking drug taking rowdies had a head bashing fest, This time, however, the L.A. times also managed to give it racial overtones. Mr. Nieson Himmel, Police Reporter for the L.A. Times, mentioned the police action, racial slurs, and did not report that a woman had been arrested for refusing to disperse from her own front yard. Who

when the City of L.A. and it's agencies do such a good job of radicalizing the silent majority? With the exception of Channel 2, KNXT news, none of the major media mentioned the focus of the action, which was to stop mass high income developments in the canal area.

At 4 o'clock, after the eulogies had been spoken, the funeral wreaths floated down the canals, a rock band started to play and people started to dance. The police came and declared it an illegal assembly. "Just like any other festival",

someone said. "Everyone had the sort of festival they wanted," said Mary Lou. "I'm a funeral freak and I had that. The militans had their festival, the boogiers had their

festival and the police had their festival.

"There were no permits so anyone could do anything they wanted - even the volice," said Jay, the Bubble Man. "Everyone did their own trip and it all added up to one big trip," said Tomito. "The police wouldn't let us carry the coffin because it attracted too much attention, so me and 5 or 6 kids snuck it up and down the foot bridges - running, Whew." Said Marcella. "You must leave this park," said a polic officer. "What for?" Said Moe Stavnezer, advocate for the community at Coastal Commission hearings. "You're under arrest." Said the police officer.

"I said the funeral would be a consciousness raising event. I didn't expect the police to cooperate so fully,

said Mary Lou. It's the kind of funeral I want. To ber lovingly remembered by friends, to know they will think of me as they do their necessary tasks for survival.

Blue Cross and Blue Shield admit they have been providing the FBI with sensitive, private mental health information about their policy holders.

Richard Luchrs, the director of the Blue Cross-Blue Shield federal employees program, states that condidential psychiatric information ha been forwarded to the FBI without court-ordered warrants. Luehrs adds that the insurance group has relied on the bureau's word that the information was wanted for criminal and not political reasons.

Blue Cross-Blue Shield says, however, that a new policy is being adopted that will require the FBI to obtain a court order before any additional information on the mental history of patients is surrendered in the future.

I.R.S. AUDITS POOR MORE

Although the Internal Revenue Service insists that audited returns are mostly chosen at random, a recent federal study shows that the lower the income, the higher the chance of IRS scrutiny.

In 1974, 3.6 percent of returns with income under \$10,000 and with itemized deductions were audited, compared with only 2.4 percent audited in the \$10,000 to \$50,000 group. Moreover, the IRS recovered 61 percent of claims against those in the under \$10,000 bracket and only 39 percent against those in the \$500,000 to 31 million specket ... LNS

ENVIRONMENTAL TRACH

The Environmental Protection Agency, along with seven ecology organizations, has resigned from the group known as Keep America Beautiful, Inc.

Keep American Beautiful is the organization that has TV ads featuring an American Indian who is weeping over the trash that has been strewn about his land. The organization has been sponsoring a \$40 million advertising campaign, carried free of charge by the major networks, that proclaims: "People start pollution, People can stop it."

The EPA and environmental groups have withdrawn from Keep America Beautiful contending it has become a "front group" for the makers of bottles and throwaway cans. The chairman of Keep America Beautiful is William May, who is the c'a rman of the American Can Company, Others on the Beautifu' board include representatives of Coco Cola, Pepsi Cola, the National Can Company, the US Brewers Association, The Glass Blowers Association and the Continental Can Company.

Oregon senator Mark Hatfield says the group has stridently opposed federal efforts to adopt an Oregon-type law that would require deposits on all beverage containers.

Hatfield adds that Keep America Beautiful's president May recently told his board that: "We must use every tool available" to combat bottle referenda this year. Hatfield quotes May as exp; aining: "Communists or people with Communist ideas are trying to get these states to go the way of Oregon.".. ZNS
