# Sign of the Times

As is the way in Venice, there are shops on the Ocean Front Walk. As is the way of shops, there are signs out front, proclaiming titles. One shop, and one sign, has been getting a lot

of attention lately,
The sign says "Local Heroes" and denotes a boutique of the usual OFW variety. Because of the sign, it's becoming a unique boutique, for the wrong reasons. The sign features a picture of the Marvel Comics character "Daredevil", pointing an enormous gun at the viewer.

Not all the locals have found this graphic image to be heroic. One nameess critic displeasure by shooting the sign full of holes. About 30 or so bullets by my estimate. Others have found more peaceful means of protest, Jerry Rubin for one, who has negotiated with the owners of the store several

times about changing or removing the sign. Although the folks associated with the "Local Heroes" boutique have made several promises, it appears at this point that all of their bargaining has been in bad faith.

Another local, Gil Borgos by name (and by fame), used a paint gun to draw a circle and a line on the sign, in the international symbol of "NO". As some of us have come to realize, it is no fun to be walking down the beach and realize there is a gun pointed

out of my home. I got into a verbal argument, and was later arrested at the station, when I went to find out why I could not file a complaint. These men had broken the law, coming to my home with guns in front of my children, scaring them half to death. I was charged with disturbing the peace when my peace had been disturbed and my rights violated ... Un wonday I received this letter:

I have informed you in front of two witnesses that if this public meeting takes place at your apartment and courtyard on Sunday . Feb. 28, 198 that you will be in violation of your rental agreement and can be subject to termination of your rental agreement and eviction from your Apt. #

This letter confirms the verbal warning listed above.

In July 1988, they decided to evict: me for the bar-b-que, my lawyer's response was this:

"The Larbeque, including the speeches, did not violate any provision of the Lease. The Landlord's prior consent is not required for such an event and the Landlord has no right to object to such an event. Consequently, neither ws. hyman's failure to obtain the Landlord's prior consent nor her refusal to abide by the Landlord's invalid and worthless



refusal to grant permission constitutes a Lease violation or a ground for eviction. rurthermore, the barbeque and speeches clearly were activity protected by the First and Fourteenth Amendments to the United States Constitution and, as such, may not form the basis for evicting ws. nyman. Civil Code 1942.5(c); see also winchell v. rnglish, 62 Cal. App. 3d 125, 155 Cal. Aptr. 20 (1976) (under Unruh Civil Rights Act, Civil Code's 51-53, landlord may not evict tenant for associating with black people); woods-prake v. Lundy, 677 F. 2d 1198 (5th Jir. 1982) (such action also violates federal law)."

So our noble Congress has decided not to give themselves a 50% pay hike. My heart just goes out to our poor representatives, who are terribly underpaid now compared to their counterparts in private industry. That's why Governor Deukmejian doesn't want to run for a third term--we taxpayers give him \$90,000 a year, while he could earn \$500,000 to a million yearly as a corporate lawyer or lobbyist. Deukmejian dreams of doing what many former-elected officials of the DemoPublican persuasion and their assistants are doing -- serve as a highly paid middleman between business and government agencies. Top Reagan officials Mike Deaver and Lyn Nofziger went on to help defense contractors make deals after they quit the Reagan White House. Defense Secretary Frank Carlucci and Secretary of State George Schultz now help run, respectively, Westinghouse, builder of nuke reactors and jet engines, and Hughes Aircraft-maker of missiles, satellites, and radar systems.

The amount of money that pours into our government from private sources is incredible. Look at the California State legislature. It costs between \$300-\$500,000 to run for election. But we pay 120 assemblymembers and senators only \$40,000 a year--that adds up to \$4.8 million. Now--private campaign contributions and Lobbying-- money spent to influence legislative or administrative action" -- total over \$100 million a year, according to reports

Regarding your article about "Our House": Great fiction! Let me give you facts about what was our house!

John Q. Tabor moved to Broadway in 1924 and bought the house. He worked for his brother Charles Tabor, driving one of the 4 trucks Charles owned. He then bought his own trucks (3) and was in business for himself from then on. Irving Tabor was chauffeur of Abbot Kinney, he never drove, owned trucks, and wasn't in partners with either of his brothers Charles or John. The gravel (which is decomposed granite) was put there by John Q. Tabor to make a suitable driveway to use for the heavy trucks, not absorb oil or grease. The ground here, being a swamp originally, is clay and not conducive for driving on. Charles and John provided the means to move the rest of our family from Morgan City, Louisiana. Not Philadelphia, and it wasn't Irving Tabor.

John Q. Tabor rented Broadway from 1946 to 1984 the year he died. Mrs. Ruby Murphy lived in the house until 1986. She lived there at least 25 years.

The house was not a gang headquarters, and there wasn't any selling of drugs in the house either; in the front of the house, possibly around the garage, it might have occurred. But don't involve Mrs. Murphy in that! As for gang slogans written or carved in the woodwork--not inside the house there

wasn't! Up to the time we sold it anyway.

And for this neighborhood being racially mixed, that's a laugh! Blacks were only on San Juan and Westminster between 7th and 5th Ave. They weren t allowed to live elsewhere. Until my grandfather moved to Broadway, and his sister and family moved to Vernon and 7th in the mid 1920's with the KKK demonstrating against it!! The Tabors and Alphonses being the first blacks to live (settle) in Venice. So in the future I expect you to derive facts and print facts not fiction, and you de better print this in your paper to undo the damage you cause by disseminating fairy tales. If you want details of our family call us.

Dear Mr. Tabor.

Thank you for correcting some of my facts. I got many of my impressions (fairy tales) from your father as he discussed what life was like growing up in this house in early Venice. I did not take notes because you and your father seemed here to welcome us to The Neighborhood and to enlist our help in renting a house your family owns about a block from here.

If you will re-read my article, you will see that there is no indication that Mrs. Murphy (who I did not name!) or any member of the Tabor family has ever condoned or participated in either gang activities or drug sales. But this house has gang grafitti inside the house carved into the woodwork the mantle and spray painted on the walls so thick that latex paint will not cover it. Collective prudence prevents me from naming the particular gang.

Those Klansmen of the 1920's you mentioned could not have devised a better scenario to rid this neighborhood of poor and minority people. As Salim Muwakkil recently wrote in In These Times: Crack is cutting "a swath through the African-American community leaving

battered lives and squandered potential in its wake...

RIGHTS AND REASONS

Dear Editor;

I would like to make a contribution to the debate on abortion. The male antiabortionists need to apply their morality in trying to menstruate, or become pregnant. This is the only honest way in which ,perhaps, they will ever be able to understand the painful agony that the women who ,rightfully, abort experience. The female antiabortionists need to

emancipate themselves from that patriarchal morality in order to understand their true nature and the true essence of their rights. Their opposition to the women who have abortions reflects a limited perception of themselves. It lacks the necessary, conscious, control over the theories and insitutions which dominate their lives. This perception, contained in Genesis, and, historically, enforced by the Church and State, has allowed the development of the unequality and injustice that characterize the social status of a great majority of women in the world today. Defending the right of the unborn child is rather hypocritical in view of the exploitation, oppression and death which victimize women and their children throughout society. Twelve hundred children were killed, as a result of family violence and child abuse, in the U.S. in 1987. The death of women from starvation, prostitution and war is a crime, abortion is not. Neither Church or State have an inherent morality that can give then the wight to regulate and impregnate women's

bodies with their selfish interests and doctrines. History denounces both of them as great powers who grew from the cruelest oppression of the female gender. Even in a civilized democracy, these institutions do not recognize the inherent equality of women to men, especially Popes and Presidents. The U.S. Constitution does not, as it should, proclaim the right of women to be and be treated equally in all aspects

of human exisistence and social relations. And Bush's budget does not provide money for saving the lives of the women and children who are, incresingly, becoming homeless. These are two of the most immeadiate problems that we really need to resolve, if we want to be honest with our fellow humans: women. After the Great Iran-Contra Immorality and the Praise the Lord Scandal, what our nation really needs is not a conventional morality on abortion, but an urgent lesson on how to be honest, within and without. #### INTRODUCTION:

"L.A. can have Disneyland back to itself." The horrible parting shot of a friend moving north (to Reedley Ca.). Do local residents' dreams really lift: no higher than Mickey's Mouse? Having worked in California's farmlands as a younger man, this mexican, american-born compadre tried a hand to legal aid here for his spanish-speaking brothers and sisters...giving up to a too high cost of living I'm sure. For instance, his brother-in-law, roomate "Chato", an underpaid restaurant worker downtown, and no relation to the gun-slinging Charles Bronson of "Shoot-em-before-they shoot-you" fame...WAS shot!, (directly alongside his heart), just trying to walk home one night. For some reason, whenever I think of the LAPD since then, (although the shooter was not known to be police), I think directly to the sanitized, disneyland fascism referred by my friend's uncanny remark.

SWITCH SCENES:

A liquor store on LaCienega Blvd, one block to a Santa Monica Freeway Ramp: An attractive, black, female police officer stares me to the eye, snapping:

"If she (\*name withheld to protect the ignorant) wants to get a piece of the rock, if she wants to be an alcoholic, if she wants to sell her body out on the street...that's <u>HER</u> business!!"

I was stunned. This was "LA-Law-In-The-Flesh" speaking. Maybe a reformed/contorted/lesbian-liber tarian I thought later. Meanwhile, fuck you too Mademoiselle and the badge you rode in on. She was talking about my girlfriend/womanfriend/lover.. whatever the hell you label someone you care about. TIMING:

At least, these cop cop cliches didn't cut their unwitty route until AFTER my trippingly- trip friend had splittingly-split the scene. In fact, she had just (again) befuddled LA's "finest". One quick tongue with faster feet

The policewoman's reproach may have been nothing more than a muttered protest to losing her. For to be accurate, it was my <u>girlfriend</u> who called these 2 LAPD folks in the first place! Almost never have I myself desired these public(?!) "servants" presence. Certainly not since a Parker Center chokehold in 82. PLOT:

So the question remains: Just what human condition gives birth to this deso callous of police remarks? CHARACTERS:

But back to the story. My womanfriend (let's rename her <u>Lani</u>) is young, also attractive, and also black. Like so many other misfortunate LA-dwellers her age, she's spent the greater part of her adult life in the United States, under the regime of Reagan. The Omni-Impotent. The "Reagan Revulsion" so to doublespeak. And like so many of her peers as well, perhaps the most noticable and easily-appearing, new activity of the Revulsion years has been cocaine-related street exchange. Gangability- type lifestyling popped-up all over.

To be truthful, cocaine and alcohol were probably no strangers to her while plugging away at fashion sales in Venice, at a boardwalk clothing shop. With the never-guiding hand of capitalistic-fervor yanking out the fabric (ouch!) of legitimate trade at her store, Lani was forced to move inland, to LA's border with Culver City. This proved an even busier trading area for the various side-industries of cocaine and/or other non-licensed, open-street money-making.

i learned soon enough that a busy-bee-like network of little 'gangers' situated themselves blocks from my house at Adams and Fairfax. Until I learned Lani was so involved with this particular group however, I never comprehended the attraction of these so-called, 'new, drug-oriented' phenomenons.

But back to the liquor store and myself. To be fair, appearances may have made the deceiving less deceitful. And that's exactly part of the "all-that-doesn't-meet-the-eye" problem. For this reporter,... indeed all of me, myself and I have been characterized by the outside world as a modern-day caucasoid. In addition, my womanfriend Lani is younger by several years. The casual abserver possibly mistaking the two of us as hooker and John. Or at least more gently as "temporary girlfriend" and latest "fucker". In the defense then of slow-minded LAPD officers', this policewoman may have thrown herself out headlong to protect a "sister" (Lani's) supposedly meager(?) "rights".

Complicating matters for this police visit, the two of us were indeed having one more spat among many, this time in public view. It was not surprising then that an intervening adult might choose to defuse things by saying something perhaps stupid. In 1985 Glendale, on the first of January, I still remember being handcuffed, arrested and brought to jail after surrounded by 5 LAPD squad cars and 1 helicopter for peacefully, PICKETING. I had made the stupid mistake of questioning a first arriving officer if he knew that the law allowed for the exercise of a so-called, first amendment right. In other words, so what that an upholderer of law and order would blurt out some ridiculous, challengable misinterpretation of the printed legal system? For instance, I already know in the 1980's that suicide is permissable....but a knowledgeable policeperson ought to know it is still against the law. Isn't it? INTERUPTION:

Otherwise this story might be truly unimportant except that who else could condone such a freewheeling advocacy of 'crime' besides <u>LAPD</u> representatives? (The female officer was accompanied by an older white male partner). Was this advice given to prevent a more serious murder perhaps? (I doubt it. This past year I actually helped convince Lani to offer details of evidence to LAPD detectives regarding a man she knew, rumored to have murdered a number of people here in LA. The same detectives who eventually

broke the case weeks later, never bothered to speak with me in person despite my own, weeks earlier version voluntarily communicated. These same interviewing individuals, although ready to date nice-looking Lani at the drop of a policecar dime, had taken nearly 6 years to catch their man. The "fugitive" meanwhile stopped over to my house several times during this same period.)

Perhaps, the policewoman's crack(!) was intended to prevent a riot god forbid? Or to turn the radical new corner of police propaganda and outwardly promote drugs, alcoholism and prostitution? (And not so inwardly promote censorship and political enforcement. Two times already in these eighties I've been falsely arrested at my union hall. It seems certain union officials are offended by what I have to say, then simply lie to police claiming I tresspass on their! (my own) union hall property.

The Ramparts division downtown has arrived many times (in addition to the arrests) to help barricade union members away from their own officials' meetings. When Chief Gates fell under heavy scrutiny for the frequent use of killer choke-holds in the early 80's, his Ramparts' officer-underlings hung up a huge banner across one Parker Center officequarters reading: "HANG IN THERE CHIEF!"/ RAMPARTS DIVISION).

Yuk yuk yuk. We think not. Instead, this was simple slippage. The quick bleeping of what police authorities truly abdicate and proliferate...whether their "willing agents" are game to the plan or no. But enough editorializing. First launch into tangent:

#### TANGENT #1

In this sales-promotion, "free trade" society of ours, a nearly iron-clad argument is daily made to legalize all three aforementioned behaviors, ie. prostitution, drug addiction and alcoholism. After all, in a way they are but the pinnacles of consumption so desired by the markets of our economy...and they neatly match the slaphappy idiocy already well chronicled in the books 1984 and Brave New World. With 'soma', the wonder drug, and brain-cleansed, female love boxes oiling the way.

Let's make no mistake about it. Ours resembles a fairly lawless, drugged-up, alcoholic and prostituting society. Disneyland LA fast represents the leading edge of a slip-sliding anarchy. The election of Deputy Dawg George Bush nationally highlights this country's infatuation with sleaze, dimmed lightbulbs, and seat-of-the-pants rhetoric. But anyway, back again to LaCienega's liquorstore:

#### AN ASIDE:

Should others' prejudice be so overpowering as to influence one's own? Let's face it, they do. So profoundly so I even find myself double—questioning my love for this woman, Lani. Constantly re-asking: is it only sex? the forbidden? the eroticism of this mix that I push for it so? Most assuredly, even my closest relations question my motives. My brother (the writer) declares in perfect cliche style: "You are driven to Lani like a moth to a flame!" Yet I've known and loved this young woman off and on now for ten years. So back to what really took place at the liquor store:

#### THE PLAY:

After several years of performance within the corrupt U.S. working "system", Lani, a 26 year old adventuress sifted through neighborhood crackhouse(?) and "gang"member routines for tortured autumn weeks. She had only recently decided to live in the same house with me, owing largely I'm sure to the fact her living funds consisted of unemployment income and whatever sidejob money she could raise.

proletarian male however has to be sheer tedium. By contrast, at "ganger" headquarters: allinight get-togethers night after night, "borrowed" (euphemism) cars, overnight jailstays, fenced goods, car-date prostitution, "date-rape", 99 cents/40 oz. malt liquors tossed like popcans into overloaded brown grocery bags, pawned-off jewelry, misplaced ("exchanged") clothing everywhere. "Protection" from "protect-my-back", hired streetwalkers, bums and skinny 20 year olds. Break-ins. The "excitement" of inevitable police pullovers, the boredom of daytime soap operas. Lani told me she was a kind of "play mother" to her newly adopted, "enfants terribles". Telling central city seargents my house was being broken into by day (while at work),...these fools told me their hands were tied unless I stayed home and witnessed it!

Bluntly put: a life of shit, arguably preferable to working at minimum wages. Or at least this is how I imagined it, pretending to see through eyes 10 years younger than my own. From a point of view of some one seeking relief from the stresses of 1990 survival in Los Angeles...at least the "comraderie" of street hustling must keep the mind alert.

Still, instinctively, I was fighting like hell to keep her "out of it". Already quite tired from my own manual labor by day...the thought of challenging nightime-arising "gang" members, simply to approach my girlfriend wore me out considerably. Tackling her natural resistance to following me, as well as to my own insecurities at having "lost" her to these same strangers proved really too much. I barely had the strength to find her let alone convince her to join any part of the probably-worse and diseased, work-a-day world of capitalism and Reagan. Even following a rape, she went back to the streets. And this is nearly impossible to print.

Finally, after near-spasmodic, acting-attempts at killing each other for the deserved and heinous crimes of having impinged totally on one another's contrary lifestyles...we, with the help of her family, raised the money to fly her to Philadelphia, <u>out of LA</u> where she'd already been planning a return 'home.'







#### \*President's Message\*

When I decided to spend as much of my time as possible on community activities, I knew it could not last forever. I'm really pleased and surprised that I managed to spend less and less time at "gainful employment" and spend over two years as a full-time activist. I'm not quitting now; but I want your understanding as I fit volunteer work around a job like the rest of you already have to do.

Last May (procrastination?) I found out how to practice real estate, as I have in other times, other places, without a conflict of interest or even the appearance of conflict. (I'm ridiculousl concerned about that.) When my license arrives within the month, I will be working as a Buyer's Agent for military veterans using their entitlement. Since the maximum loan amount is under \$150,000., my clients will not be buying in Venice where houses sell for twice that and up, up, up.

Helping ordinary people achieve home ownership appeals to the same instincts that cause my interest in community affairs. Indivuduals gain in many ways from owning, and their communities are strengthened by the stability and committment of owners-occupants.

Our government used to have a committment to help people become homeowners, but deregulation of savings and loan companies encouraged other investments—now look who the government is helping! And housing American families is becoming a real crisis. (No one in Venice needs to be told.)

housing problem. Many of us are very concerned about housing the poorest among us—and rightly so—but all segments of middle and working class people are strained to rent in Venice or to buy their first home anywhere in the Los Angeles CMSA. (Both the California State Legislature and the National Board of Realtors are lately coming to address this need with proposals just out.)

To actually buy a home in Venice the likely scenario would require about \$65,000. or more up front, with monthly payments of about \$2,500. for the next 30 years. That means that the Bank

must be able to prove an income of \$90,000. per year. And interest rates are even now being driven higher by the Fed! Of course, variable rate mortgages can delay some of the cost, but you get the picture.

If you have lived in your apartment or owned your home for a few years, you may not have thought about whether you could afford your own home today.

Why is this important? I mean why should you care if a couple (it usually takes two incomes) who make more money than you ever dreamed of can afford to live in your town? Well, you know how we talk about the "jobs-housing balance"? And how our area is job-rich and housing-poor? That means that the managers, skilled workers, professionals, secretaries and bus boys who work here have to drive into/through/around Venice and vicinity every day. So our streets are full of TRAFFIC. That's why we can't maintain our quality of life.

If everyone who drives 20 miles to work could drive 2 miles instead, we would have a reduction in the traffic they caused by 90%. And if they could bicycle or walk, that would be even better. The next best thing would be for everyone to carpool. Three riders per car instead of three cars would certainly make a noticeable difference on our streets. How much better than wider and wider streets to carry more and more traffic.

It is important in an area where businesses prosper to have support businesses nearby, just as employees need to be nearby. And all these businesses, whether high tech, service or industrial need a good mix of employees. Our town need housing for all these employees at levels that each income level can afford, near to work.

We don't was critizy towers and concects ribbons replacing our beloved community. Some would like to blame rational, planned growth and community preservation advocates for the housing crisis. We are called elitist and worse because we want to keep the ambiance and style of Venice. We must address the need for affordable housing within the context of our community plan to answer these charges. And also because it is the right thing to do.

I started out to explain myself for a change from my usual President's Message, but I just can't seem to avoid preaching a sermon:

# BIZ Zapped By Coastal For Half Mil \$

WHY DID MARK NATHANSON REDIRECT 4540,000 FROM VENICE BIZ PARKING TO L.A. COUNTY??

Venice Beach Impact Zone (BIZ) parking fund may have been done out of \$540,000.00 by a slick move by California Coastal Commissioner Mark Nathanson at the February, 1989, regular Coastal Commission hearings in San Francisco.

The applicant, Del Rey Association, is comprised of owners of 36 Rl-1 lots east of Ballona Lagoon and north of Marina del Rey channel. Del Rey wishes to develop these parcels with walk ways (similar to the walk ways in North Beach area) intersperced with regular streets. Every walkway, by virtue of being for pedestrians and not for vehicles, loses 30 parking spaces for beach access parking — each walkway or mall, as they are called, eliminates 30 spaces from the use of beach recreation.

The developer didn't want to place parking spaces on valuable residential land and indicated that they would rather pay \$3,500.00 to inlieu parking instead. Coastal Commission staff reminded the commissioners in their recommendations that, "Prior to issuance of the permit the applicant shall submit the sum of \$540,000 (\$18,000 plus 30 parking spaces) to the 'Venice Coastal Parking Impact Trust Fund' of the City

Of Los Angeles. Such funds shall be used to increase public parking opportunities and/or coastal access within the Marina Peninsula. A second alternative to this condition is for the applicant to physically provide on-site parking. Should the applicant physically provide a percentage of the 30 on-site parking spaces then the total sum of the in-lieu fee shall be reduced by the corresponding number of parking spaces, however, in no case shall the combination of parking spaces required by less than 30." We are talking about parking mitigations required in the coastal zone.

The California Coastal Commission agreed with staff that Del Rey Association needed to pay \$18,000/space or \$540,000 and so ruled. At that moment, Commissioner Nathanson said that the money should go to Los Angeles County, and it was so moved.

Just like that we lost the money to develop 30 parking spaces on the Marina Peninsula to ease the strain on all of us regarding coastal access parking.

Councilwoman Galanter had specifically requested that the in-lieu parking space money be paid into the "Venice Coastal Parking Impact Trust Fund" administered by L.A. City Department of Transportation...monies limited to providing public parking within the BIZ.

Now what? Holler and scream? You bet! Also write Ruth backing her on this. Also write Mark Nathanson and ask specifically for our parking money back.

Following Sixth District update on planning and development compiled from information from the councilmanic office and private individuals.

#### Marina Place Update

On February 24, the Venice Town Council's petition to join the VTC and City of Los Angeles' legal actions against Culver City's approval of the Marina Place Shopping Mall was heard in Superior Court. As expected, the Court approved the petition and all future settlement negotiations will require the participation of both plaintiffs as well as the defendants, Culver City and the Prudential/Melvin Simon development team. The case, based on the California Environmental Quality Act, will go to the Los Angeles Superior Court April 24.

Key issues in the dispute remain the likely negative impact the one million square foot mall will have on surrounding City of Los Angeles neighborhoods, including traffic, coastal access, air quality and the jobs/ housing balance. It is not clear whether any amount of traffic mitigation measures can alleviate the impact of a major regional shopping center on the already clogged Washington/Lincoln intersection, while the developer has shown a reluctance to consider scaling back the project or converting it to other uses.

At the April 9 regular Venice Town Council meeting, the general membership will discuss and vote on whether to accept or reject a settlement offer from Prudential/Melvin Simon and Culver City, based on months of negotiation, or to continue the lawsuit.

#### Community Planning Advisory Committee

Councilwoman Ruth Galanter has formed three new CPACs to complement the Crenshaw CPAC created in 1988. The Venice, Mar Vista/Del Rey and Westchester/Playa del Rey groups were appointed in January and February and have begun meeting on a monthly basis. The next meeting is March 2 and is

The advisory committee members were selected from a pool of persons who expressed interest when the Councilwoman announced her intention to form the committees more than a year ago.

Members represent a broad cross-section of their communities and will advise Councilwoman Galanter on planning and development issues. Importantly, the advisory role of these committees will not supplant the the crucial role of neighborhood organizations in addressing development issues on a local basis.

Although the Venice Town Council does not have a majority on our Venice Community Planning Advisory Committee, we are well represented. Members include architects, community activists, developers and realtors.

#### Playa Vista Public Hearing

The 887 acre Playa Vista "mini-city" proposal remains the "big kid on the block" of local private sector development proposals, but something about it has been changed. On February 15, the long-anticipated deal between the property-owning Summa Corporation and mega-developers McGuire Thomas Partners finally closed, giving McGuire-Thomas and their partners, JMB Realty, controlling interest in the property. McGuire-Thomas is replacing Summas as the developer, a move expected to improve communica-

tions between the Playa Vista operation and the surrounding community.
Playa Vista currently has a "Big Batch" (zone change/plan amendment) application pending before the City of Los Angeles which asks for a number of technical and substantive language changes in the existing Specific Plans for Areas B (the wetlands) and C (the state-controlled parcel) of Playa Vista. A public hearing is scheduled for Tuesday, March 21 (4 - 6 pm and 7 pm - on), at Westchester High School, 7400 West Manchester. Thanks to the arrival of McGuire-Thomas and some intensive behind-the-scenes work by Councilwoman Galanter with the Planning Department and the LA City Attorney, citizens will be able to address any issues they feel are relevant to Playa Vista Areas B and C instead of the limited scope of the original application.

#### Channel Gateway

This residential/office project in the Oxford Triangle portion of Venice near Marina del Rey is in its Environmental Impact Report preparation stage. Delivery of the draft EIR is expected any week now, which will begin the process of extensive LA City and public review of the document. Developer Jerry Snyder and his partner Milt Swimmer have been meeting regularily and honestly with a variety of community groups to get input on his proposal (up to 1300 units plus 300,000 square feet of office space) and he has also been negotiating with descendants of the Gabrielino Indians over the scope of the required archaelogical study. The Gabrielinos once inhabited the Westchester/ Playa Vista/Marina/Venice area.

This proposed Interium Control Ordinance goes before the Planning Commission at LA City Hall (room 350) hearing on March 2. East Venice covers the area bounded by Rose, Lincoln, Venice Blulevard and east to Walgrove Avenue. Planning Department hearing examiner Michael Davies held a public hearing on this proposed ICO in Westchester on January 23 for which there was a modest turnout of citizens. Supporters outnumbered opponents by about 5-3. The ICO creates a transitional height limit of 45/33 feet on Venice Boulevard, where large new R4 buildings have recently dwarfed neighboring single-family homes, and a 30 foot height limit on other residential development in the ICO area.

After prolonged spadework with the Planning Department and the Department of Transportation, Councilwoman Galanter has succeeded in establishing a Master Plan process for the future of LAX. This Master Plan will be the first time the airport has ever been subjected to a concerted, multi-agency planning effort which takes into account the airport's immense impact on surrounding communities and the whole region.

Separately, the enormous Northside project continues to lurch along. A recent public workshop in Westchester saw an outpouring of neighborhood concern about the impacts of up to 5 million square feet of commercial and office space, while Councilwoman Galanter continues to work to convince the airport to dedicate more of the site to recreational open space.

#### Developments To Watch

Public Storage facility at 4th and Rose. After delays of more than a year, the zone change necessary to allow Public Storage to complete its project while turning over 3 vacant lots to the City for affordable housing finally received Planning and Environment Committee approval on February 14. A Coastal Permit hearing is set for February 27. As a condition of the zone change, Public Storage is required to process a height district change so that the 3 vacant lots can accomodate R3 housing. After considerable public discussion, the design of the remaining storage buildings has been changed to reflect citizen concerns about undifferentiated warehouses; the new design features considerable articulation and an Early California motif.

#### \*\*\*\*

A commercial proposal at 601 Ocean Front Walk has been scaled back to maximize open space and air and light for immediate neighbors. It also includes full BIZ parking and a requirement to make spaces available for local residents at controlled rates. Tied to the project and a neighboring

affordable housing (probably at 102 Navy Street to replace an existing condemned building). The 601 OFW project is awaiting a first public hearing.

John Stein will be presenting alternatives to Steve Blanchard's  $\ensuremath{\mathsf{OFW}}$ project at the March 9 general meeting of the Venice Town Council.

#### **\*\*\*\*\*\*\*\*\*\*\*\*\***

Tony Bill and Tony Greenberg's Bed and Breakfast project at Ocean Front Walk and Navy had its first public hearing January 31 in WLA. The hearing examiner is preparing a report on this controversial 50-rocm proposal which will go to the Planning Commission March 30. Telephone 485-2478 for more information on this CPC 88-737.

#### 

Venice Artist Block, Ltd, is proposing 20 resident artist studio units to be constructed on portions of a 50' wide parcel indentured to LA Pacific Railway Company. It is zoned C2, and the developer has planned for 45 parking spaces. The date for the hearing is March 20, Monday, at 10:00 am at the WLA City Hall, 2nd floor, at 1645 Corinth Avenue. Address is: 499 Santa Clara. The parcel is bordered by Electric, Santa Clara and San Juan.

#### \*\*\*\*

Electric Avenue parking -- the City Department of Transportation is nearly finished preparing Coastal Permit applications for two interim parking lots on the City-owned Electric Avenue railroad right of way east of Abbot Kinney Boulevard. The two lots will provide approximately 80 spaces for the parking-starved neighborhood and should be ready for use later this year, barring any undue delays.

From this time hence, any new commercial buildings in  $Venice\ must\ have$ adequate parking for themselves plus BIZ parking included in the construction. The Electric Avenue parking is intended to lessen the pressure caused by those older buildings built without parking mitigations. This will decrease the parking pressure on the neighborhood.

#### \*\*\*

Werner Scharf's "quasi-mini-mall" at 2903 West Washington next to Marina Printing in the Oxford Triangle was scheduled for a February public hearing until the residents of the Oxford Triangle strongly directed his attention to the fact that; 1, yet another mini-mall was not needed or wanted, and 2, that his project was governed by the City's new mini-mall ordinance. The hearing was postponed until Scharf could file proper applications for consideration under the new ordinance, which gives the Zoning Administrator authority to consider projects which deviate from the ordinance's regulations.

K&B (Kaplan and Brunk) Development's small office project proposals at 1410 and 1518 West Washington Blvd (now called Abbot Kinney Boulevard) are undergoing redesign to accomodate the requirements of the Venice ICO. Further hearings will be announced when scheduled.

#### Canvass

The Venice Renters Canvass (VRC) is a newly established tenant's rights organization. The group, which was founded in response to the crisis which is currently facing Venice renters, is working to keep Venice affordable by strengthening rent control, preserving federally subsidized housing and fighting gentrification.

The first issue the group is addressing is the need to strengthen the L.A. Rent Stabilization Ordinance. Working with Housing L.A., a city-wide coalition of housing groups and advocates, the VRC has launched a five week canvassing drive to educate tenants regarding their rights, inform tenants of the weaknesses in the rent control ordiance, and encourage tenant's to lobby the L.A. City Council to take action on this issue before the April 1989 election. The group will also be registering voters.

The VRC Supports strengthening the L.A. Rent Control Law through eliminating vacancy decontrol, closing loopholes, extending coverage to unprotected groups, and increasing the enforcement capabilities of the Rent Stabilization Board.

The Group's next canvass will focus on saving over 400 units of federally subsidized housing in Venice. In the 1960s and 70s federal housing programs gave private developers low interest loans to build low-income housing. The owners agreed to keep the buildings affordable for a maximum of 40 years. The contracts, however, contain a loophole which allow owners to pay off their debt after 20 years. If an owner gets out of the contract agreement, the rents can be raised to market levels, often doubling or tripling the current rent.

40,000 units are in danger city-wide. 400 of these units are located in Venice and are in danger of being lost to market rate conversions. Two of these buildings, containing 109 units, are located on the beachfront and are home to elderly Venice residents on fixed incomes. If these residents lose their homes, they will, in ald probabilities be forced to

The Venice Renters Canvass hopes to solidify the precinct network already in exi stence in the Venice area through ongoing canvassing by community members in their own neighborhoods.

We will be walking door to door to involve and inform our neighbors every Saturday between now and March 25th. We are meeting each Saturday at 9:30 am at 609 California, Venice. # RICO--Rubbing Out the 1st Amendment

RICO is an acronym for a Federal law: Racketeer Influenced and Corrupt Organizations. It was first enacted by congress in 1970 to fight "organized crime", mostly to stop mobsters from laundering money made through criminal enterprises (like drug trafficking) through legitimate businesses, known as "fronts".

RICO gives free reign to confiscate the inventories of businesses that do such laundering. However, now the Justice Department has started using this law to close down bookstores and videotape shops and seize the assets of their owners.

The hunters, aka prosecutors, go into either type of these shops, and if they find just a couple of (arguably) obscene items (out of inventories of otherwise "unobjectionable" material), they can go right ahead and close the store and seize all assets.

This attack on our First Amendment rights was begun by the Reagan/Bush/Meese Justice Dept. in the name of a major "war on sex". This law, RICO, is being used by our government as a literal morality squad.

One couple was ordered by the Government to hand over the entire contents of their three bookstores and video-rental shops. The jury found that few of the tapes were sexually explicit (although you could've rented anything from "Star Wars" to (gasp) Casablanca). However, the government also wanted to confiscate their home, and they face 95 years in prison. For what? For selling \$105.30 worth of "obscene" tapes.



As a result of this action and several other impending assaults on our 1st Amendment, (Virginia, Florida and Indiana have cases pending), many shop owners are understandably, running scared. More and more "mom & pop" bookstore owners are literally censoring themselves by removing "questionable" titles from their shelves before the Feds can deem them "obscene" and do it for them. RICO can strip the naive victim of everything he or she owns: homes, bank accounts, cars, businesses etc. Way to go.

Under RICO's provisions, there is no right of appeal before judgement

is executed, meaning the defendant 1) may not petition the court to stay forfeiture proceedings while the case is on appeal, and 2) he may also be forced to forfeit all his business and personal assets as soon as he or she has been sued. This law is so powerful that the Justice (and I use the word loosely) Department can seize assets before a court or jury has even heard the case. Wait a minute... I thought Ollie only shredded some "national security" documents (bad enough), but nobody mentioned the entire Constitution! And with the Bush Administration even more hostile to civil liberties, many more federal indictments may be imminent.

Fortunately, for us, the question is: Has the Government the right to confiscate materials that have not been declared obscene in court, and are therefore protected under the First Amendment's guarantee to free speech?

The Supreme Court has agreed to hear a case which could stop these self-appointed moralists in their tracks. If we don't stop them now, the Justice Department will make bookburners out of Federal Prosecutors; book and video sellers will be forced to censor themselves to avoid prosecution and confiscation of their assets; the Reagan Administration will have left a legacy of harm, if not irreparable damage, to the First Amendment.

Think about it. Whether you agree or disagree with us or not...no more Beachhead, no more Venice Magazine, no more "explicit" ads about dreaming in your Maidenform Bra...

Note: Thanks to the ACLU for info and the on-going struggle on all our behalf.

out this has not stoppthem (Alliance)
from further harrassment.

this was not my first experience with the management company and knowing that they were baised, but I could not prove my case, even when I had witnesses to the discrimination. The year of 1986, I was terminated as the manager, and was told by Jack Taren, " Regina: I need a man for the job, and if you do what the new manager wants you can remain living here..."

Since my being fired there have been several racial related releases from the employment of alliance Housing Inc. Just alone in this area, the manager of 919 5th Ave. was replaced by a mispanic, the mispanic was given another manager's position in another building replacing another black. On Sunset the woman (black) was replaced with a Hispanic, 535 Santa Clara a black male was replaced by a Hispanic, 915 7th Ave a black woman replaced by an mispanic woman, two manager's were released from their positions because their names appeared on a flyer to help keep these apartments for low-income people. They (Alliance) have replaced manager's with false lies and they (alliance) have themselves went to obtain these lies. They also used the same tactics to get out tenants who stand up for their rights, and fight back ...

There are no black maintenence personel working in the Venice area that live here like the Hispanics do.

In the last year the Hispanics have not attended the tenants' meetings, even the ones who originally were attending and signed petitions of discrimination. They seem afraid to come out. Some black tenants who were to represent buildings, have declined to do so...

Vermont ackinney, who had his first meeting at my apartment, and is the mediator form the Justice Dept. has failed to recognize the tenant groups' leaders, and also has not returned my phone calls...


I have contacted wel Levine's office concerning the laws and regulations that how's handbook has and what is allowed by the owner. I've been told by several tenants that they (Alliance) can just about do what they want. But I thought that while they (Alliance) were still under HUD Section 8, that they (HUD) had a say in the rules and regulations. The rules they impose on the tenants and certain tenants because of dislikes or likes are wrong and I will not stop seeking help until they (Alliance) are exposed...

There will be a meeting at Carwood Recreational Jenter 767 California Ave. march 4th at 4: p.m. Ruth Calanter will be present at this meeting, it will be for the tenants of these 15 apartments to stop the harrassments and evictions that are being waged on the tenants to get them out,

They have one black man who comes from L.A. to fix the washer's and refigerator but he does not live in Venice. The black men that used to work for them were fired when they fired the black supervisor. This was outright discrimination, but nothing was done about it. The people involved did not pursue the matter, and went looking for work elsewhere. The managers did not file with the ECC office, except for me...

but lately all I hear is they are being discriminatory against us blacks...

I am the president of the Tenant action Committee for the tenants of the Holiday Venice Apartments, and they have come to me with complaints of harrassement, unfair rent increases, unjust rules and regulations, fraudulent reasons to get the blacks out of these apartments are now being waged by the management company and expoliceman fony Steinhart. I can swear to this because my lawyer and I have taken over four depositions, and in them are outragous lies by steinhart, the bad thing about this is that the Hispanics are being used by the management company, to help get the blacks out. The Hispanics are afraid: some might be afraid to say anything because they are not here legally, others just don't want problems with the management company...



There was one Hispanic who knew this was true. He was fired. Then there was another who hurt himself, but to keep from paying this man, they fired him. Ly my understanding he just went to court and won a case against them. A clack woman was witness in his behalf...

me tenants of the holiday Venice apartments would like the Federal government to check alliance records and see how many blacks make up their apartments in Venice and how many blacks they have evicted out and replaced with hispanics, and how many hispanics they have evicted out. They (Alliance) know how to get rid of the hispanics with no problems, because they just tell them they have to move and they (hispanics) move, or they (Alliance) raise their rents, and they move out because they can't pay it. Also the Hispanics have lots of people lving in their units, that come and

go, but when the blacks have one vistor over three nights (according to the lease) this is not allowed. The rules should apply to everyone, including the managers, who have people living with them or visting them.

When the police pair arrived then, Lani caught them with her lip. She neatly had them convinced I was a sort of overbearing animal. I figured wrong that they would listen to my side of the story as well. For no sooner had I begun talking than the male officer nervously jumped out of his car to "frisk me"...

ordering me to move back away from the car.

Perhaps my bare "mechanic" hands had frightened him. It's true I would love to put a few of these cherished incompetents beneath the ground. Conversely, this same officer had been content to merely stare at Lani from his car seat...and I've known her to carry butcher knives as well as have access to guns. She certainly appears diminutive if not sexily dressed travelling outside.

This male official next asked me "Why did I want Lani to go to Philadelphia(!)?", a question he apparently deduced from Lani's rapidfire protests. I told him this was simply not true (ie. that I wanted her to go). He immediately completed the inquiry. He determined she was free to leave with the money.

#### HYPOTHETICAL ARGUMENT:

Now I think I have to say something direct about racism: Had I been a 37 year old black woman hanging out with a 26 year old white man, what are the chances a young white police officer would have blinked the older woman in the eye saying: "Hey, is this your live-in boyfriend? Trying to imprison him here in LA? Go on! Sure you got a right to get your money back and keep him off the streets. Hey asshole!, Give her back the money and just don't deal with her if you want to be on your own!" or better:

"If <u>he</u> wants to get a piece of the rock, if <u>he</u> wants to be an alcoholic, if <u>he</u> wants to go out and rob older women like yourself...that's HIS business!"

HAL...a few points on sexism might be raised here as well. The main point being that police seek the easy way out like all the druggies they supposedly police.

Yet, with this hopeful plan, the residue of our battling splattered one more time. Holding on to twenty dollars, (part of the cash I exchanged with her for a microwave oven she suddenly decided to sell me)...I told her the money was specified only for purchase of the plane ticket. She needed to compare ticket prices in a Recycler newspaper we could pick up at a liquor store! (Yes, we have just now arrived to the liquor store off LaCienega Blvd.).

Once inside, Lani immediately snatched yet another Colt 45 malt liquor bottle. Our relationship had soured so much, I had become convinced she was a confirmed alcoholic...and I determined to contribute in no way to her access of it.

I couldn't take it any longer. Before reaching the cash register, I blocked her path demanding return of the money. She argued she had legitimately been paid for the sale of her microwave...and that now the money was hers to do as she pleased. I practically screamed: "You are an accomplished liar and I will not let you get away with this! Give me back my \$20!" Back and forth the accusations flew to the eyebrows of liquor store attendants. Lani asked the police to be called. And I declared "Fine!"...I would wait on their verdict as well! In my mind I hoped they at least could stall her return to the crack street Adams so close and nearby.

A near hour passed before the LAPD duo showed. In the time gap waiting, Lani blankly stared into video-game screens which in turn blinked back children's quarters. She weakly tried bolting 2 times, greeting several strangers at a store telephone booth in additional attempts to escape. I kept close by, in difficult public circumstances, to prevent her running away.

#### NOT SO HYPOTHETICAL

When two union picketing friends of mine reported to LAPD officers that they had been nearly run down intentionally (by teenagers) in a 4-wheel drive truck, one East LA porkpig calmly asked them if they had not been drinking beer prior to the incident.

And when a Venice Numero Uno restaurant owner pulled a gun on an employee where I worked several years ago...no arrests were made for assault despite official reports to authorities. Later, at least one time in my life of police encounters to the unfortunate kind, and again in Venice,....arriving officers merely laughed when they saw my dirty picketsign in front of this same man's Washington St. pizza- palace. The sign carried two big drawings of roaches. Marching across the nasty-commented placard like silent toads of ca ca. The guntoting representatives of public order left peacefully, without bravado, stupidity or violation of federal constitutional rights. (I don't remember if they scabbed and ate a slice of pizza inside or not.!)

So back to Lani, love and the LAPD. Or why does frozen beer continue to decarbonate, bubbling way beyond the boundaries of it's can? You see. I have never been too close to "family". And no, the girl is truly crazy. Which is why I love her. For you see, I'm mentally ill myself. And that is why I'm writing this story about the both of us. WE NEED YOUR HELP!!

Reviewing my experience at the liquor store, I left this time with the same quick feet and silence my womanfriend Lani might have inspired. Hers was the new Disneyland Law of 1990 Los Angeles.

P.S. And hey, if people can get dressed up in immaculate white uniforms, sit all day in wheelchairs and beg for money in cups at LAX airport...why not this article? This is LA!

issued by the Fair Political Practices Commission. And according to the same reports, business interests account for half of that \$100 million, with the financial/insurance industries giving the most.

In November's election, auto insurers spent \$64 million to push Props. 101, 104 and 106. The lawyer industry fought back with \$17 million for their Prop. 100. Both sides propositions had neat anti-consumer

features to protect their own profits. The public saw through all the expensive commercials and voted for the Ralph Nader-sponsored Prop. 103, whose backers couldn't afford flashy commercials and spent \$500,000 on the elections.

And now that the D-Pubs' Supreme Court has mucked up Prop. 103's rate cuts, maybe I should point out that while Gov. Duke takes loads of campaign cash from insurers, and little from lawyers, the State's top Democrats, Willie Brown and David Roberti, accepted \$800,000 from insurers and the trial lawyers last year.

So, do you sometimes wonder why insurance rates are so high? Maybe you don't contribute enough to your local sharks -- er legislators.

-----PROP. O and PROP. P-----According to records just filed at the L.A. City Clerk's office, it cost Occidental Petroleum \$7.85 million to run their sleazy "oil drilling and elitism" campaign for Prop. P. Oxy's opponents, led by two L.A. City Councilmen, spent \$3.3 million--raised from several hundred Pacific Palisades residents, actors, writers and State Controller Gray Davis.




