If you have a taste for disgusting and upsetting films that have been designed to entertain you with scenes of sex and violence outside of the normal boundaries of good taste and subtlety, don't miss the "Shock Value Film Festival" at the Fox Venice. The L.A. Weekly is thoughtful enough to have sponsored it for your enjoyment, or at least its publisher Mr. Jay Levine. Call him to thank him. It is a "Russ Meyer-a-thon" of sex, violence, enormous breasts and cheap thrills, which began July 30th and will continue through September 24th. Reserve your Friday evening! Don't miss "Chatterbox". "Elevator Girls in Bondage", "Blood Feast", and "Multiple Maniacs". The advertizing of the film schedule reveals the joys in store for you: demented-fat queens, a girl's striptease, terrorized men, and men dressed as women, women's faces contorded with pain and fear, a girl's half-naked and chained, and of course, "Big Chesty Morgan".

Like film Director Curt McDowell says about his film "Thundercrack"..."It is every thing my family brought me up with. It is about rules and games and patriarchal manipulation".... I couldn't agree more with him. It is inherited in our patriarchal-dominated culture. Woman is the temptress, the receptacle of evil, and her sex is inferior. We know that because our Judeo-Christian tradition hold that myth to be true. After all, who is going to doubt the printed words of God the Father himself? Just check your bible for more information.

The Los Angeles Commission on Assault
Against Women quote in their brochures that the
Los Angeles Rape and Battering Hotline receives
300 calls per month from women victims (those
who report such violence), and that 3.3 million
women in the U.S. have experienced severe beating. The statistic does not go as far as in-



forming us about the number of women being strangled, tortured, knifed or gunned down before or after being raped each year in the U.S. These assaults go on quietly as news story.

and religious bondage is fairly recent if we consider that women held great power prior to the advent of patriarchal imposed culture. That is before biblical time, roughly 3,000 years ago. She embodied Deity as the life giving

power and as the personification of wisdom, Throughout patriarchal history, it has been acceptable to commit violence against women: wife beating, the burning of witches, suttee (practice of widow-burning in India), chinese foot-binding, and African clitoris mutilation of young girls (still practiced in 15 African countries today).

What is the "Shock Value Film Festival" telling us? Simply that sado-rituals are part of our culture, and acted out in real life and in horror movies.

Spunned by the srticle "Take Back the Night at the Fox" in the August issue of the Beachead, a group of women come the Venice Community formed the "Shock Value Protest Group" to protest this sexist, exploitative film festival which depicts women as victims and nymohomaniacs, and men as sex maniacs. If you are as disgusted as we are, join the demonstration we are sponsaring in front of the Fox Venice, 620 Lincoln Blvd, September 17 and 24 at 6:00 p.m. All we ask you to do, is to encourage customers to walk out and ask for their money back, or a couple of free tickets for up-coming movies. I am a fan and reader of the L.A.

Weekly but this is not a fan letter. I
have enclosed a copy of the most recent
Free Venice Beachhead and the most recent
"poster ad" for the Fox Venice Theatre.

I would like to call your attention to an article in the Beachhead on page 4 regarding the "Shock Value" series at the Fox. I also call your attention to the various descriptions of movies in the "Shock Value" series in the "Fox Notes & Showtimes" portion of their advertiser.

Given the generally excellent quality of your paper, including the story on racism in the South Bay (Aug. 6-12), I was very distressed after reading that the Weekly was sponsoring the "Shock Value" series.

Based upon past experience, I do not think that the Weekly condones violence against women (or men, for that matter). But many of the movies in "Shock Value" graphically display a great deal of such violence which seems at odds with your usual good taste and social responsibility.

It is my hope that, at best, the Weekly will withdraw its sponsorship of the "Shock Value" series, or, at the least, publish, in a prominent place in the paper, an article which presents the not so "entertaining" aspects of violence against women. The very grim statistics cited in the Beachhead are a place to start such an article. I'm certain, unfortunately, that the stories behind those statistics are even more grim.

I hope that you will give careful thought to the implications of L.A. Weekly sponsorship of films as violent and grissly as those featured in the Fox's "Shock Value" series.

VOP Veggies Velcome im Venice

This August marked the third birthday of the VENICE OCEAN PARK FOOD COOP. Since those salad days of the summer of '79 VOP COOP has managed not only to survive Reganomics, but also to expand the range of foods and household goods offered. A new produce case will be installed in the store in September making shopping at VOP more convenient and keeping the wide array of organic and nonorganic produce as fresh as any available.

VOP is an important alternative food store offering considerable savings to members and a neighborhood market to the community. You don't have to be a member to shop at the coop but members enjoy lower prices, have a voice in the policy of the coop, and help determine the items stocked in the store. The coop is owned by members -- the community -- and exists to sell the things you need and not to maximize profits for outs stockholders. Corporate supe markets largely determine the prices we pay for food through their monopoly of the marketplace. The coop cuts food costs through volunteer labor, less prepackaged foods, and more shelf space devoted to the things which you need rather than the things advertisers want you to buy. Unlike your corner health food store, VOP sells food that is healthy for our budget as well as your body. VOP carries a mixture of commercial and "health" foods. When a comparable noodle is available in bulk from a coop or commercial supplier, VOP will tit in place of the higher prices cural" label with beautiful rain as and gurus on the wrapper.

There is a misconception that shopping at the coop is inconvenient. However, at the coop there are no long aisles of processed foods an products which you seldom need. Everything is close at hand in the store. When you have to wait to



check out, you usually know the person next in line. Coops are not just for big families or communal households with large food budgets. Single people and smaller households have a smaller monthly work requirement (only 2 hours/month for a household of 1-3 persons). The dozens of bulk grains, beans, and flours can be purchased in smaller quantities as needed rather than in expensive prepackaged form. One can also bulk order most items in the store at 5%-10% discounts below the low member's prices. Unlike many health food stores, VOP carries a wide range of household goods--paper products, light bulbs, motor oil, laundry detergent, etc. The coop has Foster Farms chickens, fish, and Health Valley meats in the freezer. One stop at VOP can take care of the week's shopping.

If Remanomics has got you down, why not try out the food store with the you can afford for the products you want? Like Monterrey Jack cheese at \$1.99/1b or Alta Dena Naja plain yoghurt for 78¢ for 16 oz. Or how about 1 gal. of Knudsen's Natural Apple juice for \$4.36? Don't forget the Alta Dena Homo milk for \$1.05/2 gal. and Raw Certified for only \$1.14. Raw honey is also \$1.14/1b. and cashews are a low \$2.25/1b. These are regular member prices not specials. With all the money you save, maybe you can splurge on a pint of Haagen Dazs for only \$1.79.



But fascism unfortunately is not exclusive to the reactionary right.


You remember Jane "Free Speech" Fonda? Seems she's suing some film historian for writing an unauthorized biography of her.

Eventually we could stockpile information about other progressive groups all over the country, ot the world, for that matter. And let's not forget our legislators... their numbers need to be available at the twist of the finger.

We're shooting for a starting date early in September, right after Labor Day. Prior to opening day we'll be having a meeting on September 2nd, 7PM, at the Church in Ocean Park (235 Hill St.). Post-Nuclear Post Office Requested Address Return

(UPI) A nuclear war would be devastating, but the mail would still be delivered "to the extent possible under the circumstances." Postal Service officials told Congress recently.

"If something is left, be it in the Everglades or wherever, we will get it through," said Jerry Jones, general manager of the prevention and planning division of the US Postal Inspection Service.

Voicing some skepticism, Congressman Markey (D-Mass) commented, "there won't be many people left to read or write letters," after a nuclear attack. But Jones, undaunted, replied, "But if there are, they will get there mail."

Jones said the post office has two national goals concerning mail delivery in the event of a nuclear attack:

-"The first is to be prepared to function and deliver the nation's mail to the extent possible under the circumstances."


-"The second is tp protect, to the fullest extent possible, postal employees from the effects of nuclear attack."

If Washington is wiped out, the national postal system would be directed
from Memphis, Tenn. If Memphis is also
obliterated, command would be transfered
to San Bruno, Calif., Jones said.

Emergency change-of-address forms would help the Dept. of Health and Human Services "register a relocated population" after a nuclear attack, Jones said. Form 809, Mail Forwarding Order Emergency Change of Address, and Form 810, Safety Notification Card, are stocked in most post offices. Jones did not indicate when such froms should be completed.

But retired Rear Admiral Gene La Rocque, director of the Center for Defense Information, told the comgressional panel the postal plans are fradulent and deceitful."

"I can assure you that while neither snow nor rain nor heat nor gloom of nite will stay the swift completion of their appointed rounds, nuclear war will," he said.



PRIVACY: a two-way street



by Dave Brown

When can a landlord legally enter a tenants' apartment or house? The practice of some land-lords entering their tenants' homes without advance notice or permission--often in the tenant's absence--can make an already-frayed landlord/tenant relationship unbearable. Most landlords--and tenants--don't know their rights and duties in this regard. Let's review them.

Section 1954 of the California Civil Code says a landlord can enter a tenant's home in the

following situations:

(a) In an emergency, at any time, without the tenant's permission. The "emergency" has to be a real one which threatens injury or property damage if not corrected immediately--like a fire, gas leak, or exploding hot water heater.

(b) To make emergency or agreed-upon repairs, decorations, etc., or to show the place to workmen, contractors, etc., prospective buyers--or prospective new tenants toward the end of the current tenancy. This can only be done during "normal business hours" (9 to 5), and the landlord must give the tenant "reasonable notice"-- presumed to be 24 hours. One loophole, though, is that the landlord doesn't have to give 24 hours advance notice if doing so would be "impracticable" (extremely difficult). All this really means, though, is that common sense should be used.

EXAMPLE: If the landlord wants to come in to repair the wall heater at 2 P.M. on Tuesday (just before the gas company personnel get there), s/he should tell the tenant on or before 2 P.M. on Monday. But if s/he can't reach the tenant until 6 P.M. (can't be reached at work), less than 24 hours notice is probably okay.

The only other times the landlord may enter

the premises are:

(c) After the tenant has moved out; and (d) After getting a court order in a lawsuit against a tenant who is totally unreasonable about giving the landlord access.

Many leases or written rental agreements say something completely different from the above—such as that the landlord can come in and inspect any time s/he wants. These kinds of provisions are not legally enforceable. Section 1953(a)(1) of the Civil Code says that any agreement where the tenant gives up or modifies his or her right to privacy is of no effect. (A few landlords realize this, but go ahead and use such illegal clauses anyway to make the tenant think s/he has no rights.)



LANDLORD RIGHTS

Few landlords willing to give reasonable notice of their intent to enter the tenant's home for legitimate purposes are faced with adamant refusals by tenants. But if a landlord does run into repeated unreasonable refusals, he or she can







legally simply enter the premises during normal business hours as long as it's for one of the reasons listed in (b) above. However, for practical reasons, a wise landlord will not enter alone, but will bring someone along who can later act as a witness in case the tenant claims some of his or her property is missing.

Another problem faced by landlords is that some tenants, fearing (perhaps justly) an unauthorized invasion of their privacy, simply have their locks changed. This is legally improper, since it prevents the landlord from entering in legitimate cases—such as emergencies—without breaking in. If you're faced with a changed door lock, you're legally within your rights if you call a locksmith and have it changed back—but you must give the tenant the new key immediately, or you may face a lawsuit for locking your tenant out. To protect yourself, put a note on the tenant's door saying a key is available from you or from a neighbor nearby—and keep a copy of the notice.

For serious conflicts, try talking-then a letter. If all else fails, you may have to start thinking about evicting the tenant by giving him or her a 30-day notice to vacate. Be sure to state on the notice that you're doing it because of an unreasonable refusal to give you proper access to the place for legitimate purposes. Also, comply with any local just-cause eviction or rent-control laws regarding evictions, and make sure you're not retaliating against isolated refusals to let you in, or against a proper and

reasonable insistence on privacy.

TENANT RIGHTS

A tenant faced with a landlord who seems to think his or her tenants are undeserving of privacy considerations should first try talking the problem out. While this may seem obvious, it's amazing how some folks in this litigious society of ours will immediately start thinking about a lawsuit before any attempt at communication is made. Try to impress on your landlord that you understand s/he needs to have occasional access to your place, but that you also need your privacy and would feel much better if s/he'd give you adequate notice as provided by law.

One frequent source of privacy problems occurs when a landlord and/or real estate salespeople trying to sell or re-rent the premises show(s) up on a tenant's doorstep without warning and ask(s) to show the place to a prospective buyer or renter. The tenant is within his or her rights to say politely but firmly, "I'm busy right now-try again after we've set a time convenient for all of us..." Remember, 24 hours notice is considered to be reasonable notice by law.

If talking doesn't produce results, a tenant's next step is to write a polite but firm letter insisting on advance notice, that entry be made at reasonable hours, and that the landlord not abuse the right of access. Keep a copy of your letter. If the landlord tries to evict you in retaliation for your trying to exercise your legal right to privacy (and it does happen), you will want to show your copy of the letter to the judge as part of your defense. This sort of letter will also be very valuable if the landlord persists in violating your rights and you sue for damages (up to \$1,500) in Small Claims Court. This is something to consider if you are dealing with a landlord who repeatedly violates your rights.

Unfilled Prescription

MEDI-CAL CUTS

by MOE STAVNEZER

Folks who are on Medi-Cal can expect to feel the full brunt of cuts in the Prescription part of that program this Septmber. On Sept. 1st, Medi-Cal recipients must, with almost no exceptions, make a mandatory add-on "co-pay" of \$1.00 for each prescription filled. Exemptions to the co-pay are ONLY children in foster homes and some nursing home type of institutions.

But that's only part of the story. The new budget also required a \$43million cut in the Medi-Cal Formulary which means that many prescription drugs will no longer be available to poor people and the elderly. In general, these cuts will means that Medi-Cal recipients will not be able to get the newest, often most effective drugs using Medi-Cal.

Removed totally from the Medi-Cal program are such types of drugs as:

1. Antimalarials: Quinine

2. Anticholinergics (mainly for ulcer patients) except Donnatal (or its generic form).

3. Antihistamines: All are eliminated e.g. Actifed, ChlorTrimeton ect.

4. Analgesics/Anti-Inflammatories:
a. eliminate all codeine and other
related pain killers and combinations of those drugs.

 b. eliminate all non-narcotic pain killers except aspirin, Tylenol and sodium salicylate.

5. Expectorants/Cough preps: all the Phenergan formulas, Robitussin, Hycodan etc.

6. Medical Supplies: such as cotton, adhesive tapes etc.

And such authorization is expected to become far more difficult to obtain than at present. Drugs requiring this authorization include many of the new anti-arthritis drugs (Motrin, Maprosyn etc.); many of the newer diuretics (Lasix, HydrDiuril, Dyazide aze still on the program); all sleeping medication except phenobarbital; all skin preparations.

Close to Sept. 1st you should check with your pharmacist and physician about your prescriptions, especially if you are chronically ill and need any of the above kinds of medications. It is possible that many doctors are not aware of the extent of the prescription cuts and how they apply to you.

So Reagonomics and Proposition 13 (lets all thank Howard Jarvis again!) means that the poor and the elderly will now have to spend much more of their meager income on what often are lifesustaining or comforting medications. The last time anything like this happened was when Reagan was governor of California. The result was a saving of money for outpatient doctor vists and prescription and a tremendous increase in hospital visits because people put off doctor visits until the disease had gotten quite serious. The result was little or no savings in money and a terrible toll in human terms. Thanks Howie; thanks Ronnie! []

Canal Defeated PROPOSITION 9

Conservation Urged PROPOSITION 13

by Ronald B. Robie, Director

California Department of Water Resources (Ed. Note: The following is the first section of Dr. Robie's Report of Activities of the Department of Water Resources as presented to the California Water Commission, July 2, 1982. Minor editing has reduced its length about 10 percent.)

I was very disappointed that the voters disaproved Proposition 9 on June 8. The Department believes strongly that the Peripheral Canal remains the only environmentally sound Delta transfer facility. On the other hand, the so-called through-Delta "Orlob Plan", which was promoted during the campaign by the Central Delta Water Agency and the Lieutenant Governor's phony Task Force, is not a viable alternative and the Department will not waste any money studying it further.

I particularly regret the fact that the Constitutional protections for the Delta, San Francisco Bay and North Coast rivers, approved by the people only 18 months ago, are now gone.

I have directed the staff to complete with dispatch the water management plans required by the Governor's Executive Order 68-80 to enable our contractors to cope with the status quo (which is the result of the election) by better manging existing supplies. These management plans will include actions that can be undertaken by the State and our water service contractors to reduce the demand for water, to reclaim urban and agricultural waste water, to store water underground in order to provide for dry years, and to provide for consideration of water exchanges and other methods for reducing the demand for new water facilities.

Unfortunately the status quo also means further adverse fishery impacts in the Delta and future water shortages. I have directed the staff to review our present Delta operations to mitigate these impacts while attempting to meet water supply needs. The rejection of Proposition 9 makes it particularly important that we obtain, at last, the cooperation of the largest Delta diverter, the federal Central Valley Project, which must finally commit itself to meeting State water rights and water quality requirements. Leverage to provide such cooperation was included in Proposition 9, but is no longer available to us. The Reagan Administration has given only lip service to states' rights. The Bureau of Reclamation has not budged from its historic position.

With regard to the Department's activities for the future. I have directed the staff to terminate the planning on the facilities dependent of Proposition 9. Over the next few months we plan to wind down the Los Vaqueros and Thomes-Newville Reservoir studies and the specific studies leading

to the Peripheral Canal. Because of program reductions due to Proposition 9's failure, we may have surplus employees and may have layoffs. We are making every attempt to minimize the adverse impact of this on our employees.

I am not going to attempt to second guess why

opposed views in moving toward rejection of Proposition 9. Environmentalists who wanted to reject the State Water Project or redirect California water planning had little in common with the California Farm Bureau and the giant land barons who opposed Proposition 9 in order to get rid of its environmental safeguards so development could proceed as it has in the past.

I am particularly outraged at the massive expenditure of funds by the Salyer Land Company and the J. G. Boswell Company, important water contrac tors of the State (as part of the Tulare Lake Basin Water Storage District) who almost singlehandedly financed the negative campaign totaling \$1,650,000 to date, solely to demolish the environmental safeguards of Proposition 9 and to rip away protections for the North Coast wild rivers. Previously they had made expensive major attacks against the Peripheral Canal in the Legislature. Their campaign activities also include contributing major amounts to the Lieutenant Governor's unsuccessful campaign for the Republican nomination for governor in the form of commercials which attacked Proposition 9 and the Canal, as well as the creation of the phony "Task Force" which generated significant adverse publicity for Proposition 9 and the State Water Project.

I'm confident they will rue the day they engaged in this self destruction. Out of the rubble which resulted from these activities, we must fashion a positive program for meeting the water needs of the people of California.

The LA Times reported on 6 August that \$6.3 million were spent on Proposition 9; \$3.6 million in opposition of which nearly \$2 million came from Salver and Boswell. It is also of interest to note that the firm that managed the campaign against the Peripheral Canal, Russo-Watts of Sacramento, has been hired to defeat the waterconservation initiative on the November ballot. A

Many concerns have emerged from the savage brawl over the Peripheral Canal.

These concerns, which include mammoth water development costs, fears of statewide water shortages, the loss of our groundwater and natural streams, reveal that California desperately needs a longrange water policy. An effective water policy to deal with scarcity which is more suited to the 1980's than to the Gold Rush days in which much of the current water law is rooted.

There is no panacea for all our water problems. However, available on the Nov. ballot is some very strong medicine. Proposition 13, the Water Conservation and Efficiency Act, an initiative measure that will heal our water problems statewide by promoting water conservation programs and efficient use. Key elements of Proposition 13 include:

Conservation: The measure requires that economically competitive water conservation programs be developed at the local level before a water district can import new water supplies. It also discourages the use of price subsidies for large water consumption.


Instream: Prop. 13 gives the Water Resources Control Board the authority to require that enough water be left in rivers, lakes, estuaries and wetlands to provide for recreation, wildlife, and water quality.

Groundwater: Prop. 13 also mandates locally developed and implemented goundwater management programs in 11 basins currently identified by the State as critically overdrafted.

Support for Proposition 13 comes from a broad range of groups and individuals including; California League of Conservation Voters, Friends of the River, the Sierra Club, Gray Panthers, Mel Levine, Alan Sieroty and Howard Berman.

U.S., French and Italian troops are being sent to Beirut to keep the peace as the Palestinian Army withdraws from Lebanon. The agreement reached "between all concerned parties" provides for the evacuation of the Palestinians and prevents the further destruction of West Beirut. The agreement does nothing to solve Arab Palestinian problem and does not address the issues of the West Bank, Gaza Strip, or the Golan Heights.

What the agreement does recognize is the apparent partition of Lebanon into the Israeli occupied south and the Syrian occupied northeast. The Israeli Army is not required to withdraw and is presently having winter supplies sent to the front. The Syrians whose Arab League mandate has expired show no signs of withdrawing from Lebanon.

The much bally-hooed agreement does not "give Lebanon back its country" and although elections will be held in Lebanon soon, thousands of Lemanese will be voting under the eye of an occupying Army.

So as the Palestinians leave Beirut, Lebanon faces the US sanctioned future as an occupied, divided vountry. And the Israelis have postponed the inevitable as the Palestinians regroup. [

Robert Avakian, Chairman of the Revolutionary Communist Party, alleging "blatant, systematic and intensifying political persecution in the USA" was recently denied political refugee status by the French Office for the Protection of Refugees And Countryless Persons. The decision stated that "Mr. Robert Avakian was never denied access to the media, nor prevented from spreading ideas of the Party as he engaged on a number of occasions and for a number of months in propaganda speaking tours during which he freely described the goals of his organization as they appear in the publication entitled: 'The Programme and Constitution of the R,C.P./USA.' "Which is available for sale free of any and all restrictions throughout the country. "

The decision also commented negatively on Mr. Avakian's submission of the documents in English and the "campaign in the USA in order to put pressure on the Appeals Commission ... " The Commission report stated that Mr. Avakian had not faced judicial persecution for his political opinions and is not "in one of the categories covered by Article I, paragraph A of the Geneva convention."

Marinoids Miffed -Seniors Gain Housing

by Moe Stavnezer

On August 10th the first step in the development of a 183-unit senior citizen complex was taken when James Crisp, Assoc Zoning Administrator, approved the permit. Crisp, in his approval, praised the careful thought regarding the design and location of the development while ignoring the opposition made by neighbors from a 16-story building in nearby Marina del Rey.

Supporters of the badly needed housing included the Marina Tenants Assoc., Coastal Committee of the Venice Town Council, Councilwoman Pat Russell and the City and County Housing Authorities. All stressed the need, the fact that the 8story building is smaller than most in immediate area, and the proven need for far less parking spaces in this, as opposed to normal, developments.

Major opposition came from the 16story Kingwood apartment building whose lawyer complained that the building had too little parking and that it would block the views of Kingswood tenants. At this writing there is no appeal of the permit but the deadline doesn't run out until the end of August. An appeal will means a hearing before the Board of Zoning Appeals and, possibly, the City Council. The housing must also be approved by the Coastal Commission in a separate permit.

The Beachhead and the Coastal Committee will keep you informed of future hearings on this development, located on Via Dolce behind the Washington Square building. .




