




The L.A. Planning Commission, over the objection of its staff, approved Werner Scharff's proposal for a senior housing building on Paloma Ave.

The building is scaled down from 40ft. and 40 units to around 36ft. and 24 units. Questions about management of the building, including who will chose tenants or ensure that they remain as affordable, were left unanswered. Scharff was quoted in a daily L.A. newspaper stating that such questions will not be addressed until he has all the permits he needs. But, once he has the permits, who will be able to control what the man does? Sounds

like a little catch-22 to me. The only concession Scharff made was to put in writing that about & the parkspaces, out of a total of 70, will be made available to community residents. No one knows exactly what that means since neither "community" nor "residents" was in any way defined. The other half of the parking spaces are to be reserved for use by Scharff, known as the applicant, to accommodate parking needs for other of his properties in the area. A euphemism for the Cadillac building which is never mentioned in any of the official papers regarding this permit though it is intimately connected to it.

About the same time this action was taken, the City issued Scharff an exemption for the remodeling of the Cadillac. What that means is that Scharff does not have to go thru the permit process having convinced the bureaucrat who made the decision that the work on the Cadillac is merely repair and maintenence! Scharff is claiming that the Cadillac is currently a hotel and that no permit is needed because no change is taking place.

A group of Venice residents has been meeting to explore ways and means of establishing a farmers market here in Venice. The idea would replicate the present examples of farmers markets currently enjoying great success in Santa Monica and in many other So. Calif communities.

These markets, also called Direct Marketing Programs, allow small farmers to sell their produce directly to consumers at up to 35% less than the retail price for supermarket purchased fruits and vegetables. The program is sponsored by local communities and the Calif. Dept. of Agriculture.

What is presently needed is a loyal group of dedicated volunteers to help plan for the start up of a Venice Farmers Market. Southern Pacific Railroads Venice

It is reported that the Southern Pacific has agreed to sell its right of way in Venice and that most of it has either already been purchased or is in escrow.

The right of way, which runs from Washington St. in the south to Pier Ave in the North, is situated just east of Mildred Ave and Washington Blvd, and runs diagonally across Venice from wouth to north-west.

The strip of land was originally granted to the Santa Fe Railroad in 1887, later was owned by the California Railway Co and the Southern Pacific Co. The line fell into disuse as freight was more and more delivered locally by truck.

The right of way has been on transportation peoples minds recently as a way to put an extension of the Marina Freeway thru Venice, or as a possible site for rapid transit or a light rail line.

The property included in the right of way between Venice and Palms has been reportedly purchased by a Mr. Slayton who happens to be the major property owner on the east side of Electric Ave. The strip between Palms and California in part is already fenced off and is reportedly purchased. Another rumour has it that Mike Zacha of the Merchant of Venice has sought to purchase the right of way strip between California and Westminster. The strip between Westminister and Brooks is also reportedly in escrow, with parts of it already fenced off.

This strip of land, the right of way, is zoned C-2, which means that either residential, offices, studios, or rentals can be built on the site. It may also be possible to build artiststudios on the site.

Although on the market for several years the Anyone interested in participating or learning land did not move because Southern Pacific insisted on selling the entire right of way to one party. Failing to move the property the Company decided to sell it in smaller parcels and this strategy proved successful. .

I also said that though I desperately want housing for low-income seniors, I realize that the price the neighborhood would pay for that would be high in regards to esthetics, and in a classic case of the tail wagging the dog, parking.

If I painted Mr. Scharf as a stereotypical money-grubbing, greedy slumlord, I stand abashed. I detest that sort of rhetoric when I read it, and am embarrassed when I'm caught writing it. According to you and some of Mr. Scharf's other tenants, Mr. Scharf has been more than fair in his dealings. Many years ago on the lot which you now lease, Mr. Scharf allowed an art show put on by the Free Venice Committee, a group that was certainly not in complete agreement with Mr. Scharf's Vision of Venice.

dark. So do I.

When I first moved to Venice two decades ago, I was able to walk by the ocean ALONE. In spite of the 200% raise in rents in twenty years, when supposedly all the bad people have been pushed out, I find Venice more unsafe now. How many people, women in particular, feel safe walking on the walkstreets now lit by Hepatitus-yel-

Since the 1970's, when Venice has beer inundated by the YUPs (Young Urban Professionals), YUMPs (Young Upwardly Mobile Professionals) and the Afflu-Hips, the 3,000-watt bulbs that my neighbors seem to use as modern HEX signs that in reality do nothing but light up my bedroom, making me feel as if I'm doing time in some Universal Joint. Crimes of rape and assault seem to have gone up. I've noticed that wattage and security measures have gone up in proportion to the rents, and from what I've observed, dope, drinking and noise pollution have not gone down in proportion to the affluency of the neighborhood. The View From First Street This last year in Los Angeles MEMORIAL SERVICE FOR THE HOMELESS DEAD

This last year in Los Angeles, 200 people have died as a result of being homeless. Tonight thousands of women, men and children will again await the morning without benefit of shelter. Chances are good that someone else will die.

When someone is found dead, or nearly dead, on the streets, usually the paramedics are called first. The paramedics notify the Coroner's office, and someone is sent out in a van to pick up the body. It is taken to the County Morgue. The Coroner's office and the office of the Public Administrator work together to identify the body and to find relatives who will claim it. If no one can be found to claim the body, it is brought by truck to the County Creamatorium on First Street in East LA. You can see the three smoke stacks from First Street. The Creamatorium is staffed by General Relief recipients, who burn the bodies as their Workfare assignment. They unload the bodies and push them into three big ovens with long sticks. The bodies are burned for one hour, then swept into boxes as big as orange crates. Each crate is marked with a paper tag with a case number and either a name or "John Doe." At this time the bones are still in big chunks. If a relative wants to claim the body, the ashen bones are put into a grinder, and the remains are put into a small box with the same tag. If no one has claimed the body, however, the crate of bones and ashes is dumped without ceremony into a plywood covered pit outside the Creamatorium. On Monday tthe hole, perhaps 5' X 8' and who knows how deep, was about three quarters full with bones and ash. There is no list of names on the pit and no marker. Workers at the Creamatorium say that they burn eight to twelve bodies a day there. The County Coroner's office says that they handle around five unclaimed bodies a month.

This grisly information is an excerpt from a memorial service for the homeless dead that was held on Ash Wednesday (March 7, 1984) in downtown Los Angeles. The fact that it was organized by the Los Angeles Catholic Worker community is not surprising. These selfless and seemingly tireless workers are consistently the champions of the most helpless and hopeless. What is surprising is that it was organized in conjunction with a group called Poor People's Committee who are tormerly homeless men and women taking a stand tor the interests of the poor. This committee exists to educate and advocate for shelter, jobs and health care.

The memorial service started at the C.W. soup kitchen (known throughout Skid Row as the Hippie Kitchen). After lighting candles with a litary to the homeless "almost invisible in the night", we anointed our foreheads with ashes and picked up our crosses and flowers. My cross was inscribed with the name, Alan Silicant. Carrying our crosses we proceeded to Pershing Square, called out the names of those we were memorializing, placed the flowers on a coffin and finished with a moment of silent prayer. In the weeks that followed, the hub-bub over prayer in the schools erupted and the superficiality of that spiritual approach stood out in pitiful contrast.

I've tried, since then, to imagine how that must feel and and it's beyond me. No place to go to - to rest, to think; to read; to cry; to put your things away; to go to the toilet. No place to be sick; to make love; to tidy up; to BE. "Invisible in the night."

And who are these "homeless"?
They range in age from 20 to 74
years of age, with 52% under age
40. They are 47% white with 60%
having completed high school and
26% some college. Veterans comprise
52% (32% from Viet Nam). 51% have for
been homeless less than one year.

These, and more statistics were compiled by Richard Rogers and Marjorie Robertson, post-doctoral fellows at the U.C.L.A. School of Public Health, from a survey conducted at the Union Rescue Mission which is the largest urban mission in the United States.

But who is Alan Silicant whose cross I bear? And whose cross I must bear. I looked him up in the press packet that was being distributed. He had died the day before the memeorial service of cancer of the bronchi and the pancreas. He was 44 years old. That's all I know. Did anyone claim him? He was listed as a transient. Is Alan just another bunch of bones shovelled into that plywood covered pit? I guess so.

The Administration has implied that for some people homelessness is a "life-style". Now that sounds sort of jaunty, doesn't it? As if, given the choice, one has opted to be free of responsibility and possessions and live the care-free life of the unfettered.

In reality, the 30,000 homeless have tew options. Mental patients released from hospitals have no community mental health tacilities to take them in and hotel managers do not have to accept any tenants they think are "nuisances". The new "Okies", victims of unemployment, who come west, cannot find work and the city currently has no public shelters. Undocumented workers and their children often work for wages that are so low that they cannot afford housing. It is illegal to sleep in the streets, on public property, and - by recent statute in cars, making criminals of the homeless population. More recently, City Council has proposed prohibiting sleeping on bus benches. Private shelters have strict time limits, often only one night.

So, this "life-style" is one of continuous struggle, fruaght with peril from disease, vermin, physical assault and severe hypothermia (defined as a core body temperature below 90-95 degrees Farenheit). Surprisingly, there are more cases of hypothermia reported at County U.S.C. Medical Center than at the equivalent facility in New York, Bellvue Hospital. Tuberculosis and leprosy which have become virtually extinct in the United States, are found among among the homeless in Los Angeles.

Malnutrition, circulatory difficulties, infestations of lice and infections are familiar physical disorders.

rise In the end, homelessness is ve frequently fatal.



4 Provisional Govt. Proposed

Dateline San Salvador:

Sounds like election time. Many of you know that I'm in the Peace & Freedom Party, but I'm not writing about our '84 elections; I have in mind a People's win in El Salvador. It is along these lines that I want to share with those who may not know that 1984 opened with a most important document coming out of El Salvados It's a PROPOSAL FOR THE FORMATION AND PLATFORM OF A PROVISIONAL GOVERNMENT OF BROAD PARTICIPATION. The proposal is signed by the Farabubdo Marti Front for National Liberation (FMLN) and the Democratic Revolutionary Front (FDR). The following are excerpts from the proposal; anyone interested in the complete document call me at 396-6876.

It begins:

- " The Democratic Revolutionary Front and the Farabundo Marti Front for National Liberation have been struggling for the final liberation of our people for several years. We have proposed different alternatives to solve the current crisis, believing that the largest number of Salvadorans must share the efforts to achieve peace because only a powerful and braod effort will bring our country out of the destruction in which it has been immersed by the Oligarchic regime and the intervention of the United States government.
- " We face a complex situation nationally. The old oligarchic society and the state that has served it, have bathed in blood their own demise: they have institutionalized an apparatus of repression and exploitation and they propose political maneuvers aimed at covering up their studdorn pursuit of a military solution, because they are unable to meet the demands of thousands of Salvadorans. On the other hand, the escalation of intervention of the Reagan adminstration has prolonged the war and it threatens to regionalize the conflict.
- " We sustain that the construction of peace in our country requires a process involving the majority of social and political forces. These forces will create a viable solution based upon the elimination of the above factors mentioned and that are the cause of the conflict.
- "Therefore, the FMLN-FDR proposes the formation of a provisional government of broad participation in support of a platform containing the indispensible tasks that we must take on to overcome the current critical situation. It is a platform that will allow our people to

The proposal to form the provisional government of broad participation is the result of the development of the denocratic and revolutionary forces of the Salvadoran people in the military and political areas. The provisional gover nment of broad participation will not be a government in which only one sector will have control. It will be the expression of the broad participation of the social and political forces ready to end the oligarchic regime and to rescue national sovereignty and independence, a government in which the existence of private property and foreign investmests will not be against the social intrests.

It will be a provisional government of a duration which will be determined by the fulfilment of its basic objectives, according to the agreements between its parts, and in the understanding that it will not be a long-term government.

Basic objectives of the government are:

1. To rescue national independence and

sovereighty. and lay the groundwork for a true democracy in which human rights and political freedom are fully respected and where broad popular participation to achieve a definitive peace becomes a reality.

3. To respond to the most immediate and pressing needs of the popular mayorities and to adopt basic economic and social measures to change these structures.

4. To establish the practical condition needed to solve the actual state of war.

5. To prepare for and hold general elections.

Representatives of the labor movement, peasant, teachers, workers, professional associations, universities, political payties, the private sector, representatives of the FMLN-FDR and of an already-restructured army will participate.

The government institutions will be an expression of all of the sectors menand sectors who are against the objecttives of the provisional government or who advocate maintanining the dictatorship will be excluded.

It then outlines immediate measures to be taken, economic and social reforms, a foreign policy, and the procedures needed to accomplish the proposal. It concludes with.

"Once the process of dialogue-negotiations begins, and reaches an advanced stage, the FMLN-FDR manifests its disposition to negotiate a cease-fire. Once the agreements are concluded, documents will be signed by the parties to the conflict, the mediators and the witnesses in their character of guarantors. The agree ments will be applicable immediately in accordance to the dates, phases and procedures agreeded upon. This process will end with the organization of a unified national army, formed by the PMLN forces and the restructured governmental armed forces. Until then, both armies will keep their own arms."

Signed 31 January 1984

The call for a provisional government is an important step in the liberation movement; it's a classical transition process. It's obvious that the existing military government can't solve the problems of the people; and it's too little too late 2. To dismantle the repressive apparatus for the hollow reforms of the Christian Democrats. The only viable solution is a transition period where the people can create the kind of government they feel will solve their country's problems.

> Considering the call for a provisional government in the light of the elections set for March 25th, the real test would be to see along side the two major candidates: Roberto D'Aubuisson, who is closely associated with the Death Squads; and Jose Napoleon Duarte of the Christian Democratic Party, a spot on the ballot for the Provisional Government. I know, neither the government in El Salvador or in Washington would go for that.



Peace On The Pentagon A Taxless

The largest peace-time military budget in the history of the world is presently being spent by the U.S. Pentagon. The following is a two-part analysis of how much money is being spent and what

it is spent for.

Two hundred billion dollars (200+) is being spent this year by the Pentagon The top companies are McDonnell Douglass Martin Marietta, Rockwell International, United Technologies, General Dynamics, General Electric, Boeing, Lockheed, Hughes, Raytheon, Grumman, and Chrysler. Their major products include Trident Submarines, Tomahawk Cruise Missles, Stinger and Terrier Missles, Tanks, Aircraft, Helicopters, Harpoon Missles, Nuclear Reactors. Space Vehicles, ICBM Warheads, Trident ICBMs, Assault Ships, Aegis Missles, the Space Shuttle, AWACS Radar Aircraft, the B-1 Bomber, MX Missles, Guided Missle Launchers, and Tow, Patriot, Sidewinder, Hawk, Maverick and Phoenix Missles.

Research is also a major part of the Pentagon: budget. The top military research companies include some of those already mentioned as well as TRW, Westinghouse and Lockheed Space and Missle. The top Educational and Nonprofit Institutions doing military research are Rand Corp., the Univ. of California, M.I.T., Johns Hopkins, Georgia Tech, Ill. Institute of technology, Aerospace Corp., Mitre Corp., SRI International and Charles

Stark Draper Labs.

If you haven't already seen the name of your favorite Fortune 500 company, you'll appreciate knowing that the top missle contractors include other big business names. Companies such as GTE-Sylvania, Honeywell, Northrop, Thiokol, Aerojet and Hercules make missles for fun and profit. In case you believe that the Pentagon has no sense of humor, 22 armored Mercedes and BMW sedans are being made for military and Pentagon brass.

Just to give you an idea of how many jobs you can buy for one billion dollars; let's say you spend a billion on missles. You get 29,402 jobs. Housing gives 30,899 jobs for the same money. Railroads do a little better and Public Utilities generate 38,192 jobs for that billion dollars. Mass Transit creates 45,397 jobs which is more than 50% more jobs than the billion for missles generates.

But not all the budget goes for hardware. The Rapid Deployment Force created by President Carter and increased by Reagan is now a "Unified Command" and includes more than 290,000 troops. These troops include but are not limited to 3 Army Divisions, 3 Carrier Battle Groups, 2 Marine Smphibious Forces and 7 Tactical Fighter Wings. Hay Huevos Aqui!

In addition to our Rapid Deployment Force(read invasion army) we have 25,000 nuclear warheads and Reagan the decade. Since 1969 when President Nixon ordered a study of military options called NATIONAL SECURITY STUDY MEMORANDUM #3, the U.S. has pursued a policy of developing the capability for a nuclear first strike against the Soviet Union. This year we're spending almost 4 billion dollars on nuclear warhead production. Most of these will be aimed at the Soviet Union for a possible sneak attack. And people won-

If the Nuclear Freeze was approved we would stop the MX Missle, The B-1 Bomber, the Trident Missle, the Pershing II Missle and Cruise Missle Series almost immediately and save ourselves 15

Meanwhile, we have 150,000 tons of mustard gas and 15,000 tons of nerve gas stored away. Current spending on Chemical and Biological warfare is only billion dollars per year. Chicken feed! Next month, SPACE WARS, U.S. TROOPS






The purpose? Why to level the building and put in a parking lot for the posh restaurant Bill is planning to open on Market St.


The star of "I'm Running as Fast as I Can" has a brand-new spiffy look, and lots of publicity to go with it.

Venice Resident Vs. L.A.O.O.C.

Lord of the Rings

The metal art sculpture, "Roofin", by artist Charlie Nothing of Freedom California sits atop the Front Porch Gallery on West Washington Blvd in Venice.

John Curtis of Venice, operator of the Front Porch, says that this project was intended as a comemorative to Los Angeles, the forthcoming Olympics, and the Venice community. Curtis, representing the artist and the Gallery, recently offered to sell the piece outright to the Olympic Committee for an asking price of \$520,000. He simultaneously requested official Los Angeles Olympic Committee sanction to produce license, and market miniature replicas of the piece. The LAOOC declined either to purchase the piece or to sanction Curtis' plan to market his project.

But then, according to Curtis (he is also the chief spokesperson for Beyond Omega I.N.C., "a non profit association of Creative Spirits) the LAOOC went even further, demanding that Curtis remove the five linked circles prominent in the sculptures center, because, said LAOOC, they represented a copywrited Olympic symbol.

The Olympic Committee, it said, had full and exclusive rights to this symbol and would not agree to allow curtis and Beyond Omega to use it either in sale or promotion of such an item.


Curtis, who is active in the West Washington Blvd Merchants Association, doesn't feel very happy about this demand. He has filed suit in Superior Court, Santa Monica, requesting relief in the form of an injunction against LAOOC and Peter Ueberroth, the Committee's President, allowing Curtis to market his Roofin sculpture piece.



Supposedly, the School Board will receive \$30,000 for the rental.



35th Anniversary

On the organization's 35th anniversary the Board of Directors of the Pacifica Foundation celebrate three and a half decades of listener sponsored free speech radio. Chair of the board Jack O'Dell said "Pacifica must contribute to the change from liberalism to advanced democracy."

On April 15,1949, Pacifica's flagship station, KPFA in Berkeley, went on-air as the world's first listener sponsored radio station. Now in 1984, Pacifica stations serve 5 of the country's largest markets. Pacifica has established a Washington-based news bureau. The Pacifica Program Service distributes thousands of tapes to stations, schools and libraries, and the Pacifica Tape Archive containing 20,000 programs, serves as a repository for the history of non-commercial broadcasting in the U.S.




Salt of the Earth

The U.S. Bureau of Land Management denied a request March 16,1984 from Kerr-McGee(Karen Silkwood's former employer) for a reduction in the royalty rate currently being paid to the Federal Government on potassium products being produced from the Federal mineral estate at Kerr McGEE's Searles Lake Argus plant at Trona, California.

The depressed price of soda ash was Kerr McGee's reason for requesting the royalty reduction "below the statutory minimum, to a royalty rate that would provide the company a zero profit before taxes."

Kerr-McGee presently holds 5 potassium leases on about 8,000 acres of Federal mineral estate at Searles Lake and is the major producer on the lake. Under the lease terms royalties are paid on the gross value of the output of the leased deposits at the point of shipment to market. In 1982, Kerr-McGee paid \$6,597,023 in royalties to the U.S. Government.



Independence for Puerto? Rico Persecution Continues

On Tuesday, April 10, 1984, five Puerto Rican and Mexicano political activists must report to U.S. federal prisons to begin serving three-year sentences.

THEY HAVE COMMITTED NO CRIME.

The five, and four others who will be sentenced in April, are being jailed for refusing to give information to a federal grand jury in New York targeting the Puerto Rican liberation movement. THIS IS POLITICAL INTERNMENT - JAILING PEOPLE BECAUSE OF THEIR POLITICS.

Since the 1930's, on the island and on the mainland, Puerto Rican patriots and their supporters have been refusing to testify before U.S. grand juries as a matter of principle. Also in April, two other independentistas from the island, Federico Cintron and Carlos Noya, and two North American supporters of Puerto Rican independence, Shelley Miller of the New Movement in Solidarity with Puerto Rican Independence and Socialism and Silvia Baraldini of the May 19th Communist Organization, will be sentenced for "criminal contempt" of the same grand jury. Another North American, Pam Fadem of Austin, Texas, is facing trial on the same charge.



Rent Control

Governor vows to end rent control (reads Los Angeles Times headline) and two bills have been introduced into the Cal. legislature to accomplish this express goal. The two bills are: in the Senate, SB 2285 by Seymour (R) and in the Assembly, AB 3808 by Costa (D). These bills, with identical language, would virtually eliminate local rent controls. The bills would set up permanent vacancy decontrol. Any new tenant after the date of the bill would have no ceiling on the rent charged. There are other dangerous changes as well. (Imagine the harrassment to get out tenants if this is passed.)

This is all part of our gov's housing package with the rent control component written by housing industry leaders!



On the local front the L.A. city council has adopted an ordinance that will require tenants in an eviction dispute to put the rent into an escrow account. No hearing at all will be required, for example, as to the merits of the landlord's or tenant's case.

(Former ?) rent control backer Councilperson Joel Wachs was quoted as saying, "I think it is a good law."

This will especially hit tenants who have maintenance problems with their landlords and have withheld rent as a result (something the Tenant Center never advises), but which people do out of frustration and rage. Also affected will be those behind in the rent who need a little time to get it together.

Radioactive Wastes:

The dangers of nuclear energy do not begin or end at the reactor site. The nuclear industry mines, mills, enriches and ships radioactive materials, and attempts to dispose of lethal radioactive wastes.


Throughout the country, radioactive waste is rapidly piling up because there are no reprocessing or high level waste storage facilities for commercial reactors. There is no safe and comprehensive solution to the disposal of nuclear waste. Many cities and states now refuse to provide nuclear dumpsites or allow the transportation of any commercial radioactive wastes through their borders.

The wastes that would be produced at Diablo Canyon include such long-lived and extremely toxic elements as plutonium, strontium, and cesium.

Diablo Canyon is capable of producing 37 tons of nuclear waste materials annually. Such wastes must be isolated from any human contact for hundreds of thousands of years.


