

CLINTON CONTRA COCAINE

From the very beginning of Campaign '92, the media has tried to cram Bill Clinton down our throats as "front runner."

Things were looking pretty good for the political ambitions of Arkansas Governor Bill Clinton until Larry Nichols of the Arkansas Development and Finance Authority (ADFA) was fired by Clinton.

Nichols, long active in Contra circles, had done a stint in Honduras gathering data on Contra military potential, which he remitted to Washington as part of the propaganda package designed to persuade Congress to renew military aid. Upon his return to Arkansas, Clinton installed him at ADFA in 1988.

Part of Nichol's duties included the issuance of "Traveller" citations--a fairly routine honorific--to Adolpho Calero and General John Singlaub, two of the most notorious figures in the contra nexus.

Nichols was fired when a reporter asked Clinton with scrutiny about the appointment of a Contra veteran to the ADFA. Clinton's excuse for firing Nichols is that he made 700 unauthorized calls to Contras in Nicaragua.

The Arkansas Committee, a student organization at the University of Arkansas, has obtained Nichols' phone bill records from the ADFA under state Freedom of Information Act laws, and a spokesperson for this group says there are no calls to Central America during the short time that Nichols worked there.

Nichols is now suing Clinton for defamation of character, and it is interesting to note that in this lawsuit lies the source of the allegations of Clinton's sexual fling with Gennifer Flowers. She is now on the state payroll, and if Clinton got her the job, that could be it for his White House race.

But even if a Skull and Bones media whitewash with a Trilateral twist leaves Arkansas's "Teflon Prick"smelling like, well, Flowers, Clinton will not be able to wiggle free of the mucky mire of Mena.

Mena, Arkansas is where the majority of CIA/Contra/Cocaine activity took place during the Reagan/Bush years, while Clinton was Governor. Potentially the greatest political liability of Clinton is his association with Raymond "Buddy" Young, Clinton's chief of security at the Governor's Mansion.

On July 5, 1991, yet another lawsuit was filed, this one by a former CIA operative named Terry K. Reed and his wife Janice, against Buddy Young in the U.S. District Court Eastern District of Arkansas, which states that:

"Plaintiff Terry Reed owned an airplane, a Piper Turbo Arrow, N2982M, which he parked on March 12, 1983 at Mizzou Aviation at the Joplin Missouri municipal airport for repairs.

"Plaintiff Terry Reed was an "asset" of the FBI and the CIA between 1982 and 1987, and he worked occasionally out of Mena, Arkansas refitting aircraft and training pilots for the CIA.

"The CIA had a program known as "Project Donation" where people would permit their airplanes and other high value items such as boats to "disappear". They then could make an insurance claim for their "stolen" property. These airplanes and other items were to be used in covert operations of the CIA in Nicaragua at a time when the Boland Amendment severely reduced funding for the Nicaraguan conflict. CIA agent John Cathey told Terry Reed that this project was for indirect funding for the conflict. When the CIA was done with the airplane or other items, they



"In March, 1983, plaintiff Terry Reed was approached by John Cathey about allowing his airplane to be "donated" to the Nicaraguan indirect funding project, and the plaintiff refused. John Cathey was an alias of Oliver North."

Within two weeks of his refusal for the offer of what North as "Cathey" referred to as "loss brokering," Reed's plane was stolen anyway.

As a part-time flight instructor, Reed's stolen Piper was a business necessity, so he filed a \$33,000 claim. Sometime later, an old Air America buddy, William Cooper, called Reed and told him that his stolen Piper had actually been taken for Oliver North and Project Donation and would be returned soon.

Ballona Baloney "Selling" Playa Vista

With one of Jerry Snyder's companies in bankruptcy, (owner of the Channel Gateway project), one partner in prison (ex. Senator Allan Robbins), his realtor Mark Nathanson under criminal investigation, the Marina Place mall project dubbed in trouble by Culver City's mayor, and the Playa Vista developers laying off employees, it seems the recession and S & L scams have really hurt our local (over)development industry.

More and More I see that Venicians are incredibly lucky the Venice Town Council didn't settle their lawsuit against Marina Place 3 years ago while the economy was still booming, when the Prudential Insurance co. offered a tempting \$12 million "mittigation" fund to the group.

rains washed away some of the foundations. HAHA



The only thing being built at Channel Gateway is the 520-unit 6-story apartment complex, financed with City tax-exempt bonds to the tune of \$68 million. 108 of these apartments will be rented to folks with low or moderate

Meanwhile, bigger than all these guys is Playa Vista, waiting to awaken with L.A. City Mello-Roos bonds that will fund their start-up costs and putting in streets.

The Playa Vista developers also plan apartment complexes similar to that at Channel Gateway with small amounts of affordable units mixed in with the expensive units. They can also use LA City housing bonds for them.

Defeatist **Development Dogma**

...or How the Master of Ulan Bator is Jerking Off Venice

The Voice of Ulan Bator, the strangely-titled combination slow-growth and Mongolian culture journal published by Venice's Arnold Springer is out at stores and the library in Venice. Published with the \$200,000 he squeezed out of the developer of Channel Gateway, Springer's Voice devotes 6 articles to local developments. 3 defend Channel Gateway and 2 praise Playa Vista. Another on Playa Vista is more balanced, in that it acknowledges that the project still arouses strong opposition. This is slow growth? I have more questions and objections:

1. The promised results of the post card survey

and objections:

1. The promised results of the post card survey which Springer spent \$10,000 on asked Venicians' if they want to form their own city with Playa Vista, so Venice can "profit" from its development. This question seemed like a loser when tied to the pavement of the last natural open space left on the Westside. But what were the results? Since the Bator Voice only publishes twice a year, it'll be a long time 'til we find out.

2. Springer's subregional transport tax.. Springer's map of future rail lines contains all the controversial routes, such as down Lincoln Blvd., where it'll mainly serve Playa Vista and Channel Gateway, and the Exposition Blvd. route that cuts thru quiet neighborhoods. But it contains none of the most logical routes that won't disturb neighborhoods, such as running rail lines down the middle of the Marina and San Diego freeways. And what about Venice Blvd? Arnold Springer lives near that route. Could Arnold be a NIMBY (Not In MY BackYard—an epithet Could Arnold be a NIMBY (Not In MY BackYard—an epithet his group usually lobs at me) and that's why he excluded this route? Does a Venice Blvd. route compete with the shuttle bus that his buddies in COAST and the Venice Resources Corporation want to operate (and which they also seek funding for from the Channel Gateway developer?—all Ruth Galanter supporters by the way.) Another brilliant suggestion a few years ago of Galanter's was to run a rail down Sepulveda Blvd. thru residential areas in Westchester, so it could serve the Hughes Center and Westwood. Dumb planning! There will be no agreement on local rail lines as I see it until planners use

and Westwood. Dumb planning! There will be no agreement on local rail lines, as I see it, until planners use existing noisy freeways through L.A. for the routes.

3. Carol Fondiller's article seeks to guilt trip Venicians who she claims have fought "intelligent, sensitive development with light and air for the neighbors, that accomodates low income families". Now, which projects is she referring to? In five years of writing for the Beachhead I have yet to see one project that fits this description. Certainly not the Tony Bill Hotel, Tom Safran's 4-story mixed use monster, the Steve Blanchard wall of fast food joints or Rob Goodfader's restaurant/parking fast food joints or Bob Goodfader's restaurant/parking structure/and token affordable housing project. All these Ocean Front Walk projects have planned no "light and air for the neighbors", so what the hell is Carol Fondiller

talking about? Likewise at the Channel Gateway monstrosity on Lincoln Blvd. which paid the bills to print this pro-development rap, where is the light and air there? Preserving Venice as an affordable community is vitally important, but not if it overimpacts the community to get it. gain, this is an example of developers using low-income housing as a club to guilt trip overdeveloped communities into submission.

4. Saving for last, on Page 17, Springer explains how he got the \$200,000 from the Channel Gateway developer, by saying he opposed it after publicly supporting it, and using a legal loophole to extort the money from the developer. What he reveals though is interesting. But the Galeston had proscripted and the control of interesting. Ruth Galanter had negotiated a payoff to various interests in Venice of \$1.2 million from the Channel Gateway developer to fund various forms of traffic "mitigation". Springer's lawyer at the time, Debra Bowen, who is now running for State Assembly in the Westside's 53rd district, formed a non-profit corporation with Dell Chumley to spend \$200,000 of this "mitigation" fund on a shuttle bus system that they would run, and that Chumley could earn a salary of \$50,000 a year at. Springer reveals the hitch in all this: that Galanter's deal said that the \$1.2 million fund would only be paid after the entire condo, apartment and office project is built. Since the economy has slowed progress on Channel Gateway to a crawl, this means the payoff to several of Springer's and Galanter's friends might not arrive for 5, 10 years or never. That's basically why Springer had to threaten to sue and derail the project in 1990, so he could get his \$200,000 slush fund up front, whether the project was built or not.

The Voice of Ulan Bator is mostly disingenuous who is now running for State Assembly in the Westside's

The Voice of Ulan Bator is mostly disingenuous disinformation, using tainted money to masquerade as a protector of the community. When Springer made his deal with the developer in 1990, I expected he'd print something to benefit the community. What we get instead





The Democratic Process and the Roots of War.

I'm sure many people in Venice have seen the recently published "Voice of Ulan Bator". I remember a conversation I had with Arnold Springer its publisher at a Beachhead meeting in 1987 in the loft of the old Fox Theater where we used to meet. It was during Ruth Galanter's first run for office for the 6th District Council seat she now holds. We were talking about Summa Corporation, the somewhat behind the scenes mass developer of the Ballona Wetlands. Ruth Galanter, I saw you on television after the sentencing of Mark Olds, the man who stabbed you; you looked upset and angry and walked out of the building, refusing to talk to the camera man in the hall; who would be the control of the building. blame you. Why then don't you or won't you acknowledge our understanding that Summa's bribes to the Nixon campaign in the 60's were part of that which came from below us and behind us to slit our nineteen year old throats on the wheel of a lottery and then hung us out for the closed drive wheel of a lottery and then hung us out for the slow drain. Viet Nam isn't over for the same reasons that WWII isn't over - that Nicaragua and Panama aren't over. The roots of war lay hidden and uncovered beneathe the carnage of the "VICTORY?" Now it seems that it was all a mistake. Ruth is covering for Summa while they slither back to Las Vegas and now under the guise of Maguire-Thomas who by their own admission acknowledge they are some kind of managing general partner to still lurking Summa. Remember the Howard Hughes Center, the "other" project of the region, developed by one of Summa's many holding companies. How an obscure notice in an obscure realtor's newspaper called the "Daily Commerce", announced the proposed Plan Amendment and a public hearing where only three showed up - passed as the democratic process that the whole world is in awe of. And then how Pat Russell, with her campaign manager Curtis Rossiter as a hired consultant to Summa, quickly changed that parcel of property next to the San Diego freeway from Low Density Housing/Limited Industrial to <a href="https://doi.org/10.10/10.1

Lansford at a Ballona Wetlands walk-through where I went to solicit her opinion on a city wide referendum on the Ballona Wetlands to protect it. She did not like the idea as she said it could interfere with "The Friends" ongoing lawsuit which has been recently settled. She seemed nice enough if a little bit officious; probably all the stress of the

forgoing years.
As Rex Frankel explains: "They were more or less forced to settle this suit against the Coastal Comission and LA County which essentially was over the definition of what a wetland is. In 1979 the county intended 445 acres of Playa Vista as protected and unbuildable wetland. After generous campaign contributions and the election of Republican Deane Dana the amount of protected land was reduced to 97 acres. Instead of using the stricter US Fish reduced to 97 acres. Instead of using the stricter US Fish and Wildlife Service guidelines for determining a wetland in this suit - surprise - the looser Army Corps of Engineers standards as enforced by the Reagan-Bush Administrations were used. The Friends of the Ballona Wetlands feel lucky to increase preserved acreage to 270 from the 97. A strict interpretation of those Republican mandated guidelines could actually have only preserved THREE acres!" Amazing - another example of Republican favors for Summa; just like in the good of Nixon days. This settlement still however doesn't get to the heart of the matter.

the matter. This has been a subversion of the democratic process from the beginning and expropriations are due. If the DEA and police can sieze yachts and cars for the possession of one hempen cigarette, certainly we will not fail to seize the assets of a rogue corporation and fortune whose intentions and influence continue to be

misrepresented, and clearly threatens much more damage to ourselves and our communities than even kilos of cocaine. How a felonious corporate entity such as this one continues to operate here in America is anybody's observation at this point. Only inertia and apathy allow it to

Reed ran a manufacturing business out of Little Rock which furnished the CIA with materials, and he trained Contra pilots on a small airstrip outside of Mena, Arkansas some 82 miles south of Fort Smith. This little airstrip was the major hub of the Contra supply network and was also the main cocaine import depot of CIA-trained Contra pilots, whose leader was Adler Berriman "Barry" Seal.

Reed's business prospered in Little Rock and upon the advice of Oliver North he expanded his machine tool business into Mexico where he would have the financial blessing of US intelligence. Part of his responsibility would entail the furthering of Contra support channels by setting up a Mexican export company for North. Reed accepted and placed himself under the supervision of "Max Gomez," an alias of Felix Rodriguez, veteran of the Bay of Pigs, the Kennedy assasination, and the killing of Che Guevara.

Rodriguez was deeply implicated in the illegal efforts to supply the Contras. Through Donald Gregg, then Vice-President George Bush's National Security Adviser, Rodriguez maintained close links with Bush, thus giving evidence to accusations that Bush not only had knowledge of but was in fact actively involved in circumventing the Boland Amendment.

Reed and his family had been in Guadalajara for only a few months when on October 5, 1986 his friend Cooper was shot down over Nicaragua on an illicit C-123 arms run, killing pilots Cooper and Wallace Sawyer. Eugene Hasenfus survived and was captured by the Sandinistas.

This was the same plane in which CIA-asset Barry Seal smuggled tons of cocaine into and elicit Contra-bound weapons out of Mena, Arkansas.

After finding over a ton of cocaine in a large Southern Air Transport shipping container with his company's name on it in a hangar he had used for his machine tool business, Reed went to his boss, Max Gomez aka Felix Rodriguez, and told him he wanted out of the Mexico operation.

If only life were so simple!

Reed's solen plane was secretly returned to his hanger. Four counts of mail fraudi were thrown at Reed and aiding and abetting charges at his wife,

Janice. And, in his FBI file he was described as armed and dangerous.

Little Rock private investigator, Tommy L. Baker, testified that on October 8, 1987 he discovered their plane when he just happened to be passing by the hanger when just at that very moment the door blew open. But Baker told Harriet Barret of Barret Aviation at the North Little Rock Airport, where the plane was placed, that he was already working on a tip about the airplane.

When Arkansas Governor Bill Clinton's security chief, Buddy Young, turned the Reed case over to the FBI for further investigation, he told the Bureau that Reed might be involved in Central and South American drug trafficking. Young claimed the information about Reed came from the El Paso Intelligence Center (EPIC), a government operation staffed by representatives of every federal investigation and enforcement agency.

But EPIC had no file on Reed at the time. In June 1988, Young dictated his reports on the case and backdated them to October 1987.

In his ruling on the mail fraud case against the Reeds, U.S. District Court Judge Frank Theis said that both Young and Baker had showed a "reckless disregard for the truth" in their testimony.

In a succint retrospective summation, Reed paints a concise picture of the modus operandi of U.S. Central Intelligence: "Over a six year period -- from the time of my initial contact with these guys [Oliver North and Felix Rodriquez, et al.], until everything went to hell -- as we got in deeper and deeper, we realized that they are sort of building things around you. If they want to pull the plug, they can, which they did. You are the deniable link."

"When I pissed the guys off down in Mexico," he said, "they set out to burn me ... they set up this crime."

Indeed, many CIA assets are bit, sucked, chewed, swallowed, regurgitated, burned and shit on (eg., Noriega, Saddam, Oswald, etc.).

The Reeds went bankrupt trying to fight back, spending \$175,000 on two useless lawyers, and received the counsel of public defender Joe Dunlap. One the eve of the first trial date, Memorial Day,

1990, Dunlap's daughter's car was firebombed as it sat in his driveway. Three weeks later his wife's car was rammed in a seeming hit-and-run accident wher she said, "It was like he wanted to make sure he hit me."

In April 1990, the Reed's secret storage unit was broken into. Meticulous files dating back to the plane's disapperance and boxes of financial and personal records were stolen. Counsel and client have regularly encountered surveillance cars outside their homes and have suspected the monitoring of day-to-day communictaions since the case began.

On September 14, 1990, four days before one of Reed's court dates, Dunlap's car windows were smashed.

Finally, on November 12, 1990, Judge Theis, after being informed by the prosecution that there was insufficient evidence to continue, acquitted Reed.

Now, Reed is mad as hell and is suing the crap out of Bill Clinton's security chief, and from this suit loads and loads of dirt is being piled as high as all the chicken shit in Arkansas.

It is no coincidence that Bill Clinton is the establishment's "frontrunner." George Bush and his criminal clique are in trouble. The ongoing Congressional investigations can only be stonewalled by a Justice Department put in place to protect the criminal element at the highest levels of government.

CIA-asset Barry Seal (who was conveniently killed in Baton Rouge on February 19, 1986 -- just a few months before the Iran-Contra hearings) with his skillfully tranined network of Contra pilots smuggled hundreds of tons of cocaine into Mena, Arkansas. Their method worked well. They only flew at night. Off the coast of Louisiana there are oil platforms with helicopters hovering around the clock. The planes would drop to the same altitude as the helicopter and decelerate to under 200 knots with the plane lights turned off. Radar would not be able to distinguish the coke planes from the helicopters busily buzzing around the oil rigs.

The dope was then unloaded in Mena, Arkansas for later shipment to our nation's schoolchildren compliments of the "Education President." The planes were then reloaded with Contra weapons to be

airdropped at night in the same covert manner over Nicaragua.

Seal's smuggling operation was facilitated by his association with Freddie Hampton, who owned Rich Mountain Aviation, an aircraft repair shop at the Mena, Arkansas airport. Secret cargo doors and extra fuel tanks were added to Seal's planes and serial numbers on the plane tails were altered, all without Federal Aviation Administration approval.

In February 1984, Seal was convicted on Federal drug charges in Miami and handed a ten-year sentence, which he never served. It has been alleged that then-U.S. Attorney General Edwin Meese received a \$350,000 bribe to lay-off Barry Seal.

In March 1984, Seal began secretly working for the highly corrupt Drug Enforcement Agency (DEA), continuing his two-way smuggling operation out of Mena, Arkansas under the cloak of immunity granted him by U.S. government agents.

By `1985, the Arkansas State Police had begun investigating Seal's operations at Mena, and the IRS began looking into money laundering allegations involving local banks.

There are numerous reports of citings in the Ouachita forest (north of Mena) of people in camoflauge brandishing weapons, practicing river crossings, and conducting other military-type maneuvers. In fact, I remember receiving a letter from a friend who lived in that area in the early '80's. He said they wore sunglasses with their camoflauge. In 1990 Terry Reed gave an interview to Oklahoma City radio station KTOK. In it he states that he trained about 24 pilots who lived in secret barracks disguised as chicken houses in the Ouachita forest.

In 1985 a federal grand jury in Arkansas was empaneled to investigate drug smuggling investigations involving Seal and his associates at the Mena airport. Three years later, the grand jury was dismissed without handing down any indictments, fueling charges by state and local officials that the case had been deliberately mishandled by the U.S. Department of Justice, presided over, of course, by Edwin Meese.

"I have never seen a whitewash job like what has been executed in this case," said Rep. Bill Alexander (D-Ark.). "There has been a conspiracy of the grandest magnitude that has not been prosecuted."

Over the past year the Arkansas Committee has repeatedly contacted Bill Clinton to talk with him about the Mena situation and encourage him to take a stand on the issue. Clinton has refused to respond. Moreover, while police documents on Terry Reed's plane seisure were manufactured almost a year after the fact, key evidence in Reed's favor sat closeted in Arkansas Governor Bill Clinton's mansion long after it ended up in the federal court's possession.

There is also the matter of \$25,000 in State funds which Clinton said he authorized during the '80's to conduct a local prosecution of the Mena case. Joe Hardegree, who served as Polk County (host to Mena) Prosecuting Attorney in the '80's, along with Charles Black, his Deputy Prosecuting Attorney, said he never received the \$25,000, "nor did I hear anything concerning these State funds from [Tommy] Goodwin, [Director of the Arkansas State Police] or anyone in the Governor's office."

Black, who was compelled in 1988 to launch a State prosecution after a federal grand jury failed to

return any indictments hand-delivered a letter to Governor Clinton asking for his assistance. "I didn't hear anything back from him," he recalled.

Recently, Black stated that even if the \$25,000 had been made available, that amount "would have been like trying to put out a forest fire by spitting on it." An adequate investigation of Mena would have cost the State "at least \$1 Million," Black added.

Why would Clinton lie about the \$25,000 and block such an important investigation?

Mark Swaney, president of the Arkansas Comittee, says, "Clinton is either grossly negligent of law enforcement in his own state or he is actively involved in a cover-up."

It would behoove us then to consider with utmost caution the choices set before us in this year's presidential election.



Lastly, to restore Playa Vista's Ballona wetlands, Maguire-Thomas Partners expects to raise \$50 million from L.A. When the Summa Corp. retreated to Las Vegas to let their front men Maguire-Thomas Partners run the public relations show for their project, the LA Times coverage (March 23, 1989) said "Playa Vista Developers Win Friends", and said that unlike before, the new team has aroused "little anger or protest". This is an outright lie. They've settled with a few of their critics, but many more are waiting to be heard from.

The *Voice of Ulan Bator* was more blunt in its endorsement of Playa Vista, running 3 articles praising the project, only one of which quoted an opponent to it (Yours truly). Still, the developer's statements were printed mostly unchallenged in this developer-funded slowgrowth journal, an oxymoron if I ever heard one.

an oxymoron if I ever heard one.

To further the "nice guy" image of the new Playa Vista front men, the Ulan Bator journal quoted Doug Gardner, the project manager saying "We don't use a PR (public relations) firm". Well, they don't need one because the head of the firm, Nelson Rising, was Mayor Bradley's campaign manager twice, in 1982 and 1986. They practically own city hall, therefore they don't need an expensive PR firm to fool the public, since the public's opinion doesn't seem to matter to them.

Speaking of public opinion, the Times and Galanter

Speaking of public opinion, the Times and Galanter have praised the Maguire-Thomas team for asking the public what they want. The reality here is that opinions were asked for and then ignored. The developers chose the requests they could fulfill, mostly cosmetic changes, and still make the outlandish profits they seek. From the April 6, 1989 Argonaut, Nelson Rising said "We're not accept to be able to please eventheld we're it like to listen. going to be able to please everybody...we'd like to listen to the public, but they can't agree on what they want". What Bullshit! Since 1985, neighboring communities of Playa Vista have been united on what they want, which is a drastically reduced project that is compatible with its neighbors. But the L.A. Times' reporters seem to have forgetten the communities' stands, and now only quotes the head of the Friends of the Ballona Wetlands who has

endorsed the project.


The Wetlands group's chair, Ruth_Lansford, wrote in the Ulan Bator journal that "In Maguire-Thomas Partners

we have a supportive, ecologically enlightened landowner." This is only relative to Lansford's neighborhood of Playa del Rey. You see, to "save" the wetlands there, the developers will instead sacrifice the neighborhoods that live on the north, south and east end of the property. To the neighborhood groups living there, Mayor Bradley's buddy Nelson Rising has told these groups repeatedly that they are NIMBY's if they don't like the project. On June 23rd, 1989, Rising told the crowd at one of their "shows" that the era of single family homes on a quarter acre lot is "a thing of the past". If that's true, than Rising's a dinosaur as Rising lives in an exclusive neighborhhood of multi-acre multi-million dollar estates near Pasadena, far far away from the traffic disaster that he seeks to create here. That's the true definition of a he seeks to create here. That's the true definition of a NIMBY.

Nine months ago, Galanter accused me on the Outlook letters page of distorting my record on Playa Vista from 5 years ago, when I suggested she demand the project be scaled down dramatically and that parkland be increased to 70% of the site or 650 acres. In 1987 I and others asked Galanter to take a tough stand on Playa Vista at a meeting 3 nights before she was stabbed. The agreement she returned to us contained only cosmetic changes—shorter buildings, better jobs-housing balance, "more" parkland. She promised no specifics, and since the choice in the election was between Pat Russell who had opened their every wish, we had no choice but to support obeyed their every wish, we had no choice but to support

Galanter.

After 5 years of research, however, I've come to the same conclusion that two longtime Galanter employees, Joan Cory and Jim Bickhart, then community activists with the Venice Town Council, reached in September 1985: that density must be scaled back drastically. They testified to the City that only single family homes should be built east of Lincoln-not the dense apartment and condo complexes now planned; that 35% of the housing units should be affordable not 15%, and that much more of the site should be left as parkiand. that much more of the site should be left as parkland. Galanter's 1987 election literature proclaims she was an "active" Venice Town Council member; was she out of the loop when they took this stand?

I feel a more balanced Playa Vista should be 70% parkland, that only 2000 homes, apartments and condos should be built, and only 1 million square feet of office and retail space should be built. In a perfect world, of course,

I'd like to see the whole thing as a park. But in our world of lawyers and judges, we have to present an alternative that is economically viable. But since the 1000 acre Playa Vista property was assembled in the 1940's by Howard Hughes for an average of \$500 an acre, anything his estate's front men build is economically viable.

The 4 Versions of Playa Vista.

The project has changed 4 times, with the 1989 Version called "a major reduction" by Councilwoman Galanter in a December 6th, 1990 press release. The figures show that "major" is a nebulous word that means little to project neighbors who see a project reduced from disastrous to merely terrible

disastrous to merely terrible.

The Westchester News' editor, who was Pat Russell's press secretary at the time she was shilling for Playa Vista, in January of this year wrote that Playa Vista's new developers had scaled down their project's density "by nearly 30%". This is completely untrue.

Rather, all this has been a kind of good-cop, bad-cop shell game as, for each reduction, there's been an increase in something else.

The developer's have seen fit to up the affordable housing component from 9.5% to 15%, but since publicassisted financing is available, this is probably not at the graces of the developer, but the city. Project shills say there's been a 25% reduction in office space, but this too is a lie. The truth is office space has been reduced from

5.9 to 4.9 million square feet. The 25% reduction is based on them reducing totally new space from 3.9 to 2.9 million, but ignores their intention also to convert a low use aircraft plant that is 2 million square feet with the same area of office space. The hitch here is that industrial uses like the aircraft plant produce about 1/2 to 1/3rd the traffic that the replacement office space would create. The true reduction in office space therefore is about 16%. But the developers have jacked up the numbers of condos and apartments from 8837 to 13,085. So, they reduce one traffic generator by 16% and increase another by 50%.

their associates have spent at least \$1,700,000 to lubricate the political wheels in California. Unfortunately, I haven't found yet a local library that has 1990-thru '92 records. But what we know is that according to the State Fair Political what we know is that according to the State Fair Political Practices Commission reports, and the local City and County Clerks, from 1981 to '89, 13 of 15 LA City Councilmembers got at least \$32,000 from Playa Vista interests. Mayor Bradley got \$24,000. The five county supervisers got \$168,000 from 1980 to '85. California State legislators received \$832,000 in Summa Corp. campaign contributions from '81 to '87, plus were lavished another \$664,000 thru lobbyists expenses.

Ruth Galanter's legislative deputy Jim Bickhart is quoted in the Ulan Bator journal saying "We are compelled by legal circumstances to permit more development" at

by legal circumstances to permit more development" at Playa Vista. This is wrong. Only political circumstances cause this. And one can look at Galanter's campaign statements (revealed in the October '91 Beachhead) that showed Galanter's warchest came 90% outside of her district, with nearly every controversial developer, polluters etc. giving to keep her in office. The legalities of Playa Vista are very simple. The California Vested Rights law, and numerous court decisions all the way to the U.S. Supreme Court say that cities and the voters can restrict new development on virgin land to what the owner is now using the land for. Because Playa Vista has only been farmed, with a tiny portion used as an airplane factory, the developers only have a guaranteed right to have that aircraft plant, and a farm on the rest of the land. Their future plans are entirely controlled by the electorate. Since Mayor Bradley is buddy-buddy with the head of the new developers of Playa Vista, a substantial part of this

democratic process has been breached.

Another *Ulan Bator* journal article laments "if we could...repeal only those parts of the 5th amendment of the constitution that we don't like". This is a defeatist obfuscation. The fifth amendment to the U.S. Constitution obluscation. The lifth amendment to the U.S. Constitution says "...nor shall private property be taken for public use without just compensation". It doesn't say <u>future</u> private property or development. And developers have tried to apply this to decisions on major projects, but the courts have always ruled in the environment's favor. Compensation must only be paid when the government's action takes away an existing use that a longeruper has compensation must only be paid when the government's action takes away an existing use that a landowner has enjoyed on their property. But everything that the Playa—Vista developers—are asking for—is a—new—use. We don't have to pay them a cent if we don't approve their mega project, or any at all. That's why I've campaigned for a drastically reduced project, one that also leaves 70% of the land undeveloped, as parks, athletic fields, a botanical gardens, an urban forest and the wetlands. These same standards have been applied throughout Orange and standards have been applied throughout Orange and Ventura Counties, which are all subject to the same 5th amendment as Playa Vista.

Why the traffic plan won't work.

The just-published traffic study for Playa Vista makes the amazing claim that a full 1/4th of the 200,000 cars a day they attract will never leave their property. The "new" Playa Vista is billed as bringing "jobs and shopping within walking distance of homes", and will use transportation demand management program and with within walking distance of homes", and will use transportation demand management programs and shuttle buses to deal with the traffic, according to the Ulan Bator journal. But this was also a claim made for the 1979 and 85 versions, which Ruth Galanter claims in 1987 campaign literature to have been in "adamant opposition to". While the latest Playa Vista has a more even balance of jobs and housing opportunities, this doesn't solve traffic problems at all. "What we have tried to create is a community that, by its function and by its design, decreases dependency on the car", says Doug Gardner. So Prove it! So Prove it!

The problem is that they can't prove it, as everywhere their new project design "guru" has designed a similar project it has been at a fraction of Playa Vista's density or it's been built far away from traffic jammed urban areas. So, there is no comparison,

Designer Andre Duany creates communities with a grid system of streets, so one can get from one end to the other by zig-zagging thru the maze instead of jamming onto "collector streets". This is designed to mimic a small town, except that it's being shoe-horned into a dense urbanized area, unlike most successful small towns which urbanized area, unlike most successful small towns which are far from the big cities. The big difference is that this would be like no small town ever built before. There would be no houses, no front or back yards. There would be no neighborhood streets because under Duany's concepts 40% of traffic will now run on them. The grid pattern effectively destroys the whole neighborhood concept they claim will reduce traffic. All housing would be 3 to 6 story complexes, much like the Venice Rennaisance--at Rose and Main, or the Channel Gateway apartments at Lincoln and the Marina freeway. Duany's small town concept

reminds me a lot of Marina del Rey.

Duany's designs also are unproven in their claim to reduce traffic. While I've been told at the "shows" put on by Maguire-Thomas that what he designs are in dense urban areas back east, in Florida for example and are comparable to Playa Vista, articles in the American Planning Association's magazine "Planning" (May and December 1991) and in "Popular Science" (September

1989) show a great deal of differences.

Duany's showcase is "Seaside", which his associates have breathlessly told me is on the coast of Florida. What "Planning" revealed was this is on the gulf coast of Florida, far away from urban areas, and that Seaside has largely florighed as a second before Seaside has largely fluorished as a second home community for rich urbanites. The planned jobs didn't materialize. Another, "Avalon Park" is just outside of Orlando city limits. It includes 14,000 homes, and 5 1/2 million square feet of office/retail/industrial, numbers very close to our Playa Vista. The difference is that Avalon Park is being built on 5,800 acres.—6 times as much land as Playa Vista's 957 acres. There's no comparison. Another Duany design in Boston called Mashpee Commons is 30 acres and only 2 stories. Still, Duany's got no track recording to the structure traffic study that says 25% won't bit our -just a trust-me traffic study that says 25% won't hit our streets.

2 local cases show that balancing out development makes little difference, and that only by reducing the size can any difference be made. Channel Gateway like Playa Vista was also redesigned under Galanter to have a relative jobs/housing balance inside the project. Across Lincoln Blvd. from it are two shopping centers. Still, L.A. City's planners would only give it a 10% internal trip reduction credit from normal traffic fees.

Why does Playa Vista think they can do better? The reality is that so-called "growth management" is a fraud. The whole issue of balancing jobs and housing as a traffic and smog reduction method has been extensively studied by the South Coast Air Quality Management District (AQMD), a State agency, and the So-Calif Association of Governments. Their research says that even fall Southern Californians could find a job close to where they live, the total of Vehicle-Miles-Traveled (VMT) in the they live, the total of Vehicle-Miles-Traveled (VMT) in the LA basin could go down by 8.5%, reducing smog overall by only 5%.


After the SCAG/AQMD's findings of only 8.5%

traffic reduction were revealed in late 1988, the agencies rewrote their policies. A July 6, 1990 LA times article is more blunt. The chairman of the SCAG Growth management task force, Jon Mikels, a county superviser in San Bernardino pointed out "We've got Orange County in balance, and we still have a massive amount of

This is why the AQMD instead now requires all major employers and future developers to significantly reduce their traffic creation. Unfortunately, what Maguire-Thomas wants is to build to the max, then they'll employ the "trust us" method of reducing traffic after they've built everything. This is a dangerous approach. Only thru reduced density can any difference be made.

The expansion has raised Culver City's semi-




The expansion has raised Culver City's semiannual sewer bill from \$2.2 to \$3.4 million. Other

in a previous life, I don't know.






