Sups Drop Act on ACT UP/L.A.

After months of investigation and literally hundreds of hours of surveillance by the Los Angeles County Sheriff's department, the Los Angeles City Attorney has dropped misdemeanor vandalism charges against ACT/LA members John Fall, Mark Kostopolis and myself. The Sheriff's department, acting under pressure from the County Board of Supervisors, accumulated a case file twice the size of what is prepared in the average felony murder case according to Marilee Marshall attorney for the defendants.

The Board of Supervisors were outraged when graffit1 appeared on County buildings last Spring criticizing the Boards refusal to respond to the needs of people with AIDS at County USC hospital. The Supervisors demanded that the Sheriff's find someone to prosecute for the graffiti. While people are dying of AIDS, more tax payers

money was spent investigating these charges than was spent on the entire cleanup of the graffiti.

Using video tages of ACT UP demonstrations and press tonferences, tounty maintenance workers were urged to identify someone in the tages to charge with the graffiti. This type of identification violates any acceptable standards of police tonduct.

The workers could have been shown photographs, which the sheriffs had in their files, of the suspects and other selected photos. Instead, the workers were shown videos of ACT/UP members engaged in free speech. In each case, the people most vocal in the video tapes were the people the witnesses chose to identify as the perpetrators.

We began our battle with the county Board of Supervisors

over a year ago because. although most major cities in the nation had AIDS wards. LA did not. Patients were left in wheel chairs in the hallways waiting for rooms. Under pressure from ACTUP/LA and other community groups. the hospital was finally forced to open an AIDS ward which is still not fully utilized because the hospital has not staffed it with enough nurses.

Venice residents helped to raise money for our defense totalling over \$1400.00.I want to take this chance to thank all the people who gave of their time and money to helo us. I can also state at this time that I was not even in the United states at the time the events I was charged with took place. I was in Canada for three weeks of dental surgery. Faced with charges asking for

\$25.000.00 in restitution fines and possible jail sentences. I could not talk about my defense before.

In collusion with the Sheriffs' Department, the County Board of Supervisors have forced the Sheriffs' Department to spend thousands of dollars to threaten activists critical of their policies at a time when health care cutbacks, social service cutbacks, and the problems of the poor, the unemployed, and the homeless combined with escalating crime are threatening to paralyze the County.

It is time for the Supervisors to start spending money solving the problems of the County instead of using that money to attack citizens critical of the Board.

hurting minority opportunities. At the same time, the two rich businessmen also served as "underprivileged" minority partners for contracts the city awarded at its airport that netted these two. along with other rich Bradley associates, six-figure salaries for no work. (See last months Beachhead--F.1)

"Public confidence in press dips sharply, surveys find." Times-11/16/89---showed that credibility of daily newspapers' has dipped 35% among regular readers, second only to the credibility lapse of Geraldo Rivera, who 74% of Americans don't believe. Yet The Times still ignores home. Though largely ignored by L.A.'s mainstream press, a Herald-Examiner columnist revealed that the L.A. Times sat on the Tom Bradley Finance Scandal, knew about it in August 1988 then saved it for after Bradley's April '89 re-election. But at the same time this coverup occurred. the Times ran a slew of front-page stories detailing no illegal acts, only "alleged racism" based on cynical memos stolen from political consultants to Bradley s chief enemy, semi-environmentalist Zev Yaroslavsky, which destroyed his challenge to the 16-year mayor, Ignored was the fact that the consultants had previously worked for Bradley.

Dear Beachhead Collective:

The following letter was sent to Councilwoman Ruth Galanter from the North Venice Boulevard Neighborhood Association:

Dear Councilwoman Galanter:

We appreciate that you met with representatives of the North Venice Boulevard Neighborhood Association November 16th regarding Werner Scharff's application to build a new parking structure for Rebecca's Restaurant and an art gallery on North Venice Boulevard west of Pacific Avenue. So much time was spent in our defending the merits of the 1983 conditions for Rebecca's that little time was left to discuss the Board of Zoning Appeals' ("BZA") findings that support the BZA's decision to deny a permit for this project:

- The current application which would delete the 1983 condition regarding Rebecca's garbage "does not comply with the Board's intent to protect adjacent residential uses from negative impacts of trash storage and collection activities."

- Granting the current application "condones" the "applicant's lack of compliance" with the 1983 conditions for trash and drainage which the BZA "imposed to protect adjacent residential properties."

- "there are no hardships which prohibit or hinder the project from complying with the 30 foot height limit,...setback requirements, lot and separation requirements" of the Venice Interim Control Ordinance ("ICO").

- "The hardships described by the

- "The hardships described by the applicant are self imposed by the applicant's design of the project."

- The project is not consistent with the State Coastal Commission development guidelines for North Venice.

- "The proposed development <u>will</u> prejudice the ability of the City of Los Angeles to prepare a Local Coastal Program."

One of your campaign promises was "to listen" to your constituents. The BZA members not only listened to your constituents, but also supported them. Why are these appointed officials more prone to protect the interests of your constituents than you are?

So far you have always supported this project, which has required you to support Werner Scharff's applications for:

- a zone change from residential to

commercial;

a Community Plan amendment from residential to commercial; and
2 ICO Hardship Exemptions ("HEXes").

One of these HEXes has already been overturned by a Zoning Administrator because the triplex apartment that has to be moved out of our neighborhood to make room for this commercial project would not fit on the lot proposed for it. This is an example of yet another City official supporting your constituents by overturning the HEX you approved.

The other HEX allows this project to exceed the Venice ICO 30-foot height maximum and 2-lot maximum for lot consolidation. The BZA findings support enforcing the ICO. It is exasperating that you do not support your own ICO! Our future Local Coastal Program development guidelines will be meaningless if you give them the same respect you give the ICO guidelines.

A BZA member stated this project is a good <u>business</u> decision for the owner, but questioned if it is a good <u>zoning</u> decision to intensify an area that is already so congested. We look forward to hearing that you have changed your mind and will actively support the BZA decision, the residents, your own ICO guidelines, and a return to the residential zoning the City provided for this block in 1973 to protect public access to the beach. Please respond as soon as possible.


