Q #3: Can you guess how the Times stacked this paltry print of letters?



# The Black Male as an Endangered Species

By Michael T. Jackson (The following speech was delivered at L.A. Harbor College on April 17,1991)

Imagine that you are sitting at home. Ferson or persons unknown to you break down the door and shoot your father, who has been retired for 4 years. Your mom is injected with some kind of substance and gets cancer. Your brother is taken away, and not allowed to return for 20 years. Your sister's newborn child dies and another brother, on seeing this, kills himself. If persons unknown were to do this, without a doubt you would gather the posse and ride. You'd be like Ice T talkin' about "this is personal". Wake up! This is no fantasy. This is happening and it's happening now! We black men are rapidly becoming an endan-

gered species.

The Î.A. Times of April 9 cites a report from the Department of Health and Human Services, our life expectancy of 69.2 years is the lowest in the nation. This is barely more than 4 years past t the mandatory retirement age. It is a full 6 years less than whites, whose life expectancy is 75.2 years. Over 50% of all black men age 18-24 are under the control of the criminal justice system. This means on probation, in jail or on parole. The infant mortality rate for whites is 9.1 per 1000, ours is 18 per 1000. This may not sound like much, but multiplied by 100 or 1000, the result is horrifying. The suicide rate of black men age 18-24 is among the highest in the country. Our cancer rate is 6 to 10% higher than that of whites. Worse yet, the leading cause of death among blacks in America is homicide. More than cancer more than heart attacks or strokes. We die violent deaths more often than any one else.

We died, manacled and malnourished, as cargo on slave ships. loss of life is estimated in the hundreds of thousand We were lynchedwhen we tried to gain our freedom, when we tried to protect our 40 acres and our mule, when we walked tall and proud down the street. We know this, it's part of American history! There have been some changes, the fact that we are here shows change. The fact that we are in a college. The fact that we are in a college. The fact that we are sitting here with brown, yellow, red and

white students and faculty shows some change. But there has not been enough change. And yet we are learning.

If we have learned nothing else, we must now learn that the government, the "power structure" and the People-in-Charge will be of little or no help to us. When President Chamorro of Nicargaus asks the congress for 10 years of aid & loans, how could they not ? When Kurds are dying at a rate over over a thousand per day and need help, how could they not ? When we need assistance, Federal equality bills are being vetood. 'Social programs covering many areas are being cut; how could they ? It is becoming moré and more difficult to get an education. There are now teachers protesting in Los Angeles over cuts in the education budget. We cannot count on help. We must help ourselves. We must improve the education system in America. Because we live in a Eurocentric society, that is the slant of our education. There have been many contributions by many peoples that have gone into the making of America. Plack American history must be taught, and at an early age. When we teach children about the Boston Massalso them about teach Crispus Attucks. The strides we have made in the arts are more readily seen than those in any other disciple but the major contributions by Black Americans in the sciences and medecine must now become common knowledge. The name of Charles R. Drew must have the same kind recognition as the name of Edward K. "Duke" Ellington. We must learn!

Crime is not exclusive to the black community, in spite of what you are told by the media. It is everywhere. But as I've already mentioned, the leading cause of death is bomicide. Host often at the hands of another Black. This is too sad for words. It is scandalous! Nearly every day we hear of another gang related killing, and many of these are young children; innocent bystanders. Every time one of these kids dies, gangmember and non-gangmember alike, we lose . We lose another potential Doctor, or Judge. We lose another potential civic leader. Getting shot down behind some colors is not a glamourous or heroic way to die for the hood. It is senseless violence, nothing more. What is the cause of the problem ? Clearly there are several factors, but at the top of any list, the reason could be drugs. Casual drug use as well as drug abuse, touches every community and every race. Once again, this is a problem that is not exclusive to the Black community, but for what-ever reasons, on our community the effects are catastrophic. It causes health problems, most often for those with no access to health care. Drugs contribute to our high infant mortality rate. Those babies that are born, and who survive drug withdrawl, are left with severe disabilities which we must deal with. Drugs are making far too many prople uneducable and therefore unemployable. Many turn to stealing to get money for drugs. Some get drugs for money. When money is needed, and we all need that kind of green to get by, some people will do anything to get it; this includes "slingin' the rock" to little kids. Anything to get "mo' money, mo' money, mo'money". Reports tell us that gangs sell drugs to finance their activities as well as buy Nike, Polo, and much gold! This kind of "new Jack" economic system cannot work. It is a drain on us all. We must stage our own "Boxer Rebellion" and throw the oppressors who bring these drugs out. When left to the Govenrment, it only means more of our young men "down by law", and there's still a drug problem. These young men are only a part of the picture. Does anyone really believe that Cuz and Blood are driving down to Peru to pick up some flake and then rockin' it up when they get back to the hood? If so, wake up and find out what time it is. We have to do more than "just say no" before it is too

Many people on many different sides are saying we face these problems because we have no unity. And that we have no unity because we have no leader But if you really think about it, we have pretty much the same leaders now, in Jesse Jackson and Jouis Farrakhan in Jesse Jackson and routs ratrantant as we did some 30 years ago with Dr. King and Malcolm X. And there are other men and women, committed to positive change in the Black community. But more need to become involved. By being college students, many of us have come



# W.C. Liedtke; Co-Founder of Pennzoil

HOUSTON William C. Liedtke Jr., former business partner of President Bush who co-founded Penuzoil Co. and helped turn it into one of the nation's largest oil companies, has died of cancer at

Liedtke and his brother, Hugh, got their start in the oil business after serving as naval officers in the South Pacific during World War H. In the mid-1950s, they teamed up with then-oilman George Bush and John K. Overbey to form Zapata Petroleum Co.

Bush and his wife, Barbara, "are deeply saddened at the loss of our very dear and close friend," they said Saturday in a statement.

In 1960, the brothers began a cooperative drilling program with South Penn Oil Co. and set up Stetco Petroleum, of which Liedtke was president. In 1963, Zapata Petroleum and Steteo merged with South Penn, which was soon renamed Pennzoil after its nationally known lube oil trade-

Liedtke served as president of Pennzoil from 1967 to 1977, when he became chairman and chief executive officer of Pog ). Pennzoil is the nation's 14th-largest oil company.

John A. McCone, who helped form the Central Intelligence. Agency and served as its director during the Cuban missile crisis in 1962, has died at his home in Pebble Beach. He was 89.

In the mid 1970s, a Senate investigation showed that the CIA during McCone's tenure had carried on the illegal surveillance of more than 10,000 U.S. citizens and had tried to assassinate foreign leaders. including Cuban President Fidel Castro and Patrice Lumomba in




This is an infra-red satellite photo of the L.A. Basin. Black areas are undeveloped land. White areas are pavement or buildings.




Major Regional Wildlife Movement Patterns

# Archidyne--The Bio-Climactic House by Jacques Rameau

by Mark Giacomelli

There is not a "solution type" for the house in regards to qualities of the site local climatic charachteristics, needs of the family, etc...The house we are proposing despite its frozen appearance, has only as "fixed", the principles of adadaptation to the neccesities of a bio-climatic habitat.

#### 1-THE PRINCIPLES

Four principle ideas are exploited:

- The Climate: profiting from or protecting against.
  - North-south orientation: allowes for passive solar captaton. Temperate climatic aggressions such as northern winds for example are out of the way rather than confronted by virtue of its "pyramid-like" aero-dynamic design.
  - Extereior spaces are sheltered in the summer and sunny in the winter. Use of wind energy is no problem.
- 2) Intermediate spaces
  - Cold rooms such as the garage, and overheated rooms like the kitchen for example are on the north.
  - The greenhouse is on the south.
- 3) Thermal enertial confinement
  - The north end of the house is underground and the east and west ends are burried partially.
  - A thermal mass fills any empty ai space under the house and diffuses cool air from under ground in the summer, while supplying heat from the static captors on the south in the winter.
  - The thermal wall:
  - a) captures heat by radiance
  - b) receives annexed heat sources (stove ventilator, hot water tank, chimney, etc...)
  - c) diffuses heat (in connection with the thermal mass)
- 4) Individual and family life

The principle of organization chosen allowes us to orient the surfaces on one central place (the transparancy of the glass cased wall and greenhouse is a symbol of community and expresses family life) thus fractioning the surfaces, promoting the most favorable conditions for particular activities or individualized isolation.

# II-THE ORGANIZATION PRINCIPLES OF THE HOUSE


a) The Volume


The house's volume is cubicle and implanted on a square, whose angles are oriented following the cardinal directions. The cube is divided by two surfaces, defined by the eastwest diagonal of the upper square of the cube and with the lower, or ground surface, extending from the southern angles of the square.

- The inclined angle of the house (commencing from the lower north angle) is perpendicular to the noon day sun of winter.
- The inclined surfaces (of 160 M2) are composed of a glass wall and a roof where active solar energy can be captured to heat water and air as well as producing electricity. (The total space useful is more than adequate: 42 M2 on the south.
- b) The implantation

The natural level of ground soil corresponds to that of the veranda. The soil removed for the implantation and swimming pool is used to cover the northern end of the house. The possibilities of access to the house (in function with the needs of the building site) are multiple:

a review





- The principle access can either be from the ground floor or upstairs.
- Entrance to the garage, integrated with the house, can be on virtually any end of the house the same as the principle ground floor entrance (N.E., N.W., S.E., or S.W.).
- c) The windows

The bays are exceptionally large (50 M2). However, the insulation is good owing to its square and cubicle design, so you have more volume for surface area.

The bays are diversified. The glass cased wall insures the general lighting of most rooms, either through the veranda, or directly through the exterior (ventilation is achieved in the same way). The smaller complete the ventilation and lighting on the sides facing the sunrise and sunset.

d) The organization of living spaces

The house has two floors. The rooms are organized on one common space whose symbols are the glass case and veranda. They permit an upstairs view from the ground floor without decreasing the surface as would normally occure in the case of the classic two story. Neither is there excessive volume, difficult to heat. At the same time there is no reason for the bedrooms and playroom to be out of view of the livingroom and kitchen either.

effect of space and movement. To balance the treatment of the organization of the house, parts of the livingroom and bedrooms are disjointed and have a sunken corner, enabling individual solitude. The intermediate spaces are obtained by arranging the rooms with respect to their thermal needs, relative to the areas more naturally warm or cool. So the garage is on the north end where heat loss is most frequent. The corridors are upstairs. The entrance and bathrooms, more cool and ventilated are at the north-east section. The usually overheated kitchen is on the north-east end protecting the living areas from the cool zones in winter. The veranda is on the south to beat the winter. Its role has the effect of a greenhouse and an intermediate space at night. In summer it can be part of the livingroom.

A livable airspace under the roof, protecting the bedroms from temperate extremes, can be converted into two additional rooms.

Contributing to the best diffusion of heat throughout the house, is the shifted floor, forming a sort of spiral, forcing the rising air to sweep across the entire volume of the house.

### III-THE PRODUCTION OF PASSIVE HEAT

a) At the south, the veranda is a supplimentary place given to the house. It is developed on one and a half of the levels of the house. There are 40 CM of soil in the veranda allowing for humidification as well as plant life. And a good dose of light comes through window.

The veranda has three functions in the winter:

- At night it insulates the house (equivalent to a triple window).
- 2) In the day it transforms light into heat (supplying calorific energy).
- Its ground constitutes an additional thermal mass.

In summer it can remain permanently opened to the livingroom, thus eliminating the greenhouse effect. The windows and doors of the veranda will allow an increased ventilation of the house. Finally, in order to prevent overheating, a pentroof is installed on the inclined window to block off the summer's direct sunlight at noontime. This eliminates the need for permanent use of shutters which are installed on the glass wall.

#### b) The static captors

There are three in number: 1) The veranda, previously explained.

2) The thermal wall

- The living areas on both floors benefit directly from the wall. The bedrooms maintain their temperature by the common rooms (and are placed upstairs where warm air is accumulated).

In a central position , it receives sunlight in the winter (in the summer, the sun is in too much of a verticle position to reach the wall so there is never the problem of overheating).

The calorific energy supply is completed by gathering the complimentary heat sources (chimney) or annexes (stove ventilator fan, hot water tank, etc...) into the wall. Finally, the wall is a conductor of calorific energy supplies of the thermal mass between the house and ground. (A chimney in the central junction completes the system)

3) The static captor It is installed in the optimum slope of the glass wall in front of the greenhouse up to the base of the window. In the summer, it must be insulated from the thermal mass under the house.

#### IV - The Thermal Masses

They allow stablization of temperatures (with diurnal, nocturnal, daily and seasonal variations). They are created in a classical way by nall the walls and floors and completed by:

- the thermal wall:

19.8 M3

- the static captor:

27.6 M3

- the greenhouse: 03.3 M3

- the thermal mass under the 70.00 M3 house:

It is a rock mass between the house and ground instead of an empty air space. It benefits from the calorific energy supplies of the static captors in winter, and in summer from the cool and constant temperatures underground (at approximately -2.5 M).

## Calorific conduction is realized:

- statically by contact with filling material and with supply surfaces (underground and static captor)
- by air space between rocks
- by the static movement of warm and cool air. The air vents would be installed in the proximity of the captor.
- in winter and at night, the air would be swept along the ca and thermal wall, and thus warmed before reaching the living areas. Stale or foul air would be evacuated through the ceiling (after having risen up the spiraling floors).
- In the summer, the air is cooled from underground when crossing the thermal mass and evacuated by the ceiling.
- It can be substantially improved by installing an air circulation system in the house. In this case, the winter time air should be evacuated by the cool zones of the house: across the greenhouse or the garage (a curtain of air is created) so the heat of the used air is conserved.

This optional arrangement, requiring limited manipulation, permits the most positive thermal conditions.

of course, no serious study can be made except on a real site. Grouping possibilities are multiple:

- The smaller and larger houses are based on the size of five rooms, with the possibility of modification. They can be troncated or enlarged with excreascences.
- The studied arrangements allow the homes to be placed in allignment on a street or in a " v" shaped alignment, in a star shape with playgrounds and courtyards etc... without limiting the sunlight or its minimum bio-climatic effect.
- The materials utilized can be adapted to the region or the particular tastes of the inhabitants. The system of construction can vary according to the enterprise, since it is on a classic frame in which the walls support or fill in (the frame is  $5M \times 5M$ ). The roofs are made of slate but can also be made of red tile etc..

### a) The framework

- The central pillar and floors are in concrete. The walls are made of parpen. The insulation (9 MM) is on the exterior. The outside walls are in brick.
- The framework is glued lamella or nailed carpentry, with a maximum of 7M between points of support. It is covered with slate.

#### b) The finishing work

- The bays on the outside are closed by double windows (except along the greenhouse where there are three windows). The venetien blinds on the exterior windows have been taken into consideration.

The joinery of the glass walls are in wood. The rest are in aluminum.

# Opportunism, Anyone?

I went to the well-attended May 9th Venice Town Council meeting at the Old Venice City Hall building. Counting myself, there were 13 people there. They talked of raising \$3000 to \$5000 to hire a 2nd attorney to help with their Marina Place lawsuit if the money isn't raised, the later with the proof of the later with the the lawsuit may die. That is-the VTC's. You see, a twin group called COAST has a near-identical lawsuit to the VTC's against the mall. Several members of the current VTC's board of directors are also on the COAST board of directors. The difference is that COAST meets in private, not in the open like the VTC, and also, like the current VTC, nearly every member of its Board of directors is also on Councilwoman Ruth Galanter's re-election committee. The VTC's lawsuit may soon become an entirely private affair-up to COAST to fight or settle as they wish. Now, maybe that would be good for the VTC. It could return to being a forum for all of Venice rather than just a political

Judging from the letters page of the Outlook, Argonaut and L.A. Times, several of the COAST/VTC's leaders are also the most vocal supporters and defenders of the Channel Gateway and Playa Vista developments, next to the developers themselves. Galanter in the Times called the redesigned Playa Vista "a model of environmental and community sensitivity". Its size has environmental and community sensitivity". Its size has changed little, merely the contents rearranged. Two COAST board members, Terry Conner and Paul Doebler, have been awarded columns in the Argonaut, at times defending Channel Gateway, Playa Vista, and "property rights" in general. The fact that Marina Place is in Culver City, while Playa Vista and Channel Gateway are under L.A. City control, leads local critics to dub COAST the Citizens Organized Against Someone-else's Traffic.

The current Galanter VTC board ran the proparization from early 1988 to the summer of 1989, when

organization from early 1988 to the summer of 1989, when anti-development and pro-cityhood Venicians with strong ties to the Beachhead became the majority and elected their own board. After a year, a development recession in full bloom, most of the board dropped back to their own organizations, and the Galanter re-election committee again took over the VTC in October of 1990. One of the first changes the new board proposed, courtesy of expresident Dell Chumley, was to ask the membership to change bylaws to keep much of the new board in office for two years, instead of the current one year rule. The seven members who showed up in the March meeting voted that idea down. Hooray for local heroes!

The Beachhead's falling out with the VTC began in March of 1989. We found ourselves in the middle of a brewing political battle, though just the opposite of what we would have expected. Community politics had been split between the leave-Venice-like-it-is side, represented since 1973 by the Venice Town Council (VTC), and the pursuers of yuppiedom, the realtor-developer dominated Venice Action Committee (VAC), successors to a history of pro-development committees formed by big Venice

property owners. The Beachhead had entered into a joint printing deal with the VTC in November of 1988 to include the VTC Voice as a 4-page pull-out section. (We'd always been sister organizations) The VTC's membership had in September of 1988 re-elected its board of directors (the Galanter faction) and then voted to file a lawsuit to halt the Galanter faction) and then voted to file a lawsuit to halt the building of the Marina Place shopping mall, located at Lincoln and Washington Blvds., actually in Culver City. While opponents of the VTC leadership, members of VAC, were also nominated by VTC members, none of their names appeared on the ballot, and the Galanter faction again swept the board. The reason given by Barbara Palivos, a board member and now VTC president, was to keep the VAC from taking over the VTC. Actually, virtually any group could "take over" the VTC as membership was only \$15 compared to the VAC's annual dues of \$150.

The VAC, formed in 1986, described their utopian,

The VAC, formed in 1986, described their utopian, greened and trafffic-less "vision of the future" in a two-page flyer. Venice's poor would be protected, they said, not uprooted in the VAC's planned "improving" of Venice. (VAC's founders own properties on Kinney Blvd. and Main

"...In the year 2000, a low income family is raising their children in a house which they have rehabilitated under the new low-interest homeowner improvement program which is funded by new commercial development projects in

Venice residents "don't need to drive--their shuttle pass takes them everywhere they need to go...The beaches are more beautiful now because the parking and traffic have been removed to satellite locations east of Lincoln Blvd...In the year 2000, a family drives to Venice from central L.A. for a day at the beach. Nearing Venice they tune in to their car radio for parking instructions which tell them available...'

This "vision" was pure Reaganomics. Basically, they said let developers go crazy, they'll make lots of money and give a fraction of it back in well-publicized token amounts of affordable apartments, \$5 parking spaces and a shuttle bus to move residents around the traffic jams created by the VAC leaders' developments.

Now the irony. In March of 1989, the anti-Marina Place lawsuit was doing well. The City of L.A. at Councilwoman Ruth Galanter's and Mayor Bradley's request had decided to join the suit, providing legal help and paying for expensive paperwork. The big court hearing was in late April.

But, wonder of wonders, the VTC's leaders, Dell Chumley, Arnold Springer and Challis MacPherson brought us a full page ad to appear as part of the April VTC Voice. The ad seemed to urge VTC members to give up and settle the lawsuit with the developer. The amount offered by the developer, \$12 million, was unprecedented. Never before had the life or death of the Venice community been given a dollar value. And strangely, the Town Council's members would have a single, 2-hour meeting to decide yes or no.

The wording of the settlement ad sounded fishyand the money to pay for it even more so. You see, the VTC board took \$250 from the mall developer, Prudential Insurance Co., to print the ad. The Beachhead staff voted, and refused to print the ad. After several contentious meetings between our two crouse, the adward changed to meetings between our two groups, the ad was changed to a simple Yes or No. The VTC board still insisted, and we relented, on printing a so-called "impartial" article discussing the settlement offer, written by Attorney Debra Bowen and Arnold Springer. But the article contained curious reasoning, which seemed to argue for taking the

money, rather than try to win the lawsuit:

"...there could be a significant disadvantage in forcing the project to another site. The ambitious programs envisioned by the settlement offer—housing, neighborhood protection, enhanced coastal access and beautification-may not be realized if the regional shopping mall goes to Villa Marina or the Playa Vista site."

A good question is does Venice need these ambitious programs and do they compensate for the mall's horrific traffic and smog impacts? The truth we learned later was that if the monster mall had moved elsewhere, various VTC board members would not be able to the training or the money. to stake their claim on the money.

The \$12 million's proposed use sounded noble enough: \$7 million for traffic "improvements" and \$5 million as an affordable housing trust fund. The problem soon discovered was that these traffic improvements would not erase at all the mall's horrendous traffic, just make it a fraction less horrendous, and they would take away onstreet parking for local small businesses. The real traffic "improvement" would be a new beach shuttle service, which would ferry beachgoers from parking lots at public schools east of Lincoln Blyd. thru a mile and a half of traffic jams to the beach. And how the housing fund would be

spent was a big question mark.

Does this sound at all familiar to the VAC's version

of Venice salvation?

But a few facts had been left out of the picture. did\_much of the VTC's membership know that several VTC board members who had brokered the \$12 million offer also planned to set up their own "non-profit" corporations independent of the VTC membership's control to help spend these developer payoffs. Chumley and Bowen hoped to operate a beach shuttle service, through their newly created Venice Resources Corporation, with Chumley getting a salary from \$25,000 to \$50,000 a year. As it turns out, the Channel Gateway project also set aside \$200,000 to run a beach shuttle service. So far, Chumley's group is the only one seeking to operate such a system. Arnold Springer would soon win a \$450,000 payout from the developer of the Channel Gateway project, which Springer says will be spent on community improvements through his newly-created Ulan Bator Foundation. Springer will also earn \$5000 a year for

the privilege of spending developer Jerry Snyder's money.

The VTC's membership agreed that the settlement was not a good deal and voted 68 to 2 to reject the rushed settlement. And contrary to the rejected Springer/Chumley ad, to this day the "long fight" continues, the suit is still alive, waiting for a court date in late 1991, and the developers have not sought to instead build the mall elsewhere in the "immediate area".

The VTC membership the next month rebelled against its Board of directors, approving a policy asking Ruth Galanter for a 1 year hold on new commercial development so the city of L.A. could study the capacity of Venice's streets, water and sewer systems to handle new development. It wasn't an unreasonable request, as next door cities Santa Monica and Culver City are right now

doing the same thing.

Galanter and her VTC Board opposed this slow growth measure. In a letter sent to the Outlook by Galanter and printed June 14, 1989, she opposed the 1 year commercial development halt, calling it "illegal", and went on to apparently admit that she supported the \$12 million settlement which the VTC membership rejected. Her letter said Venice activists have mistaken "the VTC's rejection of the Marina Place lawsuit settlement offer for lecitimate the Marina Place lawsuit settlement offer for legitimate planning." Galanter inferred that not taking the money and the mall was somehow illegitimate. The truth is that Galanter and her supporters were buttering their bread on both sides, becoming power brokers.

both sides, becoming power brokers.

As it turns out, in the list of developer-oriented contributions that Galanter has filed for her re-election campaign, \$500 came from George Mihistein, the lawyer representing Marina Place.

Reeling from the VTC rejection, a June 1989 Beachhead article by Arnold Springer called "What do we want and how do we get it?" supported the Channel Gateway highrise condo project just down the street from Marina Place. "There are lots of tradeoffs. They look acceptable to me." he wrote. "In the next few years we will have gridlock anyway. And who will provide the monies to provide us aid for the homeless, for beach cleanup, for coastal access, for removing beach traffic from our streets, for providing preferential and replacement parking, for low-income family housing? The City? Don't make me laugh. The State? The federal government? Dream on! The only The State? The federal government? Dream on! The only

The State? The federal government? Dream on! The only people who have the money out there are the developers. They are willing to trade. We have no choice but to cut the best deals we can..." he wrote.

And 1 year later, that's exactly what Springer did. By pretending to oppose it at public hearings, Springer achieved the legal standing to threaten to sue L.A. City for OK'ing the project. Fearing any more obstacles to his project, Gateway developer Jerry Snyder awarded Springer \$450,000 to go away. Some of that \$450,000 paid Springer is now flowing to COAST, to help in their own private lawsuit against the Gateway's competitor, Marina Place.

But Springer won't or can't give any money to help the VTC's lawsuit. Why? The VTC and COAST's lawyer Debra Bowen said at the May VTC meeting that there are too many connections already existing between COAST,

the VTC and Springer's Ulan Bator Foundation. The mall developer might charge that identical lawsuits by two groups with the same leaders is an unfair form of legal harrassment. If push comes to shove, I suspect the VTC will let themselves get muscled out of the suit completely, making the lawsuit a totally private, Galanter-controlled


So, has the VTC become the VAC? The names are different but the policies are the same: Development as Usual. The fact that Councilwoman Galanter supported Channel Gateway, seems to have supported the Marina Place settlement/sell out, and now also seems to be supporting Playa Vista (see adjoining L.A. Times article) should scare any voter. should scare any voter.

Rather than making developments acceptable to Venice, Galanter and the VAC/VTC seek to make Venicians acceptable to development.
