

As you must know by now, Venice has gone rogue with the June 27th election. The Board voted last Monday to go against DONE advice (see letter below) to postpone and are proceeding without approved election procedures into an election mess the likes of which I think we have never seen.

>Despite what the Board thinks, as of this moment, DONE is NOT authorizing the expenditure of any funds from the Dept related to this election which will include any invoice submitted by LWV if you choose to proceed in your role as their Election Administrator or Arbitrator.

>It is possible that the GRVNC might still ask you to participate and might offer to pay the League using NC funding. Of course, that is your choice, but as an esteemed and valuable member of the Election Procedures Working Group helping to craft policy to prevent these types of situations, I hope LWV will refuse the offer. In addition we are unclear at this time if we will validate the election or recognize those newly elected Board members, and this year Venice loses quorum and might loose their ability to conduct business (pay bills) after June 30th.

>Tomorrow we will be deep in discussions with Greg to figure out where we go from here and how we will respond. I will let you know. Venice is ripe with rumors right now about who said what to whom. If DONE decides not to support them in this endeavor (which we most likely will not) we will issue a formal letter to GRVNC restating our position with a cc to the LWV so that you know all of the facts.

The department prepared a Code of Civility and offered it to the NCs as a option. HRC assisted in the development of that. Several weeks ago, Jan Perry submitted a motion calling for the Code to be made mandatory. It has not been scheduled in committee yet. How to allow an NC to make the Code mandatory is on the City Atty's list of things to do, but no NC has said that it wants to do this. We don't know of any NC that has even adopted it as a guide.

NCs are encouraged to develop their own Code of Conduct, but I don't know of any that have done this.

The issue of whether or not NCs are city entities, and therefore where NC board members fit in the food chain, is being addressed by the City Atty. Their first opinion dealt with the Political Reform Act. Their subsequent reports will add further clarity to this question, and the options that lie ahead for the City.

... the e-mails I've sent you, I believe I have a better idea on how to address this issue now...this is a rough draft I'd started earlier...but thinking about it tonight, and with more info, I'll mostly jump into directions rather than full out reporting of the evening...

Let's brainstorm, please, on this when I get in....I'm off to Le Cont...for reals !!!

On June 7, 2004, I attended the Grassroots Venice Neighborhood Council meeting held at the Davis Center in Venice. The following are my observations of that evenings meeting.

Starting near 7PM, and running til 11PM, among the meeting's highlights were discussions and votes on two NC election matters, and the constant tension and defensive mannerisms displayed by members of the board and the audience.

Of importance that night was the upcoming NC election, set to be held June 27. The board spent some time discussing this issue, especially in light of the fact that DONE's executive director, Greg Nelson, had sent a detailed letter requesting, imploring it sounded, them not to hold the election this month, but to delay it. He apparently also offered DONE's help to pull together the election for a future date that would not be challenged.

Among the noticeable issues of that night was the apparent disregard some have for their opponents on the board. By body language, or more so by their intonations and outright comments, this board is besieged by a number of members who have an apparent lack of respect for one another. Murmuring over others speaking time, snorting or making aware one's displeasure with a speakers point of view occurred throughout the evening. While the president of the board had one member of the board handle the reading of speaker cards and acting as Sargent at arms, she did indeed stand up front and established her presences.

Issues of safety were not really directly discussed this night.

At numerous times, when it seemed as if a "hole had opened up," some people began to offer comments of racism being directed to either themselves, or others. It would appear from that meeting that racism is very prevalent in Venice. As is gentrification. Comments about being tried of being called "a racist and a Cracker" were extorted. An accusation of white racism was given by one board member.....

DONE and BONC need to take this issue seriously.

Both DONE and BONC need to agree on framework out of which NC's can both develop and once certified hold even elections. Expecting the NC's to develop their own procedures, or to develop a city-wide procedure, is too risky, given the tendencies we have seen developing across the City so far. To that notion I highly recommend bringing in (the guy from city elections who did Van Nuyso, The City HRC, and then City Att's office to tie it all up.

A serious and deep program dealing with the issues of LA needs to be offered, and required (!) By DONE and BONC for all NC's participants.... along the lines of out HRA program. To let people continue to "speak for the community" when they have little breath of knowledge about the changing demographics, is to then let elite, and exclusive, glorified homer-owners associations to exist.

While the board voted to ask for mediation via City Att.'s office, without any real HR training this will be a futile effort... more desired to, perhaps, sweat people out rather than build conscious.

I recommend that a full out Human Awareness Program be developed for the Venice community, not just the NC. That it be a must to partake of this program before any further DONE cooperation is considered.

That this should include community members from Oakwood, from boardwalk, and from general Venice, who HAVE NOT been a part of the developing NC.

Jim Smith's presentation of dates, challenges received, and recital of the election procedures is accurate; as we predicted, the challenge would probably come down to Richard Myers challenge since he was the only candidate to get his challenge in on time. I do no know when the Official Canvas from Casey Peters was issued since all of my GRVNC e-mails have been taken from e-mail box for use in the PRA (I didn't know they'd actually be taken, so I'll try to get them back), and the date that the Canvas was issued will impact whether Rick Selan's complaint/challenge will be accepted (he was a candidate, too).

- T disagree with Jim's interpretation of the facts or their significance.
- City Atty did not approve procedures.
- 2. Myers' challenge did NOT focus on ballots, per se, but rather to the following: (a) lack of timely and accurate notification of the election procedures to the Venice community; (b) No duly appointed IEA; (c) two items of business were conducted during the election (board election and stakeholder ratification of bylaws); (d) election was not properly called to order with a quorum of the officers; and (e) violation of bylaws and Brown Act re: notification of election.

Myer's wants to resolve this matter by tossing out the results of the board election and stakeholder ratification and have BONC supervise a new board election and stakeholder ratification of bylaws (seperate events) in the near future.

Thinking that we were going to do the challenge, I did a quick review of Myers' challenge and would have written my report to concur with most of the information that he provided.
